## zEnterprise 196 Software Pricing Strategy

- **MLC Software** – New metric “Advanced Workload License Charges” (AWLC) provides MLC price performance
  - Modeled after VWLC, same MSU tiers, sub-cap, and aggregation benefits
  - All products with VWLC will also be announced with AWLC
  - AWLC on a z196 provides 1%-10% savings compared to VWLC on a z10
    - Includes incremental savings on middleware products above 875 MSUs
  - Transition program will provide partial AWLC benefit as customers migrate their Sysplexes to all z196 machines
- **zIPLA Software**
  - zOTC software and the associated S&S will continue to be priced using System z Value Units, typically based upon MSUs
- **Distributed Passport Advantage Software**
  - On a z196 distributed software will continue to be priced using PVUs
  - Rating for a z196 engine (IFL or CP) is 120 PVUs, same as for the z10

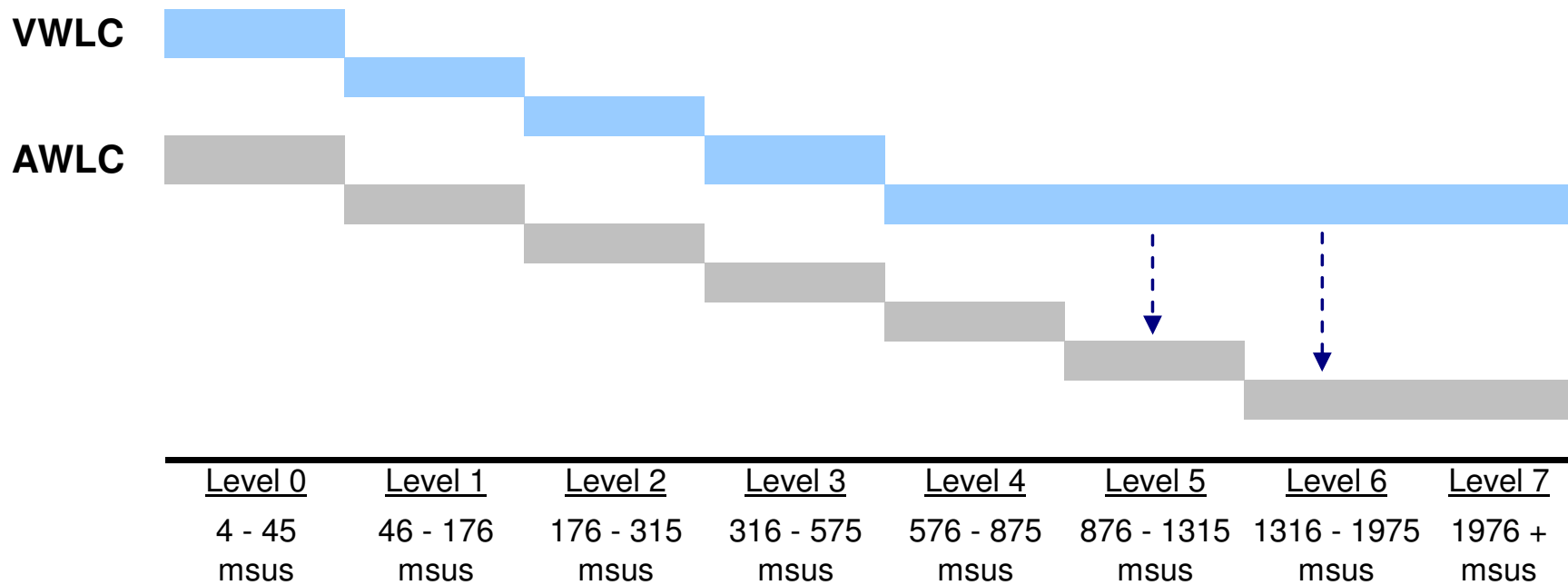

## AWLC Price Performance

## AWLC Price Performance

- AWLC has price performance improvements compared to VWLC at all MSU tiers above 3 MSUs
- Middleware price reductions on MSU tiers 5 and 6 provide additional unit cost improvement for customers > 875 MSUs



## AWLC Middleware price performance improvements

- All AWLC products above 3 MSUs have a price performance benefit compared to VWLC
- VWLC Middleware products have the same price for MSU Tiers 4, 5, 6 and 7
- AWLC Middleware products have price performance improvements for MSU Tiers 5 and 6 as compared to Level 4
- The MSU Tier 5 and 6 price changes for Middleware contribute to the overall cumulative AWLC price performance improvements

## **AWLC Software Licensing Rules and Transition Charges for Sysplexes**

## AWLC Software Licensing Rules

### z/OS and MLC middleware:

- Stand-alone z196:
  - **AWLC \***
  - VWLC not allowed
  - PSLC is allowed +
- Parallel Sysplex with all z196 machines:
  - **AWLC \***
  - VWLC not allowed
  - PSLC is allowed +
- Mixed Parallel Sysplex (z196 with z10 and/or z9):
  - **VWLC under Transition Charges for Sysplexes program \***
  - AWLC not allowed
    - *Without transition program the machines in the Sysplex would become disaggregated: z196's with AWLC and z10/z9's with VWLC*
  - PSLC is allowed +

\* Requires customer to sign AWLC contract

+ PSLC optionally allows ULC

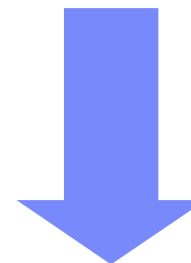


## A simple transition program provides VWLC savings for Sysplex customers as they migrate to z196 machines

- Transition Charges for Sysplexes program requires AWLC contract to be signed
- All machines in sysplex remain on VWLC until 100% of capacity migrated to z196
- A published discount schedule defines VWLC savings for partial plex upgrades
- VWLC discount will be based on the % of plex MSUs migrated to z196 machines, the % of z196 in plex is calculated using the **Full Capacity MSUs** of all Machines
- Transition Charges for Sysplexes program is **not** a special bid
  - It is announced and available for all sysplex customers
  - It is implemented in the CFSWeb configurator and in ESW/CBS

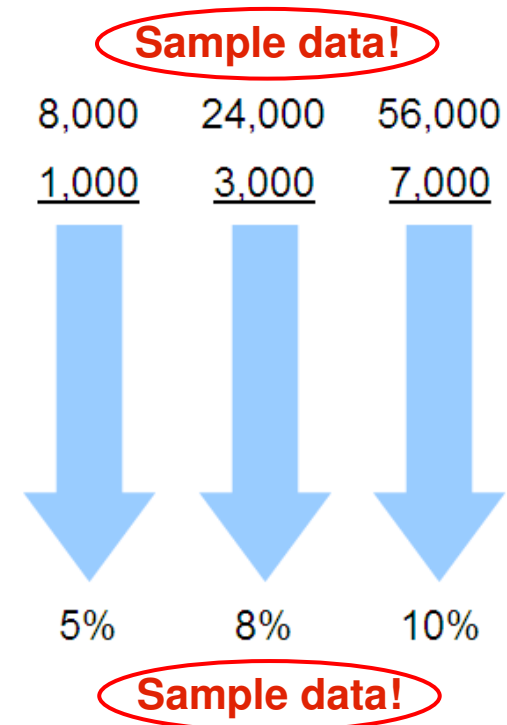

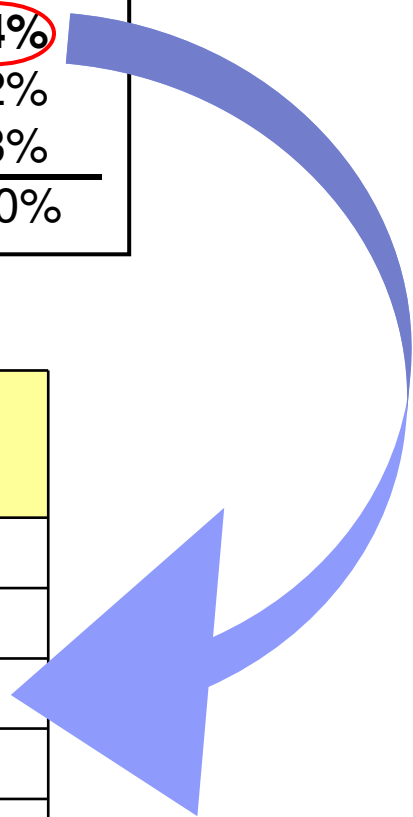

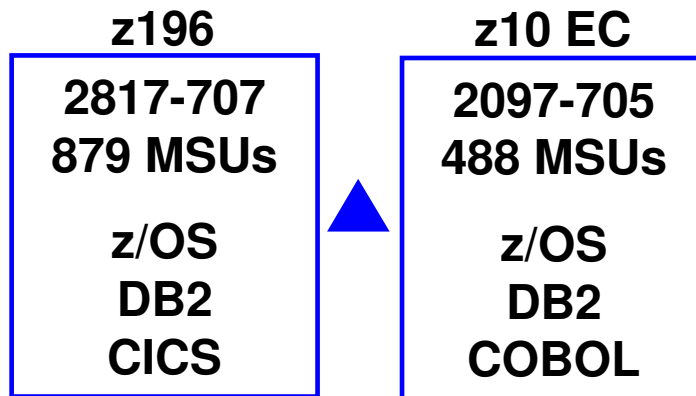

## Transition Discount Applies to All VWLC in the Sysplex

- Discount percent calculated without looking at any software!
  - Use Full Capacity MSUs of each machine to get Percentage of z196 in plex
  - Percentage of z196 hardware sets the VWLC discount percent across the plex
- Once discount percent is set it gets applied to **all** VWLC in the plex, whether or not an individual program is running on the z196



▪ **Example:**

- Percent z196 HW: 64%
- Transition discount: 4%

## Transition Charges for Sysplexes program Rules

- **Aggregated Parallel Sysplex with one or more z196 servers and one or more z10/z9 servers needs Transition Charges for Sysplexes**
  - To allow VWLC to be licensed on a z196
  - To provide partial AWLC price performance benefit during sysplex migration
- **Sysplex stays on aggregated VWLC during migration**
  - AWLC is not available to Sysplex until all machines are z196
- **Amount of Transition Charges VWLC discount is based upon the percentage of z196 hardware in the Sysplex**
  - Count only full-capacity MSUs of machines (not SCRT values)
  - Do not include OOCOD, CBU, Unassigned, or Specialty engines
  - Round the z196 portion of Sysplex to the nearest whole percent
    - e.g. 0.204999 rounds down to 20%
    - e.g. 0.205000 rounds up to 21%
- **Any time any Sysplex hardware changes, for example when one or more of the machines is upgraded or downgraded in type or size, the Transition Charges price benefit must be re-calculated!**

## Other z196 Software Licensing Rules

- z/OS MLC operating system and middleware
  - AWLC applies to z/OS
- z/TPF MLC operating system and middleware
  - AWLC applies to z/TPF (also PSLC is still allowed)
- z/OS IPLA middleware
  - Value Units (unchanged by AWLC announcement)
- z/VSE
  - MWLC (unchanged by AWLC announcement)
- z/VM
  - Engine based Value Units (unchanged by AWLC announcement)
- Passport Advantage Middleware for Linux on System z
  - 120 PVUs per z196 engine (unchanged by AWLC announcement)
- FWLC, zNALC, old NALC, and SALC all continue to work with AWLC the same way they worked with VWLC

## New AWLC Contract

- ICA Attachment for IBM System z Advanced Workload License Charges
  - AWLC Attachment number Z125-8538 / INTC-8538
  - With accompanying Exhibit Z125-8539 / INTC-8539
- **Required** for AWLC on z196 machines
  - Stand-alone
  - Aggregated Parallel Sysplex
- **Required** for VWLC on mixed z196 and non-z196 Parallel Sysplexes
  - Transition Charges for Sysplexes permits VWLC on a z196
  - Without the AWLC contract customer may not use VWLC on a z196
  - Customers may not keep VWLC and decide to give up the transition program in order to avoid signing the AWLC contract
- Not required for customers staying on PSLC
  - Without the AWLC contract only PSLC is available on a z196
- **Do not wait to ask your customer to sign the AWLC contract!!**

## AWLC Contracts and Exhibits

### ▪ ICA Attachment for IBM System z AWLC (Z125-8538 / INTC-8538) Definitions

- AWLC - Advanced Workload License Charges available for selected IBM Programs which are used on an Eligible Machine and are running under an Eligible Operating System. AWLC charges allow for Sub-Capacity Pricing.
- Eligible Machine - A Machine to which an Eligible Operating System is licensed. Any copies of Eligible Operating Systems that run on an Eligible Machine must run in z/Architecture (64-bit) mode. Eligible Machines are specified on the IBM System z Advanced Workload License Charges Exhibit, INTC-8539-00 or later, (“Exhibit”).

## Workload Pricer (WLP)

## Workload Pricer (WLP) V13.1 became available 1 July

- Use it to configure AWLC prices and Transition Charges for Sysplexes
- Price Files with the z196 hardware and AWLC prices became available on announcement day, 22 July 2010
- WLP will configure the appropriate pricing metric:
  - AWLC for standalone z196 or Sysplex with all z196 machines +
  - VWLC for Sysplex with a mix of HW technologies +
- For mixed Sysplex pricing the new “AWLC Transition Report” calculates the VWLC benefit for a plex containing z196 and other HW technologies
  - Calculates the percent z196 hardware and the benefit discount
  - Calculates the VWLC price and the TP price with the discount applied
- Workload Pricer is an internal tool not available for customer use!

+ PSLC also works as usual

- Box 1 is a z196 with 1191 MSUs, Box 2 is a z9 EC with 385 MSUs
- $1191 / 1576 = 0.755710$  which rounds up to 76% which earns 4.00% VWLC discount
- Only VWLC is affected by the TP, not FWLC or any other metric
- You must round off TP decimals per country rules

## CFSWeb will pass the TP discount level to ESW/CBS

- When CFSW sees a mixed machine type sysplex:
  - Calculates the percentage of z196 hardware in the sysplex
  - Determines the VWLC discount tier:
