Existing customers who want to upgrade to Sterling B2B Integrator version 5.2.0 must use the migration method of upgrade (import/export) to a new installation.

The traditional, in-place upgrade method is not currently available.

You should be aware of the advantages and disadvantages of these different upgrade methods before deciding which method is best for your business:

- In-place upgrade moves your transactional data and run-time assets to the new version.
- Migration upgrade (import/export) moves only your run-time assets to the new installation.
