Schemas

An XML schema is an XML document that specifies the structure of a valid XML document. Comparable to a document template, an XML schema ensures that every item is in the correct form.

You cannot combine an XML schema with an XML document that the schema governs, since the schema is used by several documents and stored separately for validation purposes.

An XML schema consists of the following components:

Component Name	Definition
XML declaration	Defines the XML version that the schema uses
Schema element	Identifies the document as an XML schema. Schemas are used to validate translation data in the Map Editor, provide web service structural information to web service clients, and define Reporting Services components such as fact models and reports.
Element declaration	Defines the element. An element is a section of an XML document. An element can contain attributes, which are characteristics of an element.
Attribute declaration	Defines the attribute.

When you submit an XML document to the system, the XML document is compared to the XML Schema to ensure that the document is in the appropriate format and is valid.

Types of Schemas

The follow types of schemas are supported:

- XML schema (.xsd)
- DTD (.dtd)
- Fact Model used for Reporting Services (.bifm)
- Report Definition used for Reporting Services (.rdef)
- Report Format used for Reporting Services (.rfmt)
- Mondrian Cube used for Reporting Services (.mond)
- Other enables you to save schema files having extensions other than those listed. For example, schemas having extensions .doc and .txt.

Schema Versioning

A version is an edited copy of a schema. Each time a schema is edited, a new version is created, but the original schema remains intact for future use. The system adds a date and time stamp to each version that can be used for version identification.

The default schema is the version of the schema that is available at the start of a business process. You can specify a default schema only if you have two or more versions of the same schema. One version must be selected as the default.

Search for Schemas

About this task

To search for schemas:

Procedure

1. From the **Administration Menu**, select **Deployment > Schemas**.
2. Enter the search criteria. The search criteria can be any one of the following:
 - Schema Name
 - Schema Name Space
 - Alphabetically
 - By Schema Type
3. Click **Go!**

Check In Schemas

About this task

Before you can use a schema, you must first check it in.

To check in a schema:

Procedure

1. From the **Administration Menu**, select **Deployment > Schemas**.
2. Next to **Check-in new XML Schema or DTD**, click **Go!**
3. Enter the **Schema filename** or click **Browse** to locate the schema. A schema name cannot use spaces or apostrophes.
4. Enter any **Check-in Comments**. You may want to note the purpose of the schema or to explain the changes made to it.
5. Click **Next**.
6. Enter the Schema Name. For translation mapping, the schema name here must match exactly the schema name in the XML instance document that the Translation service will translate. If the schema is an XML schema, the name must match the target namespace in the schema. If these conventions are not followed, the XML parser generates an error at run time.
7. Verify that the **Schema Type** is correct.
8. If you are checking in an XML schema, enter the **Target Namespace**.
9. Click **Next**.
10. If you do not want the schema to be enabled, clear the **Enable for Business Processes** check box.
11. Review the schema information.
12. Click **Finish**.

Check Out Schemas

About this task

Checking out a schema saves a copy of the schema to your local computer.

To check out a version of a schema:

Procedure

1. From the **Administration Menu**, select **Deployment > Schemas**.
2. Locate the schema you want to check out using either the **Search** or **List** option.
3. Next to the schema you want to check out, click **source manager**.
4. Next to the version you want to check out, click **check out**.
5. Click **OK** to lock the file for editing or click **Cancel** to checkout a read-only copy of the schema.
6. In the **File Download** dialog box, select one of the following options:
 - Select **Open**, then click **OK**. You can view the file in Notepad or a similar program.
 - Select **Save**. Browse to the location and click **Save** to save the file and complete check out.
 - Select **Find** to locate a program to open the file.

2. Locate the schema using **Search** or **List**.
3. Next to the schema, click **version manager**.

4. Uncheck the checkbox in the **Enable** column.
5. Click **Save**. The following message is displayed: Schema status has been successfully updated.
