## Chapter 1. Using AS3 with the Sterling B2B Integrator

Sterling B2B Integrator enables you to send and receive AS3 messages either through a custom written business process or through a schedule created during the contract creation phase. AS3 (Applicability Statement 3) systems exchange Electronic Data Interchange-Internet Integration (EDIINT) messages using FTP as the transport method (EDIINT messages are either MIME or S/MIME (secure MIME) messages).

---

### Use of Message Disposition Notifications

A *message disposition notification (MDN)* is a receipt document that contains the original message ID of a message and status information about the original message. EDIINT is a family of protocols developed by the Internet Engineering Task Force (IETF) for securely packaging and transporting messages containing business data over the Internet, using S/MIME.

MDNs that conform to the EDIINT specifications can contain a cryptographic hash calculated over the content of the message after EDIINT processing. An MDN can be either:

- Signed – Contains an encrypted digital signature of the receiver.
- Unsigned – Contains only the original message ID and not a digital signature.

Signed MDNs that conform to the EDIINT specifications can provide acknowledgement of receipt in addition to message status information. A valid digital signature over an EDIINT MDN shows that the MDN was sent by the trading partner possessing the relevant key pair. It also shows that the signed area of the MDN (which includes the cryptographic hash calculated over the received content) was not altered after signing. A message sender compares the hash in the MDN with the hash calculated when the message was generated. If the hashes match, the sender knows that the receiver received the content and has the MDN to demonstrate the status.

Whether signed or not, MDNs do not show that the received message content conforms to EDI or other business document formatting requirements.

MDNs are sent asynchronously in which they are returned at a later time during a different communication session. For example, A initiates the connection to B and drops the data for delivery to B. A closes the connection and does not wait for an MDN from B during the same communication session. In a later session, B initiates a connection to A, and sends an MDN to A. When the MDN is delivered, B closes the connection.

The majority of the AS3 functionality in Sterling B2B Integrator requires the use of the Mailbox features. Therefore, you must purchase the Mailbox license to use AS3 in the Sterling B2B Integrator. For inbound AS3 messages, payloads are extracted and stored in a designated mailbox. The payload will only be stored in the mailbox upon successful delivery of the MDN (if required) to the trading partner. For outbound AS3 message exchanges, payloads are encapsulated within the MIME or S/MIME message and sent to the trading partner.

The Bulk Message Generation feature allows you to enable the schedule of the business process to collect payloads from a specified folder, create an AS3 message, and send it to the intended trading partner. Sterling B2B Integrator supports initiating AS3 message exchanges in a scheduled manner. The option of searching a specified folder for any files present within it or matching a file pattern is configured when you create an AS3 contract.

A system generated business process is created and added to the schedule. This schedule is enabled if the option to enable it was selected during the configuration of the Bulk Message Generation option. The scheduled business process is written to collect the documents from a specified folder and invoke a business process containing the AS3 Build service to create the AS3 message and initiate a message exchange with the trading partner as specified in the AS3 contract.

To prevent system performance degradation that may occur if there are too many files to process at once or if the system keeps trying to send AS3 messages to an unavailable FTP Server, Sterling B2B Integrator allows you to throttle the AS3 message exchange rate by limiting the number of message exchanges per cycle and to schedule optimal cycle periods that the system can handle. You can also throttle the AS3 message exchange rate by limiting the number of files to be picked up. Using throttling, if an FTP Server is down or too busy to accept any new connections, Sterling B2B Integrator sets a temporary lock on the AS3 contract and suspends message transmission for the period of time you specify. If the lock is enabled, Sterling B2B Integrator does not initiate any message exchange even when the schedule is executed, and only initiates a message exchange when the lock is disabled from the AS3 contract. This ensures that system resources are not wasted in attempts to connect to an unavailable FTP Server.

Sterling B2B Integrator also allows you to configure a maximum retry count for sending AS3 message and MDNs. This connection retry logic covers all possible transmission errors such as server unavailability, authentication failures, handshake failures, network surge during data transfer, generic file system errors, and so forth. If you enable the retry option, a retry attempt is executed if a failure is encountered at any stage of the transmission process for a message or MDN.

Sterling B2B Integrator ensures that MDNs have been sent to a trading partner before an AS3 payload is placed into the PAYLOAD mailbox to be processed by the business process. If the MDN was not sent, the payload is not placed into the PAYLOAD mailbox. Instead, it is placed into an Error mailbox for tracking only, and subsequent messages from that trading partner as a result of the failed MDN are not recorded as a Duplicate entry, but are considered to be a new message.

**Note:** This happens only if the Sender requests for an MDN for the message sent. A Sender can also send messages without requesting for an MDN.

AS3 messages having a message identifier that is already recorded in Sterling B2B Integrator are considered to be a duplicate if the payload of the original message was placed into the PAYLOAD mailbox. MDNs are either sent directly to a trading partner, or are placed in an outgoing mailbox for the trading partner to pick up within a specific time period.



## Restarting a Business Process and Resending Messages with the Original Message ID

Sterling B2B Integrator allows you to easily resend messages because the building and sending of messages is all handled by the predefined business processes. This enables you to resend messages using the original message identifier by simply restarting the AS3MessageInitiation business process. The business process is invoked by the AS3 Build Service and has the AS3 message as the primary document. You need to select the failed parent business process and then select the child business processes which have been invoked and then restart the AS3MessageInitiation business process. To restart a business process, you need to select the failed business process, click on the Process ID to display the executed steps, and then select the Restart option from the Action list.

## Prerequisites for using AS3 with Sterling B2B Integrator

The following are prerequisites to using Sterling B2B Integrator with the AS3 standard:

- The audience using this software should be familiar with Sterling B2B Integrator (including the Mailbox feature and FTP Server configuration) and the AS3 standard.

**Note:** This documentation is not intended to explain the AS3 standard.

- The customer is responsible for purchasing a Mailbox license.

## Use AS3 with Sterling B2B Integrator

### About this task

To use AS3 with Sterling B2B Integrator, you must complete the following tasks:

### Procedure

- Create an instance of the FTP Server adapter.
- Write a business process to poll the designated mailbox for inbound payloads and to use the payload according to your business requirements.
- Create a trading partner organization and profile.
- Create a contract for each trading partner relationship.

**Note:** Sterling B2B Integrator automatically creates two AS3 trading partners in this process.

- Create mailboxes if you did not create the AS3 mailbox structure and mailbox names automatically when you created the partner profiles.
- Create routing rules for inbound AS3 messages and inbound AS3 MDNs if you did not create the AS3 routing rules automatically when you created the partner profiles.

7. Assign the appropriate user permissions to your AS3 mailboxes and routing rules if you specified that they should be automatically created when you create a trading partner profile. You need to assign permissions for all the partners.
8. Send and receive AS3 messages to and from your trading partners.
9. To track AS3 messages or data flows, use the monitoring functionality.

## Chapter 2. AS3 Business Processes

To help you accomplish your business goals, Sterling B2B Integrator provides predefined business processes (in conjunction with predefined services) to implement the AS3 protocol. These predefined business processes are automatically installed and configured when you install Sterling B2B Integrator.

The AS3 implementation uses these predefined business processes along with services to build and transmit messages to trading partners. After Sterling B2B Integrator extracts files from mailboxes, it launches business processes that:

- Encapsulate the data files into an AS3-compliant message.
- Attempt to transmit those messages through FTP.
- Potentially process responses or acknowledgements to those messages.

Sterling B2B Integrator provides business processes for sending messages and checking for acknowledgements (Message Disposition Notifications, MDNs).

The predefined AS3 business processes include enhanced retry logic for each partner. This disables Sterling B2B Integrator from attempting to send messages to the system of a trading partner when it is down. These business processes can detect several types of errors and can inform users and restage data files if errors occur. The business processes attempt to retry in the following situations:

- When what is potentially a transient FTP error is detected based on the return code.
- When you are collecting and saving data using the file system, a scheduled business process invokes the File System adapter, which collects data files from the file system.

The following steps summarize the activities completed by business processes when sending messages:

1. Business processes send messages requesting synchronous receipts, asynchronous receipts, or no receipts.
2. Based on the receipt options specified for a trading partner, the business processes handle business documents, as appropriate.
3. When receiving messages, the business processes complete the following activities:
  - a. Parse messages, generate and send receipts.
  - b. Extract business documents and place them in the payload mailbox.

The predefined business processes are initiated by services during AS3 processing and do not require you to modify them. The following table lists business goals for the predefined AS3 business processes:

### AS3MDNInitiation

Invoked through the routing rule that you create (either automatically through the partner profile create process or manually) that is specified on the inbound AS3 message mailbox and the inbound AS3 MDN mailbox. For each extracted message, the AS3MessageParsing business process is invoked to process the message.

## AS3MessageInitiation Business Process

The AS3MessageInitiation business process is used by the AS3 Build Service to send AS3 messages, retrieve MDNs, and add AS3 messages into mailboxes. The AS3MessageInitiation business process is initiated as part of the inbound process flow.

## AS3MbxProcessing Business Process

The AS3MbxProcessing business process is invoked through an automatic routing rule that you create (either automatically through the partner profile create process or manually) or that is specified on the trading partners inbound AS3 message mailbox and the inbound AS3 MDN mailbox. For each extracted message, the AS3MessageParsing business process is invoked to process the message.

The AS3MbxProcessing business process is initiated as part of the inbound process flow.

## Run, Restart, and Stop Predefined AS3 Business Processes

### About this task

Predefined business processes associated with a document that contains errors may continue to run unnecessarily. Using the Business Processes Monitor, you can not only obtain general and detailed processing information about predefined business processes, but also run and stop business process and any subprocesses. After reconciling document errors, you can then restart the business process.

You need to resume or restart a process when your monitoring activities uncover a process instance with a state of waiting, interrupted, or halted, or you have stopped a process for some reason, such as to correct a problem before the process continues.

View Execution Information after process resumes or restarts. When you restart or resume a business process, Sterling B2B Integrator opens the Execute Business Process page. This page lists the service, status, advanced status, start and end times, troubleshooting reports, and documents for each step completed within a

recently run business process. The following table describes the three options you have for re-activating a stopped process instance, and when to use each:

### **Resume**

Continues a process from the last step that fully completed (including full configured persistence). The instance retains its original instance ID. Use this function when the error is related to services. For example, if a service is unavailable unexpectedly, a business process using that service stops at that point. After the service is restored and active, you can resume the business process.

### **Simple Restart**

Starts a new instance of the same business process from the beginning (with the same document). The new process receives a new instance ID.

### **Advanced Restart**

Runs the original document using the default version of a different business process model (you can select the default version of any process model saved in the system).

The new instance receives a new instance ID. Use this function when the error is related to the business process BPML code.

**Note:** The information icon indicates that troubleshooting data is available. Click the **info** icon to view this information.

To perform activities for predefined business processes:

## **Procedure**

1. From the **Business Process Monitor**, select the Instance **ID** for the appropriate business process.
2. In the Business Process Detail page, from the **Action** list, select **Restart**, **Stop**, **Expedite**, or **Terminate**, and click **Go!** The options displayed are the only options available for the selected instance or instances.

**Note:** If you want to resume the process, select **Restart**.

3. To stop the business process, select **Terminate**. When you are prompted to confirm that you want to terminate or expedite the process, click **OK**.
4. If you do not want to stop the business process, complete one of the following actions:
  - To continue the business process instance from the point at which it stopped, in the **Resume** area of the page, click **Go!**
  - To restart the process from the beginning with a new instance ID, in the **Simple Restart** area, click **Go!**
  - To process the original document using a different business process model, in the **Advanced Restart** area, select the business process model you want to use for this new instance and click **Go!**

The system runs the designated default version of the process you selected. A new page displays the execution of the selected action.

5. If the business process runs to completion, you are through with the execution. If the resumed or restarted business process stops responding, you must find and correct those errors before the business process can complete.



---

## Chapter 3. AS3 Trading Partners in Sterling B2B Integrator

To exchange AS3 documents between trading partners, Sterling B2B Integrator uses predefined business processes that link trading partners together. A *trading partner* is a company or business entity that participates in the exchange of business application data. To enable Sterling B2B Integrator to run these business processes, you must provide information about each trading partner participating in the business processes, including your organization. The sending process retries a specified number of times at the interval you configure.

A trading relationship is only defined between two different partners, and in this relationship one partner must act as an Organization and the other must act as a Partner. When a trading relationship already exists between two trading partners, no reverse relationship is allowed. For example, if you have an AS3 trading relationship with your partner Roman's Floors and More, in which you act as the Organization and Roman's Floors and More acts as a Partner, then you and this partner cannot have another trading relationship with a reverse role.

An *organization* is the company or business entity that administers your system. This organization is comparable to a profile and an identity in Sterling B2B Integrator.

You must create a trading partner profile for each trading partner with whom you exchange AS3 documents. Each time you create a partner using the AS3 wizard, you need to create a contract between that partner profile and the organization.

These contract names are formatted as follows:

- [local partner identity name] InitiateExchangeTo [remote partner identity name]
- [local partner identity name] ReceivedFrom [remote partner identity name]

**Note:** The Production and Consumption profile appears if you view the created profiles from the advanced trading partner menu options.

### Before You Begin Using AS3 with Sterling B2B Integrator

Before you configure information about your organization and trading partners, you need to do the following:

- Check in certificates for the secure transport of data.

**Note:** You need to check your private key certificate in to Sterling B2B Integrator.

- Collect the following information about your organization and trading partners:
  - Name and address information
  - AS3 identifiers
  - The following certificates, as appropriate:
    - System certificates
    - SSL server certificates
    - End-user certificates
  - IP addresses, port numbers, and URLs
  - Agreed-upon algorithms for signing and encryption

- User identifiers and passwords

### **Building an AS3 Message**

When you build an AS3 message, all the information about security preferences, acknowledgement preferences, and transport is pulled from the consumption profile. The identity identifier and the signing key for the document exchange (if the document is signed) are pulled from the production profile.

**Note:** The population of the Consumption and Production profile is done through the AS3 Partner Wizard.

### **Parsing an AS3 Message**

When you parse an AS3 message, all the information about security preferences, acknowledgement preferences, and transport is pulled from the production profile. The identity identifier and the exchange key for the transport exchange (if the message is encrypted) are pulled from the consumption profile.

### **After Creating Your Organization, Partner Profiles, and Partner Contracts**

After you create all the necessary partner information in the AS3 Trading Partner wizard, you need to assign the appropriate user permissions to all the AS3 mailboxes and routing rules that were automatically created. You need to assign permissions for each of your partners.

If you do not choose to have the necessary mailboxes and routing rules automatically created, you need to assign these permissions after you manually create the mailboxes and routing rules.

## Chapter 4. AS3 Trading Partner Organization

Depending on your relationship with your trading partners, your organization may be the AS3 Trading Partner Organization, or one of your partners may fulfill that role.

MDN Download Directory	Indicates the directory where the MDN is stored on the FTP server. Required only if the Messaging Action <b>As Initiator</b> selected is <b>Send Message Directly to Trading Partner and pickup MDN only</b> .
MDN to Download	Indicates the filename of the MDN to be downloaded (for example, *.txt, which will only download documents with the extension txt). Required only if the Messaging Action <b>As Initiator</b> selected is <b>Send Message Directly to Trading Partner and pickup MDN only</b> .
Check AS3 MDN file size	System checks if the AS3 MDN is completely uploaded to the FTP server from where the download is being done. ## Chapter 6. AS3 Trading Partner Contracts

Each time you create a partner using the AS3 wizard, you need to create a contract between that partner profile and the organization.

**Note:** Two AS3 contracts are automatically created when you use the AS3 Contract Wizard to create a trading partner contract.

One contract is used for initiating an AS3 message exchange and the other contract is used for receiving an AS3 message. These contract names are generated automatically and formatted as follows:

- [local partner identity name] InitiateExchangeTo [remote partner identity name]
- [local partner identity name] ReceivedFrom [remote partner identity name]

**Note:** The Production and Consumption profile appears if you view the created profiles from the Advanced Trading Partner menu options.

The Bulk Message Generation feature is part of the contract creation process. This feature allows you to enable the schedule of a business process to collect payloads from a specified folder, create an AS3 message, and send it to the intended trading partner. Sterling B2B Integrator supports initiating AS3 message exchanges in a scheduled manner. The option of searching a specified folder for any files present within it or matching a file pattern is configured when you create the AS3 contracts. A scheduled Business Process (BP) that includes the AS3 Build Service is created with the contract name and the parameters specified in the Bulk Message Generation option, when you create a trading partner contract between an organization and a partner.

---

### Create an AS3 Contract

#### About this task

You must create a contract for all trading partners with whom you exchange AS3 messages.

To create an AS3 Contract:

#### Procedure

1. From the **Administration** menu, select **Trading Partner > AS3**.
2. In the AS3 Configurations page, in the **Create** section next to **New AS3 Contract**, select the **Organization** and **Profile** that you created for the partner and click **Go!**
3. In the AS3 Trading Contract Configuration page, complete the following parameter, as appropriate, and click **Next**:

##### **Enable Bulk Message Generation**

Whether to enable bulk message generation. Valid values are Yes and No (default). Required.

4. If you selected **Yes** for the **Enable Bulk Message Generation** parameter, in the AS3 Trading Contract Configuration page, complete the following parameters, and click **Next**:

**Collection Folder**

Directory that contains outgoing (outbound) payload for your trading partners. Required.

**Maximum Number of Files to Collect**

The number of files that are picked up from the collection folder each time that the scheduled business process executes. The default value is 10. Required.

**Note:** The number you specify should ensure that an optimum throughput is obtained based on the hardware and memory specifications of your environment.

**Filename Filter**

Indicates a filename filter to be used when collecting the payload (for example, \*.txt, which will only collect documents with the extension txt). Optional.

**Bulk Message Suspension**

Indicates the time (in seconds) when collecting files from the payload is suspended due to the inability to conclude a message exchange with the partner in the previous attempt to exchange messages. Default is 60 seconds. Required.

**Enable Schedule (Timer)**

The business process is automatically generated and scheduled. The schedule will be enabled only when you select **Yes** for this parameter. Required.

**Note:** If you do not select **Yes** for this parameter, you will need to schedule the business process manually using the interface available through **Deployment > Schedules**.

**Select Time**

Specify the required hours and/or minutes to indicate the interval at which the generated business process should be executed. Default is 3.5 hours. Required.

**Note:** If you selected **No** for the **Enable Bulk Message Generation** parameter in the AS3 Trading Contract Configuration page, the Confirm page is displayed. Click **Finish**.

5. In the Confirm page, verify the information you specified and click **Finish**.

**Note:** If an active trading contract exists for a partner, you cannot change that partner profile to an organization profile.



---

## Chapter 7. Editing an AS3 Trading Partner

The AS3 Trading Partner wizard not only allows you to create new trading partner profiles but also enables you to edit the existing profiles. Therefore, you can always change an Organization profile to a Partner profile and vice versa. If there is an active trading contract between an Organization and a Partner, then you are not allowed to change the profile type of either the Organization or Partner. Additionally, you can modify an aspect of an existing Organization or Partner profile.

Editing an AS3 trading partner may be necessary, for example, if you are negotiating a contract and you or your trading partner want to change some of the information.

---

### Edit Organization Information

#### About this task

To edit your organization information:

#### Procedure

1. From the Administration menu, select **Trading Partner > AS3**.
2. In the AS3 Configurations page, under **List**, next to **AS3 Trading Profiles**, click **Go!**  
In the AS3 Profiles page, a list of trading profiles displays.
3. In the list, locate the organization you want to edit and click **edit**.
4. Update your organization information as necessary and click **Next**.

**Note:** If you want to change this Organization to a Partner profile, for **Configuration Type** click **Partner**.

5. Click **Finish** to update the organization.

---

### Edit Trading Partner Information

#### About this task

To edit trading partner information:

**Note:** You can edit Organization and Partner profiles only if the profile is not part of a contract.

#### Procedure

1. From the Administration menu, select **Trading Partner > AS3**.
2. In the AS3 Configurations page, under **List**, next to **AS3 Trading Profiles**, click **Go!**  
In the AS3 Profiles page, a list of trading profiles is displayed.
3. In the list, locate the partner you want to edit and click **edit**.
4. Update your organization information as necessary and click **Next**.

**Note:** If you want to change this Partner profile to an Organization, for **Configuration Type** click **Organization**.

5. Click **Finish** to update the organization.

---

## Chapter 8. Deleting an AS3 Trading Partner

The AS3 Trading Partner wizard also enables you to delete trading partner information. You can delete trading partner information when it becomes obsolete. This may be necessary, for example, if a trading partner is lost, or when two trading partners merge.

---

### Delete Trading Partner Information

#### About this task

To delete trading partner information:

#### Procedure

1. From the Administration menu, select **Trading Partner > AS3**.
2. In the AS3 Configurations page, under **List**, next to **AS3 Trading Profiles**, click **Go!**  
In the AS3 Profiles page, a list of trading profiles is displayed.
3. In the list, locate the organization you want to edit and click **edit**.
4. In the list, locate name of the trading partner whose information you want to delete and click **delete**.
5. In the message prompting you to confirm your intent to delete, complete one of the following actions:
  - Click **OK** to continue the deletion.
  - Click **Cancel** to cancel the deletion.
6. In the Resource Summary page, review the information and click **Next**.

**Note:** When you click **Delete**, you completely remove this trading partner from the database. This action cannot be undone.

7. In the Confirm page, click **Delete** to complete the deletion.

## Chapter 9. Edit an AS3 Contract

### About this task

The AS3 Trading Partner wizard not only allows you to create new AS3 contracts but also enables you to edit the existing contracts. Therefore, you can always make changes to the contracts once they are created. If there is an active trading contract for a Partner, then you are not allowed to change that partner profile to Organization profile. Editing a contract enables you to enable or disable Bulk Message Generation.

Editing an AS3 contract may be necessary, for example, if you are negotiating a contract and you or your trading partner want to change some of the information.

**Note:** If you delete a trading partner the existing contract dependant on that trading partner is deleted and you cannot see that contract in the list of AS3 contracts for editing.

To edit your organization information:

### Procedure

1. From the Administration menu, select **Trading Partner > AS3**.
2. In the AS3 Configurations page, under **List**, next to **AS3 Trading Contracts**, click **Go!**  
In the AS3 Contracts page, a list of trading contracts displays.
3. In the list, locate the contract you want to edit and click **edit**.
4. Update the AS3 Trading Contract Configuration as necessary and click **Next**.
5. Click **Finish** to update the contract.



---

## Chapter 10. Delete an AS3 Contract

### About this task

The AS3 Trading Partner wizard also enables you to delete AS3 contracts. You can delete AS3 contracts when a contract no longer exists between two trading partners.

**Note:** If an active AS3 contract exists, Sterling B2B Integrator does not allow you to delete the profiles associated with that trading contract.

To delete AS3 contract information:

### Procedure

1. From the Administration menu, select **Trading Partner > AS3**.
2. In the AS3 Configurations page, under **List**, next to **AS3 Trading Contracts**, click **Go!**  
In the AS3 Contracts page, a list of trading contracts displays.
3. In the list, locate the contract you want to delete and click **delete**.
4. In the message prompting you to confirm your intent to delete, complete one of the following actions:
  - Click **OK** to continue the deletion.
  - Click **Cancel** to cancel the deletion.
5. In the Resource Summary page, review the information and click **Next**.  
**Note:** When you click **Delete**, you completely remove this contract from the database. This action cannot be undone.
6. In the Confirm page, click **Delete** to complete the deletion.





---

## Chapter 11. FTP Server Adapter Instance for AS3

The FTP Server adapter transports the AS3 and MDN messages to your trading partners. You need to create an instance of the FTP Server adapter to enable the trading partner to log in to Sterling B2B Integrator to send an AS3 message or pick up an outbound AS3 message.

When you configure an instance of the FTP Server adapter for AS3, you need to create User Accounts for their trading partners and assign the User Identifiers to the trading partner mailboxes that were either automatically created when you created the partner profiles or created manually.

**Note:** You can also create virtual roots for specific users, if desired. This functionality allows the user to be assigned a specified mailbox directory.

Additionally, as part of the configuration of the FTP Server adapter, you need to specify if Secure Sockets Layer (SSL) is required when connecting to the FTP Server. If the FTP Server adapter **SSL** parameter is set to **Optional** or **Must**, you need to give your public certificate information to your trading partners to use during the SSL handshake procedure.

**Note:** You need to set the Extractable Count to 1 to ensure that the incoming messages are deleted upon extraction and to prevent the same message from being extracted multiple times.

See *FTP Server Adapter* for more information on configuring the adapter instance.



---

## Chapter 12. AS3 Mailboxes

If you do not choose to have the necessary mailboxes automatically created during the partner profile creation process (for example, because you want the flexibility to create your own mailbox structure), you need to manually create the necessary mailboxes and then assign appropriate user permissions. See “Create an AS3 Profile” on page 21 for more information on having the mailboxes automatically created.

The following list illustrates the mailbox structure when the mailboxes are created by Sterling B2B Integrator. This is the structure we recommend you use:

### Identity’s Root Mailbox

- InboundAS3
- Inbound MDN
- Holding
- OutboundAS3
- OutboundMDN
- Payload
- ExtractedMDN
- Error

Outgoing AS3 Message	OutboundAS3	This is the mailbox that stores the outgoing AS3 messages to the trading partner. This mailbox is only used if the AS3 messaging options indicate a need to store the outbound message locally for the trading partner to pick up.

Mailbox Purpose	Name of Mailbox When Automatically Created	Description
Outgoing AS3 MDN	OutboundMDN	This is the mailbox that stores the outgoing AS3 messages containing the MDN to the trading partner. This mailbox is only used if the AS3 messaging options indicate the need to store the Outbound MDN for the message locally for the trading partner to pick up.
Extracted Payload	Payload	This is the mailbox that stores the actual payload extracted from the incoming message. An internal business process will pick up and process the document.
Extracted MDN	ExtractedMDN	This is the mailbox that stores the actual MDN extracted from the AS3 message.
Error Payload	Error	This is the mailbox that stores the extracted payload for messages that did not successfully send the MDN to the Trading Partner.

---

## Create the AS3 Mailboxes Manually

### About this task

Use the following procedure to create the AS3 mailboxes manually:

To create the AS3 mailboxes manually (one at a time) and assign permissions to groups and users to operate on the mailboxes:

### Procedure

1. From the **Deployment** menu, select **Mailboxes > Configuration**.
2. In the **Create** section, click **Go!**
3. In the Mailbox: Name page, select the parent mailbox in which the mailbox you are creating will be embedded. You can type a partial name in the **Filter by Name** field and click the **filter** button for a filtered list.  
The root mailbox is denoted by a slash (/).
4. In the **Name** parameter, type a name for the mailbox you want to create. See the table above for our recommended mailbox names.  
This name is used to identify the mailbox in Sterling B2B Integrator.
5. In the **Description** parameter, type a short description for the mailbox and click **Next**.  
Use this field to describe the mailbox.
6. In the Assign Groups page, use the arrows to add the groups to the Selected Groups list and click **Next**.  
The group you select should contain the user accounts you set up for your partners. All groups in the Selected Groups list will have permissions on this mailbox. Click the first double arrow to add all available groups to the Selected Groups list. You can type a partial group name in the **Filter by Name** field and click the **filter** button for a filtered list. No groups are required. Groups can be added from the Accounts menu.
7. Use the arrows to add users to the Selected Users list and click **Next**.

The users you select should contain the user accounts you set up for your partners. All users in the Selected Users list will have permissions on this mailbox. Click the double arrow to add all available users to the Selected Users list. You can type a partial user name in the **Filter by ID** field and click the **filter** button for a filtered list. Users can also be added from the Accounts menu.

8. Click **Next**.
9. In the Confirm page, verify your mailbox configuration and click **Finish**.
10. Complete steps 1 through 9 for all eight AS3 mailboxes.

---

## AS3 Mailboxes Housekeeping

For performance reasons, we need to ensure that all mailboxes do not retain a large number of messages. Sterling B2B Integrator only deletes messages from the InboundAS3 and InboundMDN when the messages are no longer extractable. This occurs if the messages have been given an Extractable Count value when they are initially deposited into the mailboxes and when the value becomes 0. The Extractable Count value decrements by 1 on each extraction. For the IncomingAS3 and IncomingMDN mailboxes, the Extractable Count value is defined on the FTP Server Adapter instance that has been configured to put messages into these mailboxes, while the other mailboxes have their Extractable Count value defined in the AS3 Partner Wizard UI.

For the other mailboxes used in AS3, we need to create an instance of the Mailbox Scheduled Delete Service to delete the messages. The options provided with the Mailbox Scheduled Delete Service include setting the number of elapsed days before the message gets deleted, the type of message that needs to be deleted, and the different mailboxes which require the delete action and the frequency of the schedule.

Messages need to be deleted in order to archive or purge the business process and document associated with the message. Once this is done, normal purge and archiving functionality will be implemented on all completed business processes and the corresponding document.

See *Managing Services and Adapters* for more information on Scheduling Services.

---

## Create an instance of Mailbox Scheduled Delete Service

### About this task

Use the following procedure to create an instance of the Mailbox Scheduled Delete Service.

### Procedure

1. From the **Administration Menu**, select **Deployment > Services > Configuration**.
2. In the Services Configuration page, in the **Create** section next to **New Service**, click **Go!**
3. In the Select Service Type page, type the name of the service you would like to configure or select it from the list that is available by clicking on the **list view** icon next to Service Type dialog box. Clicking on the **list view** icon opens a

new window, where you need to select the service that you need to configure. Once you select the **Mailbox Scheduled Delete Service**, click **Save** and click **Next**.

4. In the Mailbox Scheduled Delete Service: Name page, in the **Name** parameter, type a unique name.
5. In the **Description** parameter, type a short description for the Service and click **Next**.

**Note:** Select a group can be set as **None** (default).

6. In the Properties page, complete the following parameters and click **Next**:

**Delete only messages older than day(s)**

Type the number of day(s) after which you would like the messages to be deleted. Minimum value is 1. Required.

**Message Extractability**

Describes the type of messages to be deleted.

- Delete Only unextractable messages - deletes the messages from which documents were not extracted during the message exchange. Default.
- Delete All messages - deletes all the messages from the mailbox folder.

Required.

**Message Name Pattern**

Type the pattern of message that you would like to remove from the mailboxes. Optional.

**Select Mailboxes for Message Removal**

Gives you the options for the mailboxes from which you want to delete the messages.

- All Mailboxes (default).
- Selected Mailboxes.

If you select **Selected Mailboxes**, then you need to specify the mailbox names from which you want the messages to be deleted. You can always add more mailboxes as you need them to this list.

Required.

7. In the Schedule Type page, select the type of schedule from the following options:
  - Do not use schedule (default).
  - Run based on timer.
  - Run daily.
  - Run based on day(s) of the week.
  - Run based on day(s) of the month.
8. In the Confirm page, verify the information you specified and click **Finish**.

---

## Chapter 13. AS3 Routing Rules

Routing rules initiate actions automatically when a message is added to a mailbox. Automatic routing ensures that the rule is evaluated at least once.

**Note:** By default, the evaluation of automatic rules is disabled. You need to enable them from the schedule.

When a message is added to a mailbox, any rules established for the mailbox are evaluated automatically. After evaluating automatic routing rules, Sterling B2B Integrator starts any business processes that the rules are configured to run.

When a routing rule is evaluated, it searches the mailboxes defined in the rule for message names that match the pattern defined in the rule. When a match is found, the routing rule notifies the business process or contract specified in the routing rule. Depending on how the business process is defined, it may extract and process the message, extract the message and pass it to another application for processing, or notify another application to extract and process the message. If routing rules are set to be evaluated manually, they can be evaluated by a user or a business process.

You need a routing rule for both the Incoming AS3 Message (InboundAS3) and the Incoming AS3 MDN (InboundMDN) mailboxes. This routing rule is used to invoke predefined business processes to process the AS3 messages and MDNs.

If you chose to have the necessary routing rule automatically created during the partner profile creation process, then the routing rule created is named **Routing Rule created by the AS3 auto create option**. This routing rule is created during the auto-creation process and the Incoming AS3 Message (InboundAS3) and the Incoming AS3 MDN (InboundMDN) mailboxes are attached to the rule. If this routing rule already exists, the AS3 system just adds the two mailboxes to the rule. The routing rule is set up to invoke the As3MbxProcessing business process.

If you do not use the auto-create option when you create trading partner profiles, you need to create your own routing rules to invoke the As3MbxProcessing business process for the Incoming AS3 Message (InboundAS3) and the Incoming AS3 MDN (InboundMDN) mailboxes.

See “Create an AS3 Profile” on page 21 for more information on creating the rule automatically.

Regardless of whether the routing rule is created automatically or manually, you need to schedule the Mailbox Evaluate All Automatic Routing Rules service to be executed so that it can evaluate all mailbox rules designated for automatic processing, including the **Routing Rule created by the AS3 auto create option** routing rule. In addition to this, you need to assign a user or group to the routing rule. The choice of the user or group should match the user or group assigned for the mailboxes, that is InboundAS3 and InboundMDN mailboxes. For auto created mailboxes, the admin user is assigned to the mailboxes. You need to manually assign the user or group to the routing rule because Sterling B2B Integrator allows existing mailboxes to be used. The existing mailboxes may have different user or group assigned to them.

---

## Schedule the AS3 Routing Rule if it Was Created Automatically

### About this task

Use the following procedure to schedule the automatically created routing rule to be evaluated and run automatically:

### Procedure

1. From the **Deployment** menu, select **Schedules**.
2. Search (in the **by Name** section) for **MailboxEvaluateAllAutomaticRules** and select the **Enabled** check box to the left of the schedule name.
3. If you receive a status prompt, click **OK**.
4. If you want to change the frequency at which the routing rule is evaluated, click the **edit** icon to the left of the schedule name.
5. Follow the prompts of the Schedule wizard to redefine the frequency for routing rule evaluation, and click **Finish** when complete.
6. Click **Return**.

---

## Create the Routing Rule Manually

### About this task

Use the following procedure to create the routing rule manually (if you did not have the rule created automatically during the AS3 partner profile creation process):

### Procedure

1. From the **Deployment** menu, select **Mailboxes > Routing Rules**.
2. In the **Create** section, next to **Create a New Routing Rule** click **Go!**
3. Specify a name for the routing rule. This name must be unique for each routing rule. It is used to identify the routing rule in other parts of Sterling B2B Integrator.
4. In the Rule Application page, select the **Evaluation Mode**:
  - Evaluate Manually – The rule must be evaluated manually or evaluated using a scheduled business process.
  - Evaluate Automatically – The rule is evaluated every minute.
5. For **Action Type**, select **Business Process** so the rule notifies a business process when a match is found.
6. Click **Next**.
7. In the Rule Pattern page, select the **InboundAS3** mailbox (or the name you specified for this mailbox if you created it manually) and click the down arrow to add the mailbox to the **Selected Mailboxes** list.
8. In the Rule Pattern page, select the **InboundMDN** mailbox (or the name you specified for this mailbox if you created it manually) and click the down arrow to add the mailbox to the **Selected Mailboxes** list.
9. Specify the **Message Name Pattern** and click **Next**.

This is the message name or pattern that the routing rule searches for in the mailboxes specified. You can use an asterisk for a wildcard. You must specify a mailbox, a message name pattern, or both.
10. In the Rule Action page, select the **AS3MbxProcessing** business process and click **Next**.



11. In the Run Rule as User page, select the User from the user list that is associated with the routing rule when it is run (the User ID you configured for this partner).
12. In the Confirm page, verify the parameters and click **Finish**.
13. When the system update is complete, click **Return**.



---

## Chapter 14. AS3 Message Exchange

AS3 message exchange is initiated using the AS3 Build service. The contract name that you specify when you create the contracts for your trading partner is used to indicate the trading partner with whom you want to exchange the message. Sterling B2B Integrator allows you to exchange single or multiple messages with your partners.

### Single Message Exchange Process

In a single document exchange, you create a business process that includes the AS3 Build service (which you have configured). The AS3 payload can be retrieved from various sources (for example, retrieving from a legacy system or using the File System adapter to collect a message) and is then stored as a primary document within the business process prior to invoking the AS3 Build service. The document retrieved should not have any exclamation mark in its filename. The mailbox functionality fails if it receives any file with that character in the name.

### Multiple Message Exchange Process

In a multiple document exchange, the Bulk Message Generation option (which you configure during trading partner contract creation) is used to initiate multiple exchanges with your partner. As part of the contract creation process, a scheduled business process is created. This scheduled business process, when invoked, confirms that the message exchange with your partner has not been suspended in a previous attempted exchange. It then uses the default instance of the File System adapter within the business process to collect the documents from the specified payload directory and to initiate a predefined business process.

If any connection errors occur, the message exchange to your partner is suspended for the period you specified in the contract.

### Receiving an AS3 Message

AS3 and MDN messages enter Sterling B2B Integrator through the FTP Server adapter. As part of configuring this adapter, you need to create User Accounts for your trading partners and assign the User IDs to the trading partner mailboxes. The necessary AS3 mailboxes were either automatically created during the creation of partner contracts or you created them manually.

During the FTP Server adapter configuration, you can indicate if SSL is required when connecting to the FTP Server. When you configure to use SSL, you must give the public certificate to your partners to use during the SSL *handshake* procedure.

For more information on configuring the FTP Server adapter, see Chapter 11, “FTP Server Adapter Instance for AS3,” on page 43.

### Negative MDNs

When an error occurs in the processing of an inbound AS3 message (with an MDN request specified, a negative MDN is generated and sent back to the trading partner in the mode specified by the Responder Action.

If an error occurs in the processing of an inbound AS3 message without an MDN request specified, a workflow exception occurs and the transaction record is not stored in the MDN Correlation (MSGMDNCORRELATION) table.

### **Outbound Negative MDNs**

When any of these error conditions occur in the processing of an inbound AS3 message with an MDN request specified, a negative MDN is generated with the following disposition-modifier values and sent to the trading partner:

**The receiver could not authenticate the sender.**

Error: authentication-failed

**The receiver could not decrypt the contents of the message.**

Error: decryption-failed

**The receiver could not decompress the message.**

Error: decompression-failed

**Any other processing error (not specified above).**

Error: unexpected-processing-error

The transaction status is updated to **Processed with errors** and stored in the MDN Correlation (MSGMDNCORRELATION) table.

### **Inbound Negative MDNs**

When a negative MDN is received from a trading partner, the corresponding transaction status in the MDN Correlation (MSGMDNCORRELATION) table is updated to **Processed with errors** and the disposition type and disposition modifier values are extracted from the Disposition header of the original message.

---

## Chapter 15. AS3 Message Monitoring and Tracking

Monitoring messages can ensure accurate document processing. Additionally, you can use tracking options to view the correlation between an outbound message, its corresponding MDN (if any), and its state (for example, Processed without errors).

---

### Search for Data Flows

#### About this task

To trace an AS3 message from the time it transfers into Sterling B2B Integrator, as it is processed by Sterling B2B Integrator, to when it is transferred out of Sterling B2B Integrator to an external system, use the Data Flows page.

You can view detailed communication records associated with the document transfers integrated with a document tracking view of the message within Sterling B2B Integrator.

To track an AS3 message through its data flow in Sterling B2B Integrator

#### Procedure

1. From Sterling B2B Integrator **Administration** menu, select **Business Process > Advanced Search > Data Flows**.
2. In the Data Flows page, specify any combination of the following search criteria, as appropriate:

## Search for Current Messages

### About this task

Sterling B2B Integrator provides information about inbound and outbound documents and any designated outbound documents that cannot be processed because of an error. Viewing the information about documents can help you determine if further action is necessary.

The Current Documents feature offers the following benefits:

- You can monitor document processing to ensure documents are processing successfully, and take corrective action if necessary.
- If a problem document is noted, you can view document details with one click to see what happened.
- By default, the page is automatically refreshed every minute for the most current information.



- You can change the number of documents displayed per page, change the name of the document displayed to something more meaningful (for example, document type), and enable detailed document tracking.

To access Current Documents, go to **Business Processes > Current Documents**. The following information is available on the Current Documents page:

- Up to a week of processed documents is displayed. To view documents older than one week, use the **Advanced Search > Documents** feature.
- Documents are generally listed in the order received, with the most current documents at the top.
- Select **Automatically refresh every 20 seconds** to get current information. Deselect this option to disable the automatic refresh.
- Last update date and time displays when the page was last refreshed.

A Summary of the tracked documents is described in the following table:

**Status** Green or red traffic light indicates the processing status of the document:

- Green status indicates no errors or warnings occurred during processing.
- Red status indicates errors or warnings were encountered during processing.

**Document**

Name of the document processed. This can be changed in the business process so that a meaningful name will appear instead of the default. Most pre-configured business processes already have the document name established. Click the document name to view the contents.

**Note:** You can change the metadata for your service to display a more meaningful document name, such as the document type, in Current Documents instead of the default name. The default display is the Body Name, if available, otherwise it is the document ID. Some services, such as EDI documents (EDIFACT, for example), are already configured to display the document type.

**Note:** Contents will not be viewable if encrypted or obscured.

**Proc. ID**

Processing ID assigned by Sterling B2B Integrator as an identification number. Click the Processing ID to view Business Process Details.

**Sender ID**

ID of the document sender as found in the document. If no ID is found, Sender ID is None.

**Receiver ID**

ID of the document receiver as found in the document. If no ID is found, Receiver ID is None.

**Correlations**

Click the Correlations icon to view document correlations.

**Details**

If document tracking is enabled at the business process level, you can view the document history by clicking on Details from the Current Documents page.

## Change the Number of Messages Displayed

### About this task

Current Documents displays the most recent 15 documents that have been processed. You can change this and display more than 15 documents per page by making an adjustment on the My Account page.

To change the number of documents displayed:

### Procedure

1. Select **Accounts > My Account**. The My Account page is displayed.
2. In the **Preferences** section, next to **Page Size for Current Documents**, select the number of documents you want to display on each page. Remember that the larger number you select, the more you will have to scroll to see all of the documents displayed, and the system may take longer to display results.
3. Click **Save**. Your changes are saved. Log out of Sterling B2B Integrator and then log back in to see the change in preferences.

---

## Search for EDI Correlations

### About this task

*Correlation data, often called correlations, is defined as specific pieces of data that you may need to review in the process of monitoring, tracking, and troubleshooting. These data items are defined by type and value. These type-value pairs are known as name-value pairs, and are a powerful tool you can use to record and search for business process- and document-specific data. The name-value pair records are stored in the correlation table in Sterling B2B Integrator.*

Correlation searches rely on name-value pairs that define the specific data items you are trying to locate. These defined name-value pairs are tracking points for business processes and documents. The Correlation search feature offers the following benefits:

- You can receive the results of search queries more quickly.
- You can further refine document correlation searches by specifying matching restrictions for the indicated value of a name-value pair.
- You can further refine correlation searches by specifying a start and end date/time range.
- You can further refine EDI correlation searches by specifying a start and end date/time range for All levels.

Sterling B2B Integrator enables you to find and correlate an AS3 message with an EDI document or data, group, or transaction through a link in the EDI Correlation Search details, a **Document Correlation** information link that displays detailed interchange information about AS3 messages.

If you are using AS3, the Document Correlation link enables you to quickly and easily view interchange details about AS3 messages, and to see the correlation between an AS3 message and a corresponding EDI document or data.

To search for AS3 correlations:

## Search for EDIINT Transaction Records

### About this task

In Sterling B2B Integrator, you can use the Central Search pages to perform basic and advanced searches for information about EDIINT transaction records for business processes that included AS3 processing (including MDNs).

Using the EDIINT search feature, you can use tracking options to view the correlation between an outbound message, its corresponding MDN (if any), and its state (for example, Processed without errors).

To search for EDIINT transaction records for business processes that included EDI interchange processing:

### Procedure

1. From the **Administration** menu, select **Business Processes > Advanced Search > EDIINT**.
2. In the EDIINT Transaction Search page, complete one of the following:
  - Click **Go!** to view all EDIINT transaction records.
