## Sterling File Gateway 1.1 Release Notes

The following issues have been identified for this release:

Defect ID (Internal use only)	Issue Description	Resolution
165324	If the consumer file structure has a PGP layer, the file name format string specified for the inner layer is incorrectly disregarded.	The Integration Architect should still specify the preferred file name format, but not expect it to be enforced until this issue is resolved in a subsequent release.
165510	Error message for producer for a failed transfer reveals mailbox path and identity of consumer.	System Administrator should change permissions for FG_0457 to permissions=subscription. This will prevent the producer from seeing the error information.
167629	Searching by Delivery IP Address in Advanced Search may fail to return the expected results.	Search by the Consumer Name and Protocol to help narrow the search.
167106	When using the "Replace characters, then omit consecutive replacements" option in the "Special Characters" tab of the Routing Channel Template UI, multiple characters are replaced with a single character even if multiple characters are specified.	Enter only one character in the "Replace With" field.
166831	Summary and Detailed sections of reports show inconsistent results for In Progress file count.	Summary section information is correct.
167667	Depending on the duration for which the Arrived Files are being processed, the display of some activity search results may take some time.	Activity search results that show Arrived Files with statuses of Started, Determining Routes, or Routing will display, but may require additional wait time.
