Sterling File Gateway 2.2.5 provides enhanced functionality.

The following enhancements are available in Sterling File Gateway 2.2.5:

Mass replay and redeliver

Beginning with version 2.2.5, Sterling File Gateway provides mass replay and redeliver capability.

You can replay successful or failed routes to have one or more files transferred again from the beginning. You can also redeliver successful or failed routes to have one or more processed files delivered again. In previous versions, you could only replay or redeliver a single file.
