The Parcel Carrier Adapters (Sterling FedEx Adaptor, Sterling ConnectShip Adaptor, and Sterling Pierbridge Adaptor) provides applications with an interface for their carrier-related functionality. It helps companies to quickly meet the changing requirements initiated by both carriers and customers, in the most efficient way.

The Parcel Carrier Adapters have a data-driven design, with functionality defined in terms of the relationship between entities stored as data elements in the database. Carriers having similar functionality can be incorporated into an installation with minimal engineering effort.

# 1.1 Technology Overview

This section explains the architecture of the Parcel Carrier Adapters, and default printers that the Parcel Carrier Adapters support.

# 1.1.1 Parcel Carrier Adapters Architecture




Figure 1–1 Architecture of Parcel Carrier Adapters

Figure 1–1 illustrates Parcel Carrier Adapters integration with FedEx, ConnectShip, and AgileElite server through TCIP/IP socket and HTTP.

**Note:** For LTL/TL (Less-than Truck Load/Truck Load) shipments, integration with any of the Parcel Carrier Adapters is not supported.

# FedEx

The Sterling FedEx Adaptor communicates with the FedEx PowerShip server (FSMS) through TCP/IP sockets. The FedEx Powership server and the Sterling FedEx Adaptor are part of the same LAN/WAN. Labels can be either printed directly from the FedEx server or saved in PNG format. The FedEx server can also return a label buffer, but the current WMS or Sterling FedEx Adaptor integration does not support printing this buffer.

# **ConnectShip**

The Sterling ConnectShip Adaptor communicates with ConnectShip through HTTP. The ConnectShip server is installed on a machine that is part of the same LAN or WAN as that of the Sterling ConnectShip Adaptor. Labels can be printed directly from the ConnectShip server or saved in PNG format.

# **AgileElite Shipment Server**

The Sterling Pierbridge Adaptor communicates with the AgileElite shipment server through HTTP. The AgileElite shipment server is installed on a machine that is a part of the same LAN or WAN as that of the Sterling Pierbridge Adaptor. Labels can be printed either directly from the AgileElite shipment server or saved in .png format on the AgileElite shipment server.

# **Parcel Carrier Adapters Technical Details**

The Sterling Warehouse Management System provides the ability to integrate parcel carriers as a part of the manifesting process within a node.

The Sterling WMS integrates with carriers when:

- Opening a manifest for a carrier
- Adding containers to an open manifest
- Removing containers from an open manifest
- Closing a manifest

The carrier integration is built over an abstraction layer called the Parcel Carrier Adapters. This layer abstracts the integration details to various carriers from the applications. The Parcel Carrier Adapters expose internal APIs corresponding to the Sterling WMS carrier integration as listed (above) to the application layer. For example, in the Sterling WMS, the Parcel Carrier Adapters take a standardized XML, use configuration data specific to carriers to massage the data and pass data to the carriers using specific protocols.

The Parcel Carrier Adapters are preconfigured to integrate directly with FedEx, ConnectShip, and AgileElite shipment server.

This chapter provides technical details of the Parcel Carrier Adapters. It contains descriptions and usage information for the Parcel Carrier Adapters tables, User Exits, and XML.




Figure 2–1 The Parcel Carrier Adapters Tables

### 2.2 Parcel Carrier Adapters Integration Details

Generally, carriers are integrated with the Parcel Carrier Adapters when manifesting. The Sterling Warehouse Management System has the following Parcel Carrier Adapters:

- Sterling FedEx Adaptor
- Sterling ConnectShip Adaptor
- Sterling Pierbridge Adaptor

During manifest, the Sterling WMS integrates with a carrier as follows:

- Selling and Fulfillment Foundation checks if carrier integration is required or not based on the configuration present in YFS\_SCAC and YFS\_SCAC\_EX tables. If carrier integration is required, the Sterling WMS invokes the relevant Sterling Parcel Carrier Adapter.
- The input and output XMLs passed between the carrier's server and the Parcel Carrier Adapters may change based on the API being invoked by Sterling WMS. The Parcel Carrier Adapters create input data needed for these XMLs based on the mapping details provided in Table 2–4, and sends it to the carrier's server.

**Note:** Note that the openManifest API does not support any carrier integration.

### 2.3 Field-Level Mapping for Carriers

This section depicts the conversion of the Sterling WMS input XML to the Parcel Carrier Adapters input XML. It also explains the mapping that is done between the input XML that is passed to the Parcel Carrier Adapters, and the input required for individual carrier servers.

## 2.4 Using User Exits

#### Implementation

There is a class for each user exit, which is called from the application.

**For example:** A user wants to use the shipCarton user exit for a ShipCarton Transaction. There is a Java interface for this transaction for which the user exit has been defined. That is, shipCarton is defined in the Java interface YCSshipCartonUserExit.

This file has to be compiled and the path of the class file should be specified using the User Exit Management in the Applications Manager. For more information about User Exit Management, see the *Selling and Fulfillment Foundation: Application Platform Configuration Guide*.

# Integrating the Sterling Parcel Carrier Adapters with Carrier Servers

This chapter explains the integration of the Parcel Carrier Adapters (Sterling FedEx Adaptor, Sterling ConnectShip Adaptor, and Sterling Pierbridge Adaptor) with carrier servers, ConnectShip, PowerShip for FedEx, and Pierbridge. This chapter provides detailed information about:

- Integrating with ConnectShip
- Integrating with PowerShip
- Integrating with the AgileElite Shipment Server

**Note:** The Parcel Carrier Adapters integrate only with the parcel services, and not with the LTL/TL (Less-Than Truck Load/Truck Load) services.

# 4.1 Integrating with ConnectShip

ConnectShip provides a suite of products to integrate with various carriers. At the core of this product line is Progistics, which provides full functionality access to many parcel carriers (including UPS) in a carrier independent approach. Progistics conforms to Microsoft's Internet technologies like ASP, COM/DCOM and requires Windows-based systems running IIS.

ConnectShip Toolkit, another product of ConnectShip, provides XML over HTTP-based APIs to access these Progistics features.

The Sterling ConnectShip Adaptor uses APIs provided by ConnectShip Toolkit to integrate with all carriers. For more information about ConnectShip capabilities, visit the following Web site: http://www.connectship.com

# 4.1.1 Installing the ConnectShip Toolkit

ConnectShip Toolkit can be downloaded from the 'members area' of ConnectShip website (http://www.connectship.com).

- ConnectShip requires the installation of IIS. For more information about installing ConnectShip, see ConnectShip website.
- While installing choose all the relevant Carrier components, like UPS Domestic, UPS Europe, UPS Canada, UPS Latin America (including Mexico), and UPS Asia Pacific.
- Also choose the relevant printer device models, such as, Eltron, Zebra, and Windows Printer.

# 4.1.2 Configuring the ConnectShip Server

On successful installation, ConnectShip ToolKit is accessible through IIS. This is installed under C:\Inetpub\wwwroot\Progistics and is accessible with Internet Explorer at

http://localhost/Progistics/ASP/index.asp (This link is relative to the server where this software is installed).

Some minimal configuration is required on the ConnectShip server, including creating shippers, and registering the shippers with carriers. This configuration is available under Progistics configuration link.

In configuring a shipper, ensure that shipper abbreviation is mapped to ShipperAccountNumber on the Sterling ConnectShip Adaptor.

Warehouse Management System sets the ShipperAccountNumber Parcel Carrier Adapters XML attribute with the Shipping Account Number in ScacEx setup for ShipNode and Enterprise.

Keep the Abbreviation attribute on ConnectShip exactly the same as that of ShipperAccountNumber. But it would be better if there is a mapping created on the Sterling ConnectShip Adaptor (through YCS\_ GENERAL\_CODES table) between Abbreviation on ConnectShip with ShipperAccountNumber from WMS.

# 4.1.3 Printing Labels and Documents

Labels and documents can be printed by ConnectShip to a network printer or to a local printer. Alternatively, ConnectShip can also return a label buffer to the Sterling ConnectShip Adaptor for printing. For more information about printing labels, Section 4.1.4.2.6, "Printing and Saving UPS Labels".

# 4.1.4 Software Components

## 4.1.4.1 Open Manifest

ConnectShip does not have a corresponding API. It automatically opens a new manifest for the pickup date and the Shipper when the first package is being manifested. While the Sterling ConnectShip Adaptor allows multiple open manifests for a given day for UPS packages, ConnectShip does not support this. ConnectShip allows only one open manifest for a Shipper for a given day. To open a second manifest, the first one has to be closed. So, while integrating with ConnectShip, the Sterling ConnectShip Adaptor ensures that only one open manifest exists for UPS for a given day. To identify if ConnectShip integration is being used, the Sterling ConnectShip Adaptor checks the existence of Logic\_Switch attribute with "CS\_SHIP" and Api\_Name attribute with SHIPCARTON in YCS\_PROCESS\_CONTROL.

# 4.1.4.2 Add Containers to Manifest

ConnectShip provides two APIs called SHIPREQUEST and SHIPMENTREQUEST for manifesting a package. Both have similar XMLs and the Sterling ConnectShip Adaptor uses the SHIPMENTREQUEST API. Apart from manifesting the package, it also returns Tracking #, rating details, and prints labels. This API accepts Shipper, Carrier and Service, Consignee details, and Package & Special Services details as input.

The Sterling ConnectShip Adaptor exposes CS\_SHIP as a Transaction (in YCS\_PLD\_DETAIL table and Logic\_Switch in YCS\_PROCESS\_CONTROL table). If this is configured for the Carrier in which the package is being shipped, then ConnectShip integration is called.

Out-of-the-box, this integration is provided for UPS. FedEx continue to communicate directly to PowerShip.

This component of the Sterling ConnectShip Adaptor transforms the input XML to ConnectShip's requirements based on configuration present in YCS\_PLD\_DETAIL table. Factory defaults are provided for YCS\_PLD\_DETAIL for UPS/CS\_SHIP.

#### 4.1.4.2.1 Shipping international Shipments

These are shipments originating from USA to a consignee in a different country. The Sterling ConnectShip Adaptor integration with ConnectShip for international shipments is different from domestic shipments in the US.

For international shipments, integration with ConnectShip occurs at a Shipment level and not at the Package level. This is required since freight charges at Shipment level is less than the sum of freight charges for individual packages.

The Sterling ConnectShip Adaptor internally calls ConnectShip SHIPMENTREQUEST API, which prints a label for the package and also manifest it. However, in the case of international shipments, ConnectShip is called only after all the packages in the shipment are manifested.

Labels for all packages along with Commercial invoice for Shipment is printed when the last package in the shipment is manifested. The IsLastPackageInShipment attribute has been added to PackageLevelDetail in shipCarton input XML.

Logic for determining whether a package requires Shipment/Package level integration is determined based on Carrier Service code. YFS\_SCAC\_ AND\_SERVICE table has a column called Is\_Shipment\_Level\_Intg\_Reqd based on which the switch occurs.

Note that International shipments have different Service codes as compared to Domestic Services. This is because Domestic shipments would sometimes require Shipment level integration.

Other additional setup required is:

Mapping between Country codes sent by WMS and the Country Symbol code as required by ConnectShip. In YCS\_PLD\_DETAIL table, two ConnectShip XML nodes,

SHIPMENTREQUEST/PACKAGES/PKG/CONSIGNEE/COUNTRYSYMBOL and SHIPMENTREQUEST/PACKAGES/PKG/PACKAGESERVICEOPTIONS/INTL/COMMOD ITYCONTENTS/CONTENT/ORIGINCOUNTRY require this mapping. These fields are mapped to UPSPLD/PackageLevelDetail@ConsigneeCountry and UPSPLD/CommodityRecord@LineOriginCountry attributes on the input XML.

If international shipments are to be sent for countries other than US and Canada, user needs to insert data in YCS\_GENERAL\_CODES table. For example, if you want to ship to Germany, the Sterling Warehouse Management System code is DE, and ConnectShip maps it to GERMANY. Insert the following record in the YCS\_GENERAL\_CODES table:

INSERT INTO YCS\_GENERAL\_CODES (GENERAL\_CODES\_KEY, CARRIER, CARRIER\_ADAPTER\_IMPL\_KEY, CODE, VALUE, DESCRIPTION) values ('PrimaryKey1', UPSN', 'ConnectShipAdaptor', 'DE', 'GERMANY', 'UPSPLD/PackageLevelDetail@ConsigneeCountry');

Similar record must be inserted for the UPSPLD/CommodityRecord@LineOriginCountry attribute.

As a factory setup, the Sterling ConnectShip Adaptor only provides the mapping for US, passed in the input XML by WMS, to "UNITED\_STATES", as required by ConnectShip. Similar mappings would be required for other countries. The Carrier Code to be passed to ConnectShip is TANDATA\_UPS.UPS.

Carrier Service Codes are different for international shipments and domestic shipments. ConnectShip provides three service codes for International shipments: WEPD, WEXPPLS & WEXP. Only these Services can be passed. Default factory data is provided for this mapping based on default WMS configuration. WEPD is mapped to 08, WEXPPLS to 54 and WEXP to 71.

ConnectShip treats UPS Carrier code for Shipments from Canada, Europe, APAC, Latin America and US all differently.

#### 4.1.4.2.2 Shipments from Canada

UPS Carrier Code for Canada is TANDATA\_UPSCANADA.UPS.

#### 4.1.4.2.3 Shipments from Europe

UPS Carrier Code for Shipments from Europe is TANDATA\_UPSINTL.UPS.

#### 4.1.4.2.4 Shipments from APAC

UPS Carrier Code for Shipments from Asia Pacific region is TANDATA\_UPSAPAC.UPS.

#### 4.1.4.2.5 Shipments from Latin America (including Mexico)

UPS Carrier Code for Shipments from Latin America is TANDATA\_UPSLATAM.UPS.

#### 4.1.4.2.6 Printing and Saving UPS Labels

ConnectShip enables automatic printing of UPS labels for the package being manifested. ConnectShip supports printing of US Domestic MaxiCode labels, Canada MaxiCode labels as well as Standard UPS label for shipments from other countries. The factory setup provided by WMS supports printing of MaxiCode labels for US Domestic Shipments and Canada shipments. For rest of the countries, the printing utilizes Standard labels.

ConnectShip also provides the capability to save UPS labels in PNG format. To enable this, you must configure parcel carrier preferences appropriately. For more information about configuring parcel carrier preferences, see the *Sterling Warehouse Management System: Configuration Guide.* ConnectShip returns the label URL in the SHIPMENTRESPONSE input XML whenever a package is manifested using the SHIPMENTREQUEST input XML.

The label format to be printed is determined as follows:

- The Sterling ConnectShip Adaptor internally sets the "UPSPLD/ExtraFieldsRecord@LabelFormatValue" input XML attribute to either DOMESTIC/INTERNATIONAL based on origin and destination countries.
- The Sterling ConnectShip Adaptor looks up YCS\_PLD\_DETAIL table to get the mapping for CarrierFieldName SHIPMENTREQUEST/PACKAGES/PKG/LABELFORMAT and it's DefaultType & DefaultValue.
- For UPSN, the DefaultType is set as MAPPING and mapped to "UPSPLD/ExtraFieldsRecord@LabelFormatValue" input XML attribute.
- In the YCS\_GENERAL\_CODES table, DOMESTIC has been mapped to "TANDATA\_UPS\_MAXICODE\_US\_DOMESTIC.STANDARD" and INTERNATIONAL to "TANDATA\_STDLABEL.STANDARD".
- For other Carriers (UPSC, UPSE, UPSA & UPSL), the DefaultType is set to SYSTEM and DefaultValue to TANDATA\_STDLABEL.STANDARD.

ConnectShip supports printing labels on many printers. Significant among them are many models of Zebra printers as well as Eltron printer models.

Irrespective of whether the Printer is a Zebra/Eltron or a different model, ConnectShip prints to that printer if printer driver is installed on the machine where ConnectShip is installed, by passing the PrinterModelSymbol as "GENERIC.WINDOWSPRINTER".

ConnectShip can also return the label string back to the Sterling ConnectShip Adaptor if the Printer Port is passed as "STRING" instead of a PrinterName. Label string that ConnectShip returns is based on the PrinterModel that is passed to it. However Port cannot be passed as "STRING" if PrinterModelSymbol is passed as

"GENERIC.WINDOWSPRINTER". PLD setup provided in factory setup for printing is listed below. In B2C scenarios where a shipment is predominantly a single package shipment, implementations can pass the value "STRING" in the

"UPSPLD/ExtraFieldsRecord@ThermalLabelPrinterID" Parcel Carrier Adapters input XML attribute to get back the Printer string and print this UPS label as a part of a A4 Packing slip.

#### 4.1.4.2.7 Printing Other Documents

ConnectShip also prints shipment level documents like Commercial Invoice, SED, and Certificate of Origin. These documents are valid only for international shipments, as integration at shipment level occurs only for international shipments. The Sterling ConnectShip Adaptor prints these documents only when the last international package is being manifested.

**Note:** In order to print shipment level documents, you need to install the Sterling Warehouse Management System on top of Selling and Fulfillment Foundation.

Shipment Level documents that need to be printed can be configured in YCS\_PLD\_Detail. The Sterling ConnectShip Adaptor provides printing of Commercial Invoice in the Factory setup. Additional documents can just be similarly added. The attribute ShipmentDocumentPrinterID added to the Sterling ConnectShip Adaptor input XML obtains the printer details for printing these documents.

## 4.1.4.3 Close Manifest

ConnectShip provides an API called "CloseOutRequest" to close the manifest. The Sterling ConnectShip Adaptor accepts Carrier, Manifest#, and ShipperAccountNumber as inputs for closing a manifest. The Sterling ConnectShip Adaptor changes the status of manifest and deletes all packages (YCS\_MANIFEST\_UPS\_DTL) on the Sterling ConnectShip Adaptor database and then calls ConnectShip's CloseOutRequest API.

The Sterling ConnectShip Adaptor additionally checks to see if all printed packages are manifested. If any of the packages have not been manifested, this API throws an error. Such packages have to be removed from the manifest (either by User or by WMS) and reprinted (by manifesting them). For shipment level integration, actual manifestation of packages with ConnectShip happens when the last carton in the shipment is manifested on WMS. However, if user is trying to close the manifest even before all the packages in a shipment are manifested, then the Sterling ConnectShip Adaptor automatically calls ConnectShip's SHIPMENTREQUEST API to close all these shipments. Note that WMS actually disallows closure of Manifest if all packages are not manifested. But this helps in situations where all packages in a Shipment are manifested by user and when WMS fails to specify the last package to the Sterling ConnectShip Adaptor. This would typically happen if the last package was deleted from WMS before it was manifested.

# 4.1.4.5 Print Container Labels

The Sterling ConnectShip Adaptor component generates Tracking # and prints the carton label without actually manifesting it. WMS implementations may want carrier carton labels to be printed during wave release or at the time of manifest. Implementations that need these labels to be printed during wave release can use this component.

ConnectShip allows user to generate Tracking # and return rating information without actually manifesting the containers.

During actual manifestation, Sterling ConnectShip Adaptor also checks to see if the package has been modified after it was printed. If package was modified, then it would return an error to inform the user to void the package and reprint it. To determine if Package is modified, it would check to see if the following attributes have changed or not:

- ConsigneeAddress1
- ConsigneeAddress2
- ConsigneeCity
- PickupDate

#### 4.1.5.1 Adding New Carriers to the Sterling ConnectShip Adaptor

Selling and Fulfillment Foundation can be easily configured to integrate with the Sterling ConnectShip Adaptor to support other carrier services. For more information about the carriers and services, see Section 3.3, "Pre-Configured Carriers". To add a new carrier to the Sterling ConnectShip Adaptor, perform the following steps:

- From the YCS\_PROCESS\_CONTROL table, copy only those records that have UPSC as the Carrier Code, insert the records into the same table, and change the Carrier Code to that of the new carrier.
- From the YCS\_GENERAL\_CODES table, copy only those records that have UPSC as the Carrier Code, insert the records into the same table, and change the Carrier Code to that of the new carrier.

The YCS\_GENERAL\_CODES table provides a translation of the Selling and Fulfillment Foundation XML attribute values to ConnectShip-specific values with respect to some of the attributes. Most of these attributes, such as Sunday Delivery Required, Residential Flag, and Consignee Country are not specific to any particular carrier, and can be copied from UPSC. However, attributes such as Carrier Service Code is specific to each carrier, and such records must be modified with appropriate ConnectShip values. Table 4–12 lists the attributes that must be updated with ConnectShip carrier-specific values.

# 4.1.5.2 Adding New Services to the Sterling ConnectShip Adaptor

Selling and Fulfillment Foundation can be easily configured to integrate with the Sterling ConnectShip Adaptor to support other carrier services. For more information about the carriers and services, see Section 3.3, "Pre-Configured Carriers". To add a new service to the Sterling ConnectShip Adaptor, perform the following steps:

- 1. From the YCS\_GENERAL\_CODES table, copy only those records that meet all the following requirements:
  - The value of the CarrierAdapterImplKey column must be ConnectShipAdaptor.
  - The Carrier Code can be that of any carrier.
  - The Description can be either ReprintPackage@UPSServiceType or UPSPLD/PackageLevelDetail@UPSServiceType.
- 2. Insert these records back into the YCS\_GENERAL\_CODES table.

- 3. Make the following changes to the newly added records:
  - Carrier Code to that of the new carrier.
  - Electronic Code to that of the Electronic Code of the carrier service.
  - Service Code to that of the new Service Code. The new Service Code must be set as to the code that ConnectShip uses to address the carrier service.

# 4.2 Integrating with PowerShip

This section explains the integration of the Sterling FedEx Adaptor with the FedEx PowerShip server.

# 4.2.1 Software Components

#### 4.2.1.1 Open Manifest

PowerShip does not have a corresponding API. It automatically opens a new manifest for the pickup date and the shipper when the first package is manifested. For FedEx packages, the Sterling FedEx Adaptor doesn't allow you to simultaneously open multiple manifests for a given day. To open a second manifest, the first manifest must be closed. Therefore, when integrating with PowerShip, the Sterling FedEx Adaptor ensures that only one open manifest exists for FedEx for a given day.

#### 4.2.1.2 Add Containers to Manifest

PowerShip provides string-based transaction 020 for manifesting a package. When manifesting a package, the carrier label is generated for the package. Return labels can also be generated for the package if the package contains returnable items, and the FedEx carrier service used to manifest allows returns.

The Sterling FedEx Adaptor exposes transaction 020 (in the YCS\_PLD\_ DETAIL table and Logic\_Switch in YCS\_PROCESS\_CONTROL table).

This component of the Sterling FedEx Adaptor transforms the input XML to the requirements of PowerShip based on the configuration present in the YCS\_PLD\_DETAIL table. The factory defaults are provided for the YCS\_PLD\_DETAIL table for FEDX or 020.

#### 4.2.1.2.1 Shipping International Shipments from USA

These are shipments originating from USA to a consignee in a different country. The Sterling FedEx Adaptor integration with PowerShip for international shipments is different from domestic shipments in the USA.

For international shipments, integration with PowerShip occurs at a shipment level and not at the package level because freight charges at shipment level is less than the sum of freight charges for individual packages.

The logic for determining whether a package requires shipment or package level integration is based on the Carrier Service code. The YFS\_SCAC\_AND\_SERVICE table has a column Is\_Shipment\_Level\_Intg\_Reqd based on which the switch occurs.

Labels for all packages are printed when the last package in the shipment is manifested. The IsLastPackageinShipment attribute has been added to PackageLevelDetail in the shipCarton input XML.

The Sterling FedEx Adaptor uses open shipping method of PowerShip to manifest shipments that requires shipment level integration.

The Country Codes sent by the Sterling Warehouse Management System and the Country Symbol Code of the FedEx PowerShip server (FSMS) must be mapped. Table 4–13 describes the field-level mapping in the YCS\_PLD\_DETAIL table.

If international shipments are to be sent for countries other than US and Canada, user needs to insert data in YCS\_GENERAL\_CODES table. #### 4.2.1.2.2 Printing and Saving FedEx Labels

PowerShip enables printing of FedEx labels automatically for packages that are manifested. PowerShip also provides the capability to save labels in PNG format in the default directory. To enable this functionality, you must configure the parcel carrier preferences appropriately. For more information about configuring parcel carrier preferences, see the *Sterling Warehouse Management System: Configuration Guide*.

FedEx generates PNG image of the carrier label for the package that is manifested if the value of the label format FSMS Field ID 187 is set to "PNG". The label is saved in the default directory of PowerShip.

The label format that is to be printed is determined as follows:

- The Sterling FedEx Adaptor internally sets the UPSPLD/ExtraFieldsRecord@LabelFormatValue attribute of the input XML to the Device Sub Type of the printer configured to print the FedEx label. For creating a Device Sub Type, see the Selling and Fulfillment Foundation: Application Platform Configuration Guide.
- The Sterling FedEx Adaptor searches in the YCS\_PLD\_DETAIL table to retrieve the records for FieldName LabelFormatValue. For this record, the DefaultType is set to MAPPING, and mapped to the UPSPLD/ExtraFieldsRecord@LabelFormatValue attribute of the input XML.
- In the YCS\_GENERAL\_CODES table, the record with Description LabelFormatValue and the Code equal to UPSPLD/ExtraFieldsRecord@LabelFormatValue is selected and the value of the field named Value of this record is passed as a label format value to FSMS.

Default mapping is provided for Eltron and Zebra printers for determining the value of field 187. The list of values that is used in field 187 for other printers are as follows:

- Unimark U550 4x6 doc tab 177
- Unimark U550 4x6 non doc tab 277
- Eltron LP2348 or LP2443 4x6 doc tab 199

PowerShip enables the user to generate tracking number and return rating information without manifesting the containers.

During manifestation, the Sterling FedEx Adaptor verifies if the package is modified after printing it. To determine this, the Sterling FedEx Adaptor checks whether the following attributes are changed:

- ConsigneeAddress2
- ConsigneeCity
- PickupDate

If the package is modified, the Sterling FedEx Adaptor throws an error. To reprint the package, you must void it.

# 4.3 Integrating with the AgileElite Shipment Server

The AgileElite shipment server provides a unified view of multiple carriers, including UPS, USPS, FedEx, and Purolator in a carrier-independent approach through its XML interface. It allows shipping functionalities, such as Ship, Rate, and Void. The AgileElite shipment server is an open Web service built on Microsoft .NET, and is highly scalable and reliable. For more information about Pierbridge's capabilities, visit the following Web site: http://www.pierbridge.com

# 4.3.1 Installing the AgileElite Shipment Server

Before installing the AgileElite shipment server, ensure that all the corresponding prerequisites are met. For more information about how to install the AgileElite shipment server and the prerequisites, refer the corresponding Pierbridge documentation.

When installing the AgileElite shipment server, install the following components:

- Pierbridge Administrators Toolbar
- Pierbridge FSMS Label Server
- Pierbridge Shipment Server

**Note:** Because the AgileElite shipment server uses Microsoft SQL Server 2005, sqljdbc.jar version 1.2 must be installed in Selling and Fulfillment Foundation. For more information about installing the sqljdbc.jar file, refer to the *Selling and Fulfillment Foundation: Installation Guide*.

**Note:** The AgileElite shipment server uses the ConnectShip server to integrate with the UPS and USPS carriers. Similarly, this server connects to the FedEx PowerShip Server for integrating with FedEx-supported carriers. Both the ConnectShip server and the FedEx server should be installed and configured on the machine where the AgileElite shipment server is installed in order to integrate with the carriers supported by them.

# 4.3.2 Configuring the AgileElite Shipment Server

Configurations pertaining to the following must be performed on the AgileElite shipment server:

 Organization and Location - An organization is an entity that ships packages. The AgileElite shipment server setup requires at least one organization to be added to the AgileElite shipment server. A location refers to an organization's address. Every organization must have at least one location associated with it. The address will be overridden by the transactional requests sent by the Sterling Pierbridge Adaptor. The Sterling Warehouse Management System will not use the details pertaining to the organization that has been added to the AgileElite shipment server.

- Carrier The carriers that are supported by the Sterling Pierbridge Adaptor are listed in Table 3–1. These carriers should be enabled on the AgileElite shipment server. The AgileElite shipment server uses the ConnectShip server to integrate with the UPS and USPS carriers. Ensure that these carries are enabled in the ConnectShip server too.
- User The AgileElite shipment server uses the Windows user as the AgileElite shipment server user. The transactional requests sent by the Sterling Pierbridge Adaptor are sent with respect to this Windows user that exists on the AgileElite shipment server. Therefore, when configuring a user, ensure that the Windows User Name is exactly the same as the ShipperAccountNumber on the Sterling Warehouse Management System. The Sterling Warehouse Management System sets the ShipperAccountNumber Parcel Carrier Adapters XML attribute with the Shipping Account in the Parcel Carrier Preference for ShipNode and Enterprise. Similarly, a user must be configured on the AgileElite shipment server with the same User Name as that of the default Rate Request User provided in the <INSTALL\_ DIR>/properties/yfs.properties\_ycs\_ext file.

After a user is configured, necessary permissions must be granted to the user in order to allow the user to perform relevant shipping activities. For activities such as shipping a container, if the bill payer is not specified in the request sent by the Sterling Pierbridge Adaptor, the bill payer value that is configured in the Default Bill Payer field in the Permissions tab of the AgileElite shipment server becomes the default value.

 Accounts - The AgileElite shipment server connects internally with the ConnectShip server and the FedEx server in order to ship packages using various carriers. Ensure that the necessary security credentials and account information are configured for the carriers on the AgileElite shipment server. Also ensure that the user has the required permission to ship the packages using the carriers configured on the AgileElite shipment server.

- Device When configuring the device (in this case, a printer for printing labels) and providing a description of the printer on the AgileElite shipment server, ensure that you enter the complete path to the printer on the network. This path must match the printer alias of the printer configured on the Sterling Warehouse Management System.
- Output In order to configure the formatting of shipping labels and other documents, provide the required permissions for the AgileElite shipment server users to allow them to print labels, return labels, and documents. All AgileElite shipment server users should be granted permission to use all the printers that are configured using the Device tab. If a user wants to save labels as images, configure the PrinterType field as Client on the AgileElite shipment server, under the Outputs tab. When this configuration is completed, the URL of the labels will be returned as output in response to the ship transaction. This URL will be in encoded format.

#### Notes:

- When the Save label as images option is set in the Sterling Warehouse Management System, a user must manually configure the PrinterType field as Client on the AgileElite shipment server. Also, in the AgileElite shipment server, select Images from the Format drop-down list by navigation to Outputs > Config.
- When a user wants to print a label using a specific printer, and if that printer is incorrectly configured in the Outputs tab of the AgileElite shipment server, by default, the label is printed using the first available printer configured in the Outputs tab.
- It is recommended that in the Outputs tab of the AgileElite shipment server, you select only the specific user or user group from the User/Group drop-down list to whom you want to grant permission to perform certain configurations, and not all users.

# 4.3.3 Printing Labels and Documents

Labels and documents can be printed by the AgileElite shipment server to either a network printer or a local printer. Alternatively, the AgileElite shipment server can also return a label buffer to the Sterling Pierbridge Adaptor for printing. For more information about printing labels, see Section 4.3.4.2.2, "Printing and Saving Labels".

# 4.3.4 Software Components

This section explains the various transactions available with the AgileElite shipment server.

#### 4.3.4.1 Open Manifest

The AgileElite shipment server does not have a corresponding API. It automatically opens a new manifest for the pickup date and the shipper when the first package is being manifested. The Sterling Pierbridge Adaptor doesn't allow to simultaneously open multiple manifests on a given day and for a carrier. The Sterling Pierbridge Adaptor also allows only one open manifest for a shipper for a given day. To open a second manifest, you must close the first manifest. So, when integrating with the AgileElite shipment server, the Sterling Pierbridge Adaptor ensures that only one open manifest exists for a carrier on a given day.

#### 4.3.4.2 Add Containers to Manifest

The AgileElite shipment server provides the ShipRequest transaction for manifesting a package. Apart from manifesting the package, this transaction also returns the tracking number, rating details, and prints the labels. This transaction accepts the details pertaining to the Shipper, Carrier and Service, Consignee, Package, and Special Services as inputs. When manifesting a package, a carrier label is generated for the package. Return labels can also be generated for the package if the package contains returnable items, and the carrier service used to manifest allows returns. The returns functionality is available for both FedEx and UPSN carriers that use the Sterling Pierbridge Adaptor.

The Sterling Pierbridge Adaptor transforms the input XML to the AgileElite shipment server's requirements based on the configurations present in the YCS\_PLD\_DETAIL table.

#### 4.3.4.2.1 Shipping International Shipments

The international shipments originate from a country and go to a consignee located in a different country. The Sterling Pierbridge Adaptor integration with the AgileElite shipment server for international shipments is different from domestic shipments.

For international shipments, integration with the AgileElite shipment server occurs at a shipment level and not at the Package level. This is because freight charges at the shipment level is less than the sum of the freight charges for individual packages. For international shipments, after the pack process, it is mandatory to enter the ITN#.

For domestic shipments, the Sterling Pierbridge Adaptor internally calls AgileElite shipment server's ShipRequest transaction, which prints a label for the package and also manifest it. However, in the case of international shipments, AgileElite shipment server transaction is called only after all the packages in the shipment are manifested.

Labels for all the packages along with the Commercial Invoice for a shipment is printed when the last package in the shipment is manifested. The IsLastPackageInShipment attribute has been added to PackageLevelDetail in the shipCarton input XML.

**Note:** In order to print shipment level documents, you need to install the Warehouse Management System on top of Selling and Fulfillment Foundation.

Logic for determining whether a package requires Shipment or Package level integration is determined based on the Carrier Service code. The Is\_Shipment\_Level\_Intg\_Reqd column in the YFS\_SCAC\_AND\_SERVICE table helps to determine whether a package requires Shipment or Package level integration.

**Note:** The international shipments have different service codes as compared to domestic shipments. This is because domestic shipments sometimes require shipment level integration.

#### 4.3.4.2.2 Printing and Saving Labels

The AgileElite shipment server provides the functionality to automatically print labels for packages that are manifested. AgileElite shipment server also provides the capability to save labels in .png format by configuring the parcel carrier preferences appropriately. For more information about configuring the parcel carrier preferences, see the *Sterling Warehouse Management System: Configuration Guide*. The AgileElite shipment server returns the label URL in the ShipResponse input XML whenever a package is manifested using the ShipResponse input XML.

The AgileElite shipment server supports most of the printer models for printing labels, including Zebra and Eltron.

Following are the various printer models available on the AgileElite shipment server:

Irrespective of the printer model, AgileElite shipment server prints to any printer whose printer driver is installed on the machine where the AgileElite shipment server is installed, and is configured as Generic Windows on the AgileElite shipment server.

Based on the PrinterType configurations carried out on the AgileElite shipment server, the AgileElite shipment server will either return the URL of the label, or print the label.

To switch between the printing tasks, you must manually modify the configurations on the AgileElite shipment server. In Selling and Fulfillment Foundation, the behavior of the reprint transaction depends on the AgileElite shipment server configuration.

For more information about configuring the AgileElite shipment server, see Section 4.3.2, "Configuring the AgileElite Shipment Server".

#### 4.3.4.2.3 Printing Other Documents

The AgileElite shipment server also prints shipment-level documents such as Commercial Invoice, Certificate Of Origin, and Shipper's Export Declaration (SED). These documents are valid only for international shipments because integration at the shipment level occurs usually for international shipments. The Sterling Pierbridge Adaptor prints these documents only when the last international package is manifested. **Note:** In order to print shipment level documents, you need to install the Sterling Warehouse Management System on top of Selling and Fulfillment Foundation.

The shipment-level documents that are to be printed can be configured in the YCS\_PLD\_DETAIL table. The Sterling Pierbridge Adaptor provides the capability to print Commercial Invoices in the factory setup. Additional documents can be printed similarly. The ShipmentDocumentPrinterID attribute of the Sterling Pierbridge Adaptor input XML obtains the printer details for printing these documents.

#### 4.3.4.3 Close a Manifest

The AgileElite shipment server provides the EndOfDayActionRequest transaction to close a manifest. The Sterling Pierbridge Adaptor accepts carrier code, manifest number, and shipper account number as inputs for closing a manifest. The Sterling Pierbridge Adaptor changes the status of the manifest, deletes all the packages on the YCS\_MANIFEST\_UPS\_DTL Sterling Pierbridge Adaptor database, and invokes the EndOfDayActionRequest transaction.

#### 4.3.4.4 Remove Containers From a Manifest

The AgileElite shipment server provides the VoidRequest transaction to remove a container from a manifest. This transaction requires the shipper account number and tracking number. The AgileElite shipment server identifies a package based on the tracking number, and returns this number when a package is included in a manifest using the ShipRequest transaction.

#### 4.3.4.5 Print Container Labels

The Sterling Pierbridge Adaptor generates the tracking number and prints the carton label without manifesting it. The Sterling Warehouse Management System implementations may want carrier carton labels to be printed either during wave release or at the time of manifest. Implementations that require these labels to be printed during wave release can use this printing mechanism. The AgileElite shipment server enables users to generate the tracking number and returns the rating information without manifesting the containers.

During manifestation, the Sterling Pierbridge Adaptor also verifies if the package has been modified after it is printed. If the package has been modified, it returns an error, informing the user to void the package and reprint it. To determine if the package is modified, Sterling Pierbridge Adaptor verifies whether any of the following attributes have changed:

- PackageActualWeight
- ConsigneeAddress1
- ConsigneeAddress2
- ConsigneeCity
- PickupDate

#### 4.3.4.6 Reprint Container Labels

The Sterling Pierbridge Adaptor component regenerates carton labels and reprints the labels for cartons for which the tracking numbers have already been generated. To reprint a label, ensure that the PrinterType field in the Outputs tab is configured as Windows on the AgileElite shipment server.

# 4.3.5 Adding New Carriers and Services to the Sterling Pierbridge Adaptor

This section describes the process of adding new carriers and services to the Sterling Pierbridge Adaptor.

**Note:** If you are performing an upgrade, for an existing carrier that is not given as part of the factory setup, integration with the Sterling Pierbridge Adaptor will take place only after you perform the steps mentioned in the subsequent sections.

#### 4.3.5.1 Adding New Carriers to the Sterling Pierbridge Adaptor

Selling and Fulfillment Foundation can be easily configured to integrate with the Sterling Pierbridge Adaptor to support other carrier services. For more information about the carriers and services, see Section 3.3, "Pre-Configured Carriers". To add a new carrier to the Sterling Pierbridge Adaptor, perform the following steps:

- From the YCS\_GENERAL\_CODES table, copy only those records that have the value of the CarrierAdapterImplKey column as PierbridgeAdaptor, and the Carrier Code can be any carrier.
- 2. Insert all these records back into the YCS\_GENERAL\_CODES table, and change the Carrier Code to that of the new carrier that is to be added.

The YCS\_GENERAL\_CODES table provides a translation of the Selling and Fulfillment Foundation XML attribute values to Pierbridge-specific values with respect to some of the attributes. Most of the attributes, such as Sunday Delivery Required, Residential Flag, and Consignee Country, are not specific to a particular carrier, and can be copied from any carrier. However, attributes such as Carrier Service Code is specific to each carrier, and such records must be modified with the appropriate AgileElite shipment server values.

- From the YFS\_SCAC\_ADAPTER\_SUPPORT table, copy any record that has the value of the CarrierAdapterImplKey column as PierbridgeAdaptor, and the Carrier can be any carrier.
- 4. Insert the record back into the YFS\_SCAC\_ADAPTER\_SUPPORT table, and change the Carrier to that of the new carrier that is to be added.

#### 4.3.5.2 Adding New Services to the Sterling Pierbridge Adaptor

Selling and Fulfillment Foundation can be easily configured to integrate with the Sterling Pierbridge Adaptor to support other carrier services. For more information about the carriers and services, see Section 3.3, "Pre-Configured Carriers". To add a new service to the Sterling Pierbridge Adaptor, perform the following steps:

- 1. From the YCS\_GENERAL\_CODES table, copy only those records that meet all the following requirements:
  - The value of the CarrierAdapterImplKey column must be PierbridgeAdaptor.

- The Carrier Code can be that of any carrier.
- The Description can be either FreightCharge/Shipment@Service, ReprintPackage@UPSServiceType, UPSPLD/PackageLevelDetail@UPSServiceType, or UPSPLD/ReturnShippingLabels/ReturnShippingLabel@UPSServiceType.
- 2. Insert all these records back into the YCS\_GENERAL\_CODES table.
- 3. Make the following changes to the newly added records:
  - Carrier Code to that of the new carrier
  - Electronic Code to that of the Electronic Code of the carrier service.
  - Service Code to that of the new Service Code. The new Service Code must be set as the code that the AgileElite shipment server uses to address the carrier service.

# **Troubleshooting Connectivity Issues**

This chapter describes some issues that are commonly encountered with the Parcel Carrier Adapters (Sterling FedEx Adaptor, Sterling ConnectShip Adaptor, and Sterling Pierbridge Adaptor). It also includes some tips discovered during the development of the Parcel Carrier Adapters Framework.

# 5.1 Dumping inXML on the Parcel Carrier Adapters

To dump inXML on the Parcel Carrier Adapters, use the <INSTALL\_DIR>/properties/customer\_overrides.properties file to set the ycs.xmlDump.directory property. In the value for this property specify the directory, where you want the inXML file to be dumped.

For additional information about overriding properties using the customer\_overrides.properties file, see the *Selling and Fulfillment Foundation: Properties Guide*.

# 5.2 SaxParseException Encountered While Manifesting a Container

The following error is displayed while manifesting a container:

org.xml.sax.SAXParseException

#### Cause

If a SaxParseException is encountered while manifesting a container, it may be due to the address line or fax number exceeding 35 and 15 characters respectively.

#### Resolution

This problem can be fixed by ensuring that the address line and fax number fields do not exceed 35 and 15 characters respectively.

# 5.3 FedEx Issues

The section describes some issues that are commonly encountered with FedEx.

## 5.3.1 Dumping the FedEx Input String

The flag for dumping the XML and reply buffer to a file is set to "N" by default.

In the YCS\_GENERAL\_CODES table, the VALUE field has to be set to "Y" for the record with the CARRIER value of "FEDX" and the CODE value of "FEDEXINXMLDUMP".

The naming convention for the dumped file name is as follows:

<CARRIER><CartonNo>.txt or <CARRIER><PalletSCM>.txt, depending on whether it is a carton SCM or pallet SCM.

For example: The name of the file maybe FEDX0000201001.txt

(Where 0000201001 is the carton number and FEDX is the Carrier)

The file is dumped into the XMLlog directory.

## 5.3.2 Dumping the FedEx Output String

The flag for dumping the XML and reply buffer to a file is set to "N" by default.

In the YCS\_GENERAL\_CODES table, the VALUE field has to be set to "Y" for the record with the CARRIER value of "FEDX" and the CODE value of "FEDEXREPLYDUMP".

The naming convention of the dumped file name is as follows:

<CARRIER><CartonNo>.txt or <CARRIER><PalletSCM>.txt, depending on whether it is a carton SCM or pallet SCM.

For example: The name of the file may be FEDX0000201001.txt

(Where 0000201001 is the carton number and FEDX is the Carrier)

The file is dumped into the XMLlog directory.

# 5.3.3 Label Not Getting Printed

Carton is getting manifested, but the label is not getting printed.

#### Cause A

The printer associated with the station is not configured, or is incorrect.

#### Cause B

The printer is not online or out of labels.

#### Cause C

Mismatch in the device subtype printer or incorrect record is present in the YCS\_GENERAL\_CODE table.

# 5.3.4 Label Not Getting Reprinted or Getting a "Tracking Number Not Found" Error When Reprinting

Label is not getting reprinted, or getting a "Tracking Number Not Found" error message when trying to reprint label.

#### Cause

The reprint of carrier labels is supported only by the printer type that printed the same carrier label previously, although different physical devices are available to print the carrier label.

# 5.3.5 Unable to Compute Freight Charge Error

You receive an "Unable to compute freight charge" error.

#### Cause

- In the carrier setup, external server type is not set to "F2".
- The shipping key is invalid.

#### Cause

The account number in the carrier code setup is wrong or the shipping key mapping in the YCS\_GENERAL\_CODES table is wrong. Account ID 2

in the carrier setup is not linked to the shipping key in the YCS\_GENERAL\_CODES tables.

# 5.3.6 Unable to Manifest Containers of an International Shipment

You receive a "Description 1 cannot be left blank" error.

#### Cause

This error message is displayed when a container is being added to manifest, and the NMFC code or the NMFC class of the item in that container is not configured.

#### Resolution

To resolve this issue, configure either the NMFC code or the NMFC class for each of the items being shipped in the corresponding international shipment.

# 5.3.7 Error Message is Displayed When Reprinting a Carrier Label

You receive a "Tracking No not found" error message when you try to reprint a carrier label.

#### Cause

This error message is displayed if the corresponding label was not printed during the Tracking Number generation process. This occurs if the Fedex carrier label printer document is not associated with a printer.

#### Resolution

To resolve this issue, the Fedex carrier label printer document should be associated to a printer. Also the current Tracking Number must be made void, and the container must be manifested again.

# 5.4 ConnectShip Issues

The section describes some issues that are commonly encountered with ConnectShip.

# 5.4.1 Manifesting Cartons that are Modified After Carrier Label Print

Carrier specific labels can be printed during Wave release using the getTrackingNoAndPrintLabel API.

If these cartons are modified (for example, units are added or removed from the package) before they are manifested, the Sterling ConnectShip Adaptor stops the user from manifesting such cartons.

The way to handle this situation is to undo the label print by calling the voidTrackingNo API and then manifest the package.

# 5.4.2 Closing a Manifest When Some Expected Cartons are Not Manifested

When a package label is printed during a Wave Release, a Manifest is automatically opened for the Expected Shipment Date of the package.

If the Node is unable to ship the package on that date and has to close the Manifest for the remaining packages, the label and tracking # generated for all such un-manifested packages have to be voided by calling the voidTrackingNo API.

# 5.5 AgileElite Shipment Server Issues

The section describes some issues that are commonly encountered with the AgileElite shipment server.

#### **Error Message**

Error opening input transaction.

#### Cause

This error message is displayed when a valid account number is not configured in the Parcel Carrier Preference window of the Selling and Fulfillment Foundation Applications Manager pertaining to a shipper.

#### Resolution

Configure a valid shipping account number for the shipper in the Parcel Carrier Preference window of the Selling and Fulfillment Foundation Applications Manager.

#### **Error Message**

Unit of measure for commodity is unacceptable.

#### Cause

This error message is displayed when a Unit of Measure (UOM), for example, pound, is not accepted by the AgileElite shipment server.

#### Resolution

None.

#### Error Message

or Length girth.

#### Cause

This error message is displayed when the dimensions of a container that is being manifested are not acceptable.

#### Resolution

None.

#### Error Message

Invalid FTR No.

#### Cause

This error message is thrown when the International Tracking Number (ITN) number is not posted for a shipment.

#### Resolution

None.

#### Error Message

Invalid Payer Type.

#### Cause

This error message is displayed in the context of USPS domestic shipments when manifesting using either COLLECT or Third Party billing freight terms.

#### Resolution

None.

#### **Error Message**

Incomplete Dimensions.

#### Cause

This error message is displayed when the dimensions (length, height, and width) of a package are zero.

#### Resolution

To resolve this issue, at the manifest station, select a valid container type for the container that is being manifested.

#### Error Message

Description Required for each International Package.

#### Cause

This error message is displayed when a container is being added to manifest, and the NMFC code or the NMFC class of the item in that container is not configured.

#### Resolution

To resolve this issue, configure either the NMFC code or the NMFC class for each of the items being shipped in the corresponding international shipment.

#### Error Message

Package #1: Invalid contact SHM5-A.

#### Cause

This error message is displayed when a container is being added to a manifest, and the name of the user receiving this shipment is not configured in the Sterling Warehouse Management System.

#### Resolution

To resolve this issue, configure the name of the user receiving the shipment in the Sterling Warehouse Management System.

#### Error Message

Recipient phone number cannot be left blank

#### Cause

This error message is displayed when invoking the addContainerToManifest API if all the contact numbers of the receiver of the shipment are left blank.

#### Resolution

To resolve this issue, configure the contact numbers of the receiver of the shipment.
