# What's New in Release 10.0.1

## Scope

---

This chapter contains information about the new features that are available with the 10.0.1 release of Emptoris Supplier Lifecycle Management.

## Workflow Enhancements in Supplier Qualification

---

With 10.0.1, the supplier registration workflow is enhanced.

Users can now cancel the supplier registration process if they do not want to complete the registration process.

Users can also re-open the supplier assessment for internal or external respondents in the Supplier Qualification module.

## Updating Supplier Registration Information through Adhoc Assessment

---

With 10.0.1, users can now update the supplier registration information by creating an adhoc assessment series for the registered supplier in the Supplier Qualification module.

## Other Supplier Qualification Enhancements

---

The following additional enhancements are done in the Supplier Qualification module:

- After a supplier is cleared and registered successfully, the supplier is created automatically in the Emptoris Virtual Supply Master module of the Emptoris Strategic Supply Management platform.
- During registration of a potential supplier, the user with the Clearing role defines a user ID and user contact login name in the Emptoris Strategic Supply Management platform.

- While initiating spontaneous supplier registration, a new disabled field is added to the registration template that displays the registration template link.
- You can now select a region based object type for the Entity answer type to provide additional restrictions while answering state and country specific questions.

## Generating Hardfacts in Performance Evaluation

---

With 10.0.1, users can now generate hardfacts from the Performance Evaluation module. Hardfacts can be generated for a criterion, chapter, or the Performance Evaluation result.

## Support for Notifications in Supplier Classification

---

With 10.0.1, notifications are triggered by the application on account of a user action or status change in the Supplier Classification process. All user communication with internal or external users is done through notifications.

Depending on different system based triggers, emails are generated and sent to users during the Supplier Classification process.

## Usability Enhancements

---

The following usability enhancements are done in the Emptoris Supplier Lifecycle Management application for the 10.0.1 release:

- In the Supplier Qualification and Performance Evaluation modules, if the user clicks the **Submit** button to submit an incomplete questionnaire, links are displayed at the top of the questionnaire to re-direct to the incomplete section.
- The Strategic Importance notification templates are enhanced. New notification bundles are now available in the Strategic Importance module to communicate with internal and external users.



- In the Supplier Development module, you can now provide information about the goals and the result in separate fields. The fields are editable based on the assigned user roles.
- With 10.0.1, multiple users can work together on an assigned task in different modules of Emptoris Supplier Lifecycle Management.

## Korean Language Supported

---

With 10.0.1, the Emptoris Supplier Lifecycle Management application supports the Korean language.

## Enhanced Follow-up Business Actions

---

You can now initiate a business action by using the follow-up option in the Emptoris Supplier Lifecycle Management application for all possible business objects. Some of the business actions that can be initiated as follow-ups are:

- Supplier Qualification assessments series
- Action for Supplier Development

You need to configure the follow-up actions after installation. For information on configuring the follow-up actions, see the *IBM Emptoris Suite 10.0 Installation Guide*.

## Supplier Risk - Enhanced Alerting

---

With 10.0, users can now configure alerts that can be triggered upon a threshold breach or change over time. You can define risk indicators and rules while configuring alerts to be triggered. Alerts can additionally be sent out as a notification to responsible users.

In the Supplier Risk module, a new **Recent Alerts** menu is added to allow users to see recent alerts and also search for them if required.

## Strategic Importance - Change in Workflow

---

With 10.0, the Administrator or Responsible user role can now activate or deactivate the Strategic Importance evaluation. Notifications are no longer received for the Strategic Importance module.

## Enhanced Home Page

---

The Home page of the Emptoris Supplier Lifecycle Management application is enhanced so that the users can view their open tasks across all modules in the application. Moreover, they can also view the objects that were recently opened in the Emptoris Supplier Lifecycle Management application.

## RESTful Interfaces

---

The Emptoris Supplier Lifecycle Management provides RESTful interfaces. This allows other business applications to gather strategic business information from its various business modules to drive business processes in these applications. All HTTP enabled clients, for example portlets, mobile devices, browsers, or even ERP systems can obtain data from these interfaces. Business data from following modules is available in the current release:

- Master Data (suppliers, regions, organization, and categories)
- Supplier Qualification
- Performance Evaluation
- Supplier Classification
- Supplier Risk

For example, the approval status of a supplier based on the assessments in the Supplier Qualification module, the risk impact and risk likelihood scores derived from the Supplier Risk module, and so on.

In this release, it is only possible to fetch data from Emptoris Supplier Lifecycle Management via HTTP GET requests and the following resource representations (response formats) are supported in this release:

- XML
- JSON

## Integration with other IBM Emptoris Applications

---

Emptoris Supplier Lifecycle Management is now integrated with IBM Emptoris Spend Analysis and IBM Emptoris Contract Management.

You can view the spend data from Emptoris Spend Analysis and the header information of the contracts of suppliers from Emptoris Contract Management in the 360° view section of suppliers in the Emptoris Supplier Lifecycle Management application.
