Cross-Committal System Overview

Cross-committal provides a method of committing documents to a different Image Services system than the system on which the Batch Entry Services (BES) system resides. Unlike a multi-committal configuration, a cross-committal system can commit to only one Image Services system — its target. You can schedule cross-committals to run during off-peak hours. For more information on this feature, see Chapter 4, "Scheduling System Committals," on page 103.

Note You cannot use a cross-committal configuration to commit COLD documents to a target system. For COLD documents, you must use a multi-committal configuration.

Document Committal Sequence

In a cross-committal configuration, documents are processed by the BES system and committed on the target system. There is no committal on the local (source) system. A committal is initiated on the target system.

Note If the BES system fails to communicate with the target Image Services system (for example, when the network fails or the target system is down for maintenance), the BES periodically retries the committal process until it re-establishes communication.

The sequence of events on the target system is as follows:

- The document is migrated to tranlog. This migration must complete before continuing to the next step.
- The document is migrated to primary.

The following shows a cross-committal configuration where the source system is configured as a Remote Entry System (RES). The RES is used for scanning and indexing documents to be committed on the target Image Services system.



Cross-committal Configuration

Configuring a Cross-Committal System

The following is a high level overview of the tasks you must accomplish when creating a cross-committal system. Detailed steps follow in chapter 2, <u>"Configuring Cross-Committal Systems" on page 26</u>.

Add Peers to Source and Target Systems

Use **fn_edit** on both the source system and the target system to do the following:

- Add a peer system to both the source and target systems. The source system will peer to the target and the target system will peer to the source. The source system must recognize the target as a peer in order to commit to the peer.
- Ensure the systems are compatible: the document ID ranges on both systems must not overlap.
- Turn on Fast Batch Committal.
- Cataloging is not required on the source system.

Ensure matching Names and Passwords

Use the **Xapex (or Application Executive)**, **Security Administration** to ensure compatible security parameters as follows:

• Ensure that the source and target systems have matching names and passwords. Use the **Users** menu option **Add Users** on both source and target systems to create matching user accounts to give the user access to both source and target systems. For example: System A Security Objects user1:SystemA user1:SystemB System B Security Objects user1:SystemA user1:SystemB

• Set up identical group names on source and target systems. Although the users in the groups can differ, make sure the read/ write/append access group name is present on both systems.

Ensure Matching Indexes, Family Names and Classes

Use the **Xapex Database Maintenance** program to do the following:

- Set up any required indexes to match on both source and target systems.
- Define family names to match **exactly** on the source and target systems. Select the family media type for the target system.
- **Note** Although the family names must match, you can select different **media types** for the source and target system.
 - Ensure that document class names match on both source and target systems.
 - Ensure that the read/write/append access group name is present on both source and target systems; however, document class security and users in the group do not have to match.
 - Define access rights for committed documents on the source system.

• Define retention base for committed documents on the target system.

As an alternative, follow the steps above only on the source system, then use the **ddexim** tool to export the data dictionary from the source system, and import the file on the target system. (See the *Image Services System Administrator's Handbook* for more information on the ddexim command). Multi-Committal System Overview

A multi-committal configuration provides a way to commit copies of documents to more than one system. This may serve as an alternative backup to be used for disaster recovery or as a central repository.

Completing document committal on the source system triggers committal on the target system. Multi-committal systems use fast-batch committal to commit documents to target systems. The fast-batch objects remain in cache on the source system until they have completed committal on all of the target systems.

Note A multi-committal configuration is more efficient when documents are committed to the source system using fast-batch committal.

Multi-Committal Document Committal Sequence

In a multi-committal configuration, the document committal sequence is as follows:

- The document is migrated to the local system first. Local disk writes need to complete before the system can release a document to the target system. If local OSAR is not available, batches/documents will remain in local caches until the writes to the local optical is completed. After the local migration is complete, the document is migrated to each of the targets in turn.
- In the local system, if a tranlog is required, a migration is initiated and must complete on the tranlog first. Then the document is migrated to primary.
- In each of the target systems, if a tranlog is required, a migration is initiated and must complete on the tranlog first. Then the document is migrated to primary.
- **Note** If a particular target system is down and document committal fails, the system keeps retrying the committal process to the target system where the failure occurred.
- **CAUTION** Post-committal changes to a document index or annotations on one server does not automatically update the documents previously committed to another server. If you make post-committal changes on either the source or target systems and you require replication of document index or annotations, you must duplicate those changes on documents committed to the other servers in the multi-committal chain. For assistance, contact your service representative.

The following illustration shows a single-source Image Services multicommittal configuration. The source system is used for scanning and indexing documents which are then committed to the local storage library. After the committal completes on the source system, it automatically commits the documents to the target system.



Single-Source Multiple-System Committal Configuration

The following illustration shows a dual-source Image Services multicommittal configuration. A financial organization might use this type of configuration where they scan, index, and commit documents on Image Services servers at more than one branch, and require copies of those documents at their corporate office. After committing the documents on the branch system, the source (branch) system repeats the committal on the target Image Services system, based at corporate headquarters. This enables the organization to retain backup documents in a central location, which could be used for disaster recovery.

Configuring a Multi-Committal System

The following is a high level overview of the tasks you must accomplish when creating a multi-committal system. For detailed steps see **Chapter 3, "Configuring Multi-Committal Systems," on page 65**.

Add Peers to Source and Target Systems

Use **fn_edit** on both the source system and the target system to do the following:

- Add a peer system to both the source and target systems. The source system will peer to the target and the target system will peer to the source. The source system must recognize the target as a peer in order to commit to the peer.
- Depending on your system, you may want to set up the document ID ranges on both systems so that they do not overlap.
- **Note** Although having non-overlapping document IDs is recommended for organizational purposes, this is not *required* for multi-committal systems.

Ensure matching Names and Passwords

Use the **Xapex (or Application Executive) Security Administration** program to ensure that the **User** and **Security** settings for a user are identical on both the source and target systems:

• Ensure that the source and target systems have matching names and passwords. Use the **Users** menu option **Add Users** on both source and target systems to create matching user accounts to

give the user access to both source and target systems. For example:

System A Security Objects	System B Security Objects
user1:SystemA	user1:SystemA
user1:SystemB	user1:SystemB

• Set up identical group names on source and target systems. Although the users in the groups can differ, make sure the read/ write/append access group name is present on both systems.

Ensure Matching Indexes, Family Names and Classes

Use the **Xapex Database Maintenance** program to complete the steps in this section. Refer to the *Image Services System Administrator's Handbook* for more information. To download this handbook rom the IBM support page, see <u>"Accessing IBM FileNet documenta-</u> **tion" on page 11**.

- **Note** For organizational purposes, you may want to match doc classes and indexes on both the source and target systems. Family names and media types do not need to match.
 - Set up any required indexes to match on both source and target systems.
 - Define optical disk sizes, or family names, as configured on each system.
 - Ensure that document class names match on both source and target systems.

- Ensure that read/write/append access group name is present on both source and target systems; however, document class security and users in the group do not have to match.
- Define access rights for committed documents on the source system.
- Define retention base for committed documents on the target system.
- (Optional) As an alternative, follow the steps above only on the source system, then use the **ddexim** tool to export the data dictionary from the source system, and import the file on the target system. (For details on the ddexim command, refer to the *Image Services System Administrator's Handbook*.) To download this handbook from the IBM support page, see <u>"Accessing IBM FileNet documentation" on page 11</u>.

Source System Only

To verify proper family configuration, follow these steps on the source system only:

- After you create an account as described in <u>"Ensure matching</u> <u>Names and Passwords" on page 16</u>, log into Xapex.
- Open the Database Maintenance application and select Define/ Update Family from the Families menu.
- Select the Families option from the Remote menu and select the target domain from the Domains drop-down list.
- Select the family you created in <u>"Ensure Matching Indexes,</u> <u>Family Names and Classes" on page 17</u> from the Families dropdown list.

Note Configuring systems for multiple system committal requires linking the primary disk family on the source system with one or more primary families on target systems. Either target or source systems can point to multiple families, as long as they do not point back to each other, which would result in a loop, causing committals to attempt to repeat indefinitely.

Configuring Cross-Committal Systems

A cross-committal System is composed of a **source** Image Services system and a **target** Image Services system. The source system commits images to the target system, but does not retain the images locally.

A Remote Entry Server (RES) is a specific type of Cross-Committal system that has no storage library and is used only for entering images for committal to another independent system (the target) that does have a storage library. The target system is also capable of entering and committing images, so in this situation the two systems must be "compatible," that is, they must have non-overlapping document IDs and surface IDs.

Since an RES uses Batch Services to commit to the target system, you must use a product that commits using Batch Services so that the images are not retained locally after committal. For example, FileNet Capture uses Batch Services to commit while FileNet IDM Desktop uses Document Services to commit, so Capture should be used instead of IDM Desktop on an RES.

Cross-Committal Checklist

You will configure various aspects of your source and target systems depending on what you enter in this worksheet. The configuration steps will follow the checklist.

Note You may need to access your source and target systems in order to fill out the checklist.

System Domain Names

A cross-committal system will have two peer domains. One is the **source** system (no resident storage library) and one is the **target** system (storage library is present). Enter their names in the following table.

Document ID Numbers

The most important input in building a cross-committal system is maintaining system compatibility. This means that document ID numbers on the two systems can't overlap each other. Otherwise, errors will generate and documents won't commit.

Enter the document ID ranges in the following table. Note that the total range is 100,000 to 3,999,999,999. (The numbers entered below are sample values.)

Configure Cross-Committal Systems

As you complete the following subsections, be sure to distinguish between the **source** system for document entry and the **target** system for document committal.

Update the Host File on the Source System

The host file is typically located in the C:\Windows directory and contains information that allows the source server to locate a target server. The information in the host file includes the IP address, the server name, and the four-part NCH name. Locate and open the host file in a text editor. Add the host information for each target server in the crosscommittal system.

Cross-committal Peers

There are two types of Peers:

The **Compatible Peer** configuration contains remote system SSN and requires that the doc_id number ranges **not** overlap.

The **Non-Compatible Peer** configuration DOES NOT contain system SSN and allows the doc_id ranges to overlap.

Cross-committal configurations must be made up of compatible peers where the doc_id ranges do not overlap.

Add Peer to Source System

Each of the FileNet systems in a cross-committal or a multi-committal configuration is an independent system with a Root/Index server. For this reason, each system is considered a **peer system** by all the others.

Note Cross-committal configurations must be made up of compatible peers where the doc_id ranges do not overlap. See <u>"Cross-committal</u> <u>Peers" on page 31</u> for more information.

These procedures will differentiate between the peers by referring to **source** and **target** systems.

Server Types Perform the steps in this section on the root server of the **source** system.

- **Note** The system serial number (ssn) of each peer system is listed in the as_conf.g file on the Root server. You will use the ssn in the Configuration Editor to add additional peer systems.
 - 1 Go to an X-station, a workstation that supports X Windows or Common Desktop Environment (CDE), or a PC with an X Windows emulator and login to your **source** system as **fnsw** user. Start X Windows.
 - 2 As **fnsw** user, run **fn_edit** by entering:

fn_edit &

The Open Configuration Database dialog box displays.

- **3** Verify that the two-part domain information is correct and click **OK**. The System Configuration Editor window displays.
- 4 Click on the Procedures tab in the System Configuration Editor window.
- **5** Select the Add a Peer System from the Procedure List Box, then click Run.
- 6 Enter the domain name of the Peer server, for example, target.
- **Tip** If the organization name of the target Peer server is different from the organization name of the source Peer server, enter both the domain name and the organization name. For example, **target:YourCorp**.
 - 7 Enter the ssn of the target Peer server.
 - 8 Enter the network address of the target Peer server.

Set Document Number Ranges on the Source System

- **9** Select the System Application Services tab.
- **10** Select the Document Services tab.
- 11 Enter the appropriate amounts for the Document Number (high value) and Document Number (low value) for both the source server and the target server. Refer to the numbers you entered in the checklist. THE NUMBERS ON THE SOURCE AND TARGET CAN NOT OVERLAP.

Verify/Configure Batch Entry Services on the Source System

- 1 Select the Server Application Services tab. (Click the Server Application Services tab.)
- 2 Select the Batch tab.(Click the **Batch** tab.)
- **3** You will see a box entitled **Target IS Domain Name**. Click the down arrow icon in the box.
- 4 Select the domain name of the target system from the list box. (In the **Target IS Domain List**, click the target system you want.) Your selection determines the system where the batches will be committed.

You should select only compatible systems as peer systems. Compatible systems must have no overlapping document IDs or disk IDs.

- 5 Under the Batch tab, click on Fast Batch Committal. (On the Batch tab, select the Fast Batch Committal option.) Make sure it is set to Yes (✓).
- 6 Click the System Applications Services tab. Click the Others subtab.(On the **System Applications Services** tab, click the **Others**

tab.) Make sure Cataloging Enabled is set to **No** (an 'X' mark). (Select the **Cataloging Enabled** option. Make sure it is set to **X**.)

- 7 Click on the Performance Tuning tab in the System Configuration Editor window. (Click the **Performance Tuning** tab.)
- 8 Click on Server Processes. (Click the Server Processes tab.)
- 9 Click on the arrow button to increase or decrease the number of bes_ commit processes. (In the **BES Commit Process Count** column, type or select the number of commit processes you want.)
- **10** From the System Configuration Editor window, Click on the File pull down menu and click on the Exit option.(On the **File** menu, click **Exit**.)
- 11 You will then be asked if you want to save the changes you have just made to the current configuration database before you exit. Click on the **Yes** button to save the configuration and exit the System Configuration Editor.
- **12** Put the changes into effect by restarting Image Services. Enter the following at the command line:

initfnsw -y restart

13 Logout of the source system.

Add Peer to Target System

The procedures for target system mirror the procedures you followed for the source system with one exception: the target system will be committing to itself.

Server Types Perform the steps in this section on the root server of the **target** system.

Note The system serial number (ssn) of each peer system is listed in the as_conf.g file on the Root server. You will use the ssn in the Configuration Editor to add additional peer systems.

- 1 Go to an X-station, a workstation that supports X Windows or Common Desktop Environment (CDE), or a PC with an X Windows emulator and login to your **target** server as **fnsw** user. Start X Windows.
- 2 As **fnsw** user, run **fn_edit** by entering:

fn_edit &

The Open Configuration Database dialog box displays.

- **3** Verify that the two-part domain information is correct for your target server and click **OK**. The System Configuration Editor window displays.
- 4 Click on the Procedures tab in the System Configuration Editor window.
- 5 Select the Add a Peer System from the Procedure List Box, then click **Run**.
- 6 Enter the domain name of the Peer (source) server, for example, **source**.
- **Tip** If the organization name of the source Peer server is different from the organization name of the target Peer server, enter both the domain name and the organization name. For example, **source:YourCorp**.

- 7 Enter the ssn of the source Peer server.
- 8 Enter the network address of the Peer server.

Set Document Number Ranges on the Target System

- **9** Select the System Application Services tab.
- **10** Select the Document Services tab. You should see the source and target server names displayed.
- **11** Enter the appropriate amounts for the Document Number (high value) and Document Number (low value) for both the source server and the target server.
- **CAUTION** These numbers should NOT match what you entered earlier on the source server. These numbers can not overlap.

Verify/Configure Batch Entry Services on the Target System

- 1 Select the Server Application Services tab.
- **2** Select the Batch tab.
- **3** You will see a box entitled **Target IS Domain Name**. Check to see if the target system name is visible, if not, click the down arrow icon in the box.
- 4 Select the domain name of the **target** system from the list box. It is likely the default selection. Your selection determines the system where the batches will be committed.
Note At this step, the target server is configured to commit to itself.

Configuring Multi-Committal Systems

A multi-committal system is an independent FileNet Image Services system that contains a Storage Library server and commits images both to its own Storage Library and to the Storage Library of another independent FileNet system. Multi-committal systems may or may not be "compatible" systems with non-overlapping document IDs. If they are not compatible, new doc IDs are assigned on the target system. This could prove to be a minor performance consideration.

Multi-Committal Checklist

Each of the FileNet systems in a cross-committal configuration or a multi-committal configuration is an independent system with a Root/ Index server. For this reason, each system is considered a **peer system** by all the others. These procedures will differentiate between the peers by referring to **source** and **target** systems.

System Domain Names

A multi-committal system will have two peer domains. One is the **source** system (no resident storage library) and one is the **target** system (storage library is present). Enter their names in the following table.

As you complete the following subsections, be careful to distinguish between the **source** system for document entry and the **target** system for document committal.

Update the Host File on the Source System

The host file is typically located in the C:\Windows directory and contains information that allows the source server to locate a target server. The information in the host file includes the IP address, the server name, and the four-part NCH name. Locate and open the host file in a text editor. Add the host information for each target server in the multicommittal system.

Multi-committal Peers

There are two types of Peers:

The **Compatible Peer** configuration contains remote system SSN and requires that the doc_id number ranges **not** overlap.

The **Non-Compatible Peer** configuration DOES NOT contain system SSN and allows the doc_id ranges to overlap.

Multi-committal configurations support BOTH compatible and noncompatible configurations. This is helpful if you do not want to limit the number of doc_ids by dividing up the ranges on each system. You can create peers WITHOUT the SSN for incompatible systems, and the doc_id range can overlap by a little or a lot.

If the peers are created with the SSN, and error 30,0,42 is generated (at the target system):

- 1 Use fn_edit to delete the SSN from the **Peer Configurations** of both the source and target systems.
- 2 Restart Image Services. The documents will finish migrating to the target media.

Add Peer to Source System

Each of the FileNet systems in a multi-committal System configuration is technically an independent system with a Root/Index server. For this reason, each system is considered a **peer system** by all the others. These procedures will differentiate between the peers by referring to **source** and **target** systems.

- **Note** The system serial number (ssn) of each peer system is listed in the as_conf.g file on the Root server. You will use the ssn in the Configuration Editor to add additional peer systems.
 - 1 Go to an X-station, a workstation that supports X Windows or Common Desktop Environment (CDE), or a PC with an X Windows emulator and login to your **source** system as **fnsw** user.
 - 2 As fnsw user, run fn_edit by entering:

fn_edit &

When the FileNet software has started successfully, the system is ready to run. Test the system by entering, committing, and retrieving several documents to make sure they've been committed on the appropriate systems.

Return to Production Mode

The upgrade is finished and you can restart the IS software and return your FileNet system to normal operation.

Scheduling System Committals

This chapter describes how you can schedule cross-committals (bes_ commit) and multi-committals (rmt_commit). This feature allows you to select specific times and days for processing committals of batches or documents. You may want to schedule this activity during non-peak hours. For example, if the network traffic is heavy between the hours of 8:00am and 5:50pm weekdays, you can schedule the committal operation outside these peak hours of operation.

Note When you use this scheduling feature, committals for documents scanned during peak hours may be delayed. In addition, you may need to increase the transient database and cache space to accommodate the backlog of transient data.

Image Services reads the scheduling file from the following location:



/fnsw/local/sd/sched_conf (UNIX platforms)



<FNSW_drive>:\fnsw_loc\sd\sched_conf (Windows platforms)

This is an ASCII text format file that you generate. If this file does not exist, no scheduling will take place to disable the daemon processes.

If column one has the following characters, that line will be skipped:

- # Comment line
- 0 NULL
- \n New line

All key tokens will start at column one of each new line. The key token will be the name of the committal daemon to be scheduled. There are two supported daemon tokens (not case sensitive and always starting at column one):

Bes_commit

Rmt_commit

Following the daemon token indicator is the mandatory start and end time. The start and end time will have following format:

Hh:mm - The two digit hour in military time.

When the start time you specify is later in the day than the end time, processing will occur from 00:00 to the end time and from start time to 24:00. See the example below.

Following the end time indicator is the optional three character day of the week indicator (SUN, MON, TUE, WED, THU, FRI, SAT). If no day indicator is present, then the schedule will be followed every day of the week. The day indicator entries will supersede the non-day entries.

For example, you can use the following entries if you want to follow one schedule Monday through Saturday and a different schedule for Sunday. Sunday's schedule supersedes the base schedule. In the following example bes_commit will not run between 8:00am to 5:30pm Monday through Saturday and will run continuously on Sunday:

Bes_commit 17:30 08:00
