

Trinity College:

Tracking All-Important Private Support

At Trinity College, an independent, nonsectarian liberal arts school in Hartford, Connecticut, business intelligence from Cognos is a key factor in employing data to maximize fundraising efforts. Fundraising is crucial to the success of higher education. Across the U.S., private contributions to colleges and universities (from individuals, corporations, and foundations) totaled \$24.2 billion in fiscal year 2001.

Trinity College, with 1,900 students, raised \$31 million in gifts and pledges in FY2001 (with an operating budget of \$86.5 million). This means there is a copious amount of critical fundraising information to track and monitor: gifts, pledges, donor count, gift count -16measures in all. In this fast-changing environment, it helps that Cognos makes it possible to refresh data on new gifts and pledges on a daily basis, which means fundraising information is always current.

Gwen Stengel, Technology Solutions Specialist at Trinity, notes, "The Advancement, or Fundraising, Office can tell how much money we've raised this year; how many donors; how many unique donors this year over the past ten years; actual gift dollars and pledged dollars; and they can slice it and dice it in many different ways." It's critical that Trinity can keep track when transactions are adjusted or posted, so nothing gets lost in limbo.

The Alumni Office is also using Cognos to understand the population of the alumni – where they live, gender, status, ethnicity, and so on. The Cognos solution offers a multitude of ways to do quick and easy counts.

Stengel adds, "We were able to create one dreaded report, that usually took hours, in seconds. The team was able to customize their constituent groupings to their liking, and when the Alumni folks were shown they could save this view to their personal news box or to a shared Alumni Office folder, they were delighted."

The value of Cognos to fundraising in colleges and universities is clear. In the future, Stengel says they plan to apply Cognos solutions to admissions, curriculum and registrar data, and finance (part of Trinity finance already uses Cognos).

"But we don't call it Business Intelligence," Stengel points out, "we call it Institutional Intelligence."



HEALTH AND HUMAN SERVICES

Delivering services to citizens is clearly the mission of most public institutions. In the case of Human Services departments and agencies, such services are regularly delivered to people living on the margins of society, and are essential to their well being. As caretakers of the public trust, you need to ensure that services are delivered effectively and efficiently. Temporary Assistance to Needy Families (TANF)

Compliance to TANF programs requires wide-ranging accountability and involves new reporting requirements for government departments. Jurisdictions need flexible, secure BI tools to format data from a variety of sources to fit the structures of mandated reporting requirements.

The Health Insurance Portability and Accountability Act (HIPAA)

In the U.S., HIPAA mandates stringent safeguards to protect the privacy of patient data, and robust access controls to sensitive information. This can be quite difficult and complex when institutions typically rely on data from a number of interconnected sources.

Using a role-based access management strategy, Cognos BI restricts views of data to only those authorized to view it. And when patient information is accessed, an audit trail assures access is documented. State and local government budgets are under severe stress. You have to know how much budget is left, where the money has gone, whether you are over- or under-budget, and you have to know NOW.

MassHousing:

Keeping Your Financial House in Order

MassHousing is a self-supporting, quasi-public authority of state government in Massachusetts that lends money to support rental and home ownership opportunities for low- and moderate-income residents. Since 1970, the Agency has provided more than \$7 billion to finance apartments and home mortgages throughout the state.

MassHousing uses Cognos solutions to track and monitor core business information and performance: loan portfolios, pipeline management, underwriting, and risk management. They are also providing financial management reporting and analytical tools to the Agency's managers and financial analysts.

Frank Creedon, Director of Corporate Planning and Administration, gives an example of how Cognos is being used: "We regularly measure our volume of loan originations against our annual targets; we compare where we are today with where we were at the same time in prior fiscal years. We assess our pipeline of loans that have not as yet closed; we can see if there are any aberrations that we need to investigate or whether we have the appropriate geographic penetration or whether we are reaching those populations that we are here to serve." Their team has been able to structure huge quantities of data in meaningful ways by a large number of factors and criteria. This has facilitated the management of the business to performance targets and the easy identification of exceptions and variances.

Creedon adds, "The solution is very good in terms of looking at trends, to see, for example, whether increases in utility expenses or administrative costs were making some of the rental housing developments that we financed less profitable. It enabled our people to do their own analysis. We also provide the ability to segment the portfolio in different ways, recognizing that not all developments operate the same way: an assisted living development for the elderly will not operate in the same way as a subsidized, low-income, family-oriented development in an urban area.

"Now, we are in a much better position to be able to measure performance than we were previously. If we look at delinquencies or non-performing loans, we can readily identify where they are and who owns them, and how many units are involved. As the issuer of tax-exempt and taxable mortgage revenue bonds, we are accountable for the performance of the loans in our portfolio. We need to be able to readily identify our problems and then track whether corrective actions are having the desired result. Our oversight, which is enhanced by our EIS, has been recognized by the bond rating agencies (Standard & Poor's, Moodys, and Fitch and others) as a 'best practice'."

Creedon explains that they update financial information, such as general ledger, accounts payable, and payroll once a week, while other areas of their system are updated daily. This ensures that they always have the most current data available and remain on target.

"MassHousing's Executive Information System (EIS), built with Cognos BI, represents a state-of-the-art solution to the management of information that is truly aligned with our mission and business strategy. Our staff have become 'knowledge workers' who can now 'see the forest from the trees'. Also, the Agency and its constituents benefit from the provision of reliable, consistent information."
