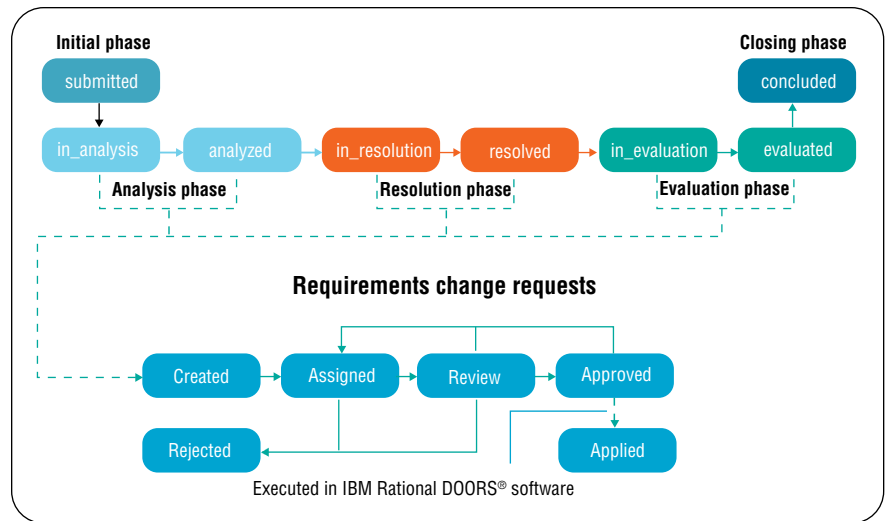


Figure 1: The Rational Enterprise Change Process lifecycle is extended with Rational DOORS.

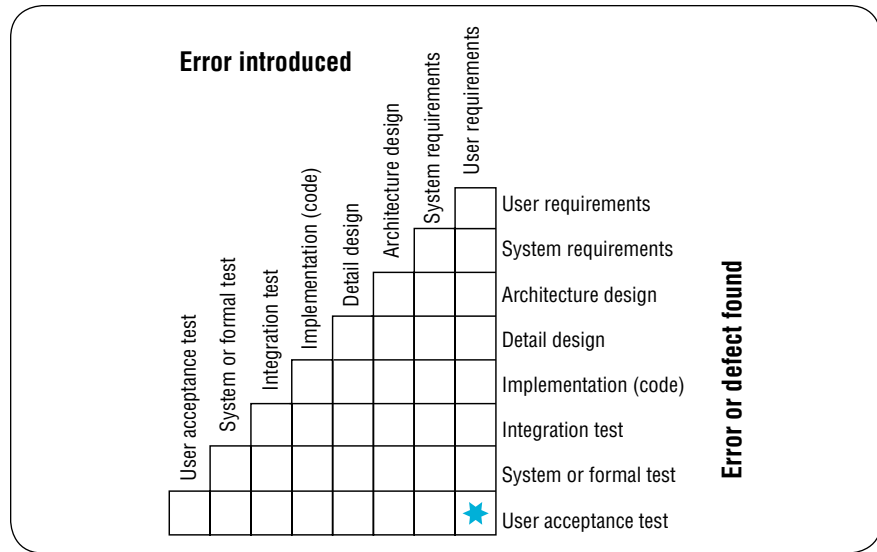


Figure 2: Rational Enterprise Change Process collects advanced metrics to support more informed decision making.
