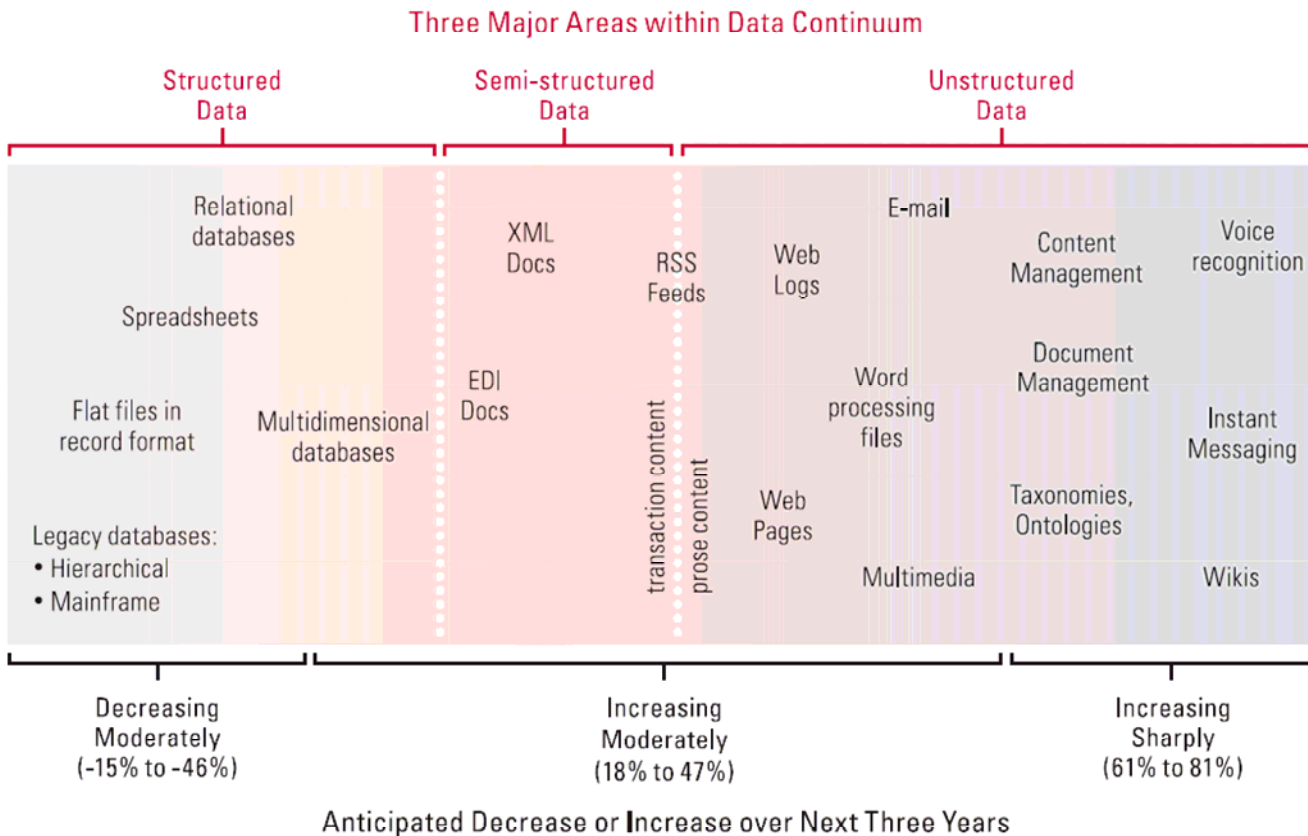

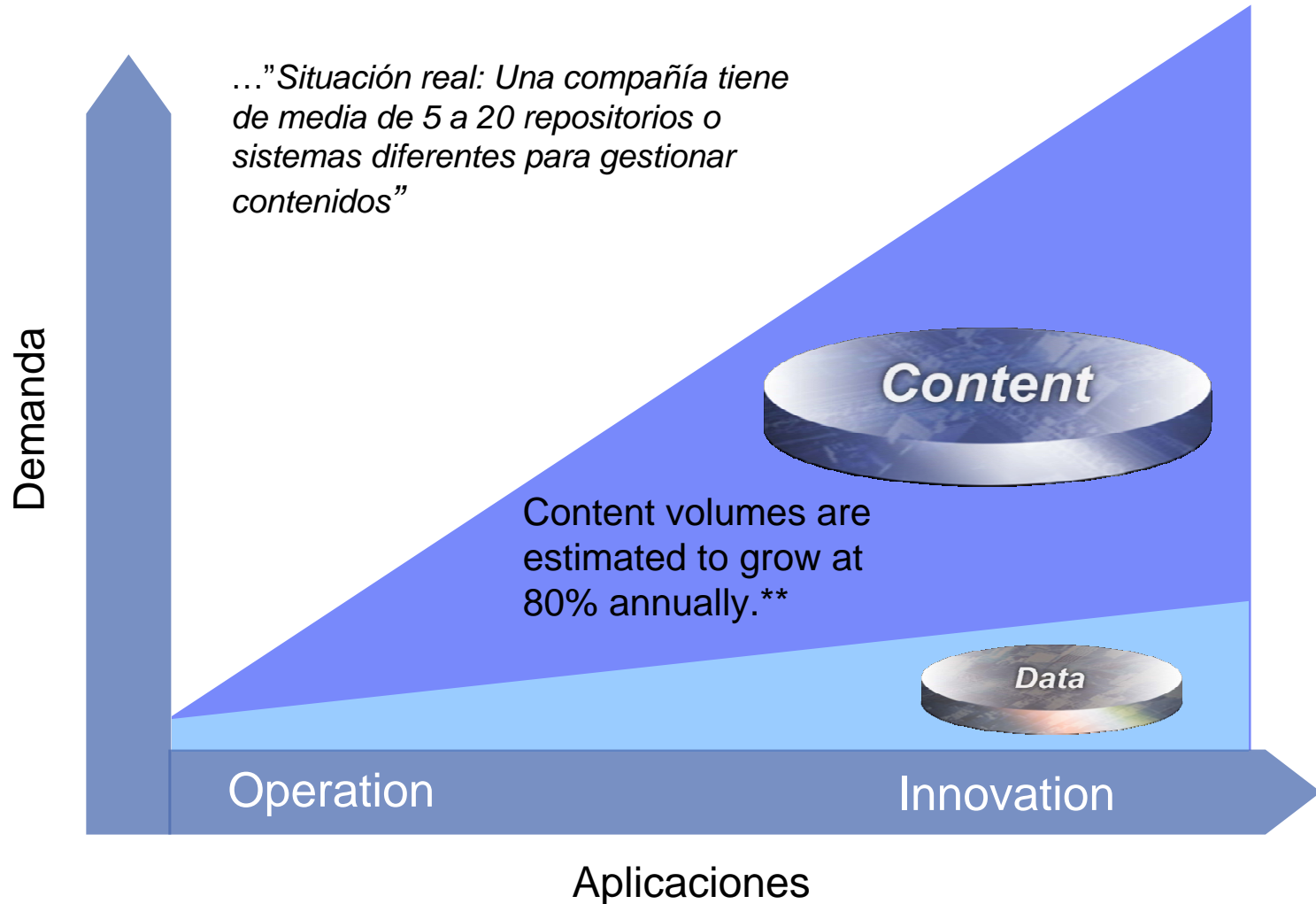
Data and source types plotted on the data continuum
