

AT&T PON 01H01 – Commercial UCC

Bill Format

The positioning of the charges must be either on the Summary of Charges Bill page under Regulatory Fees or the OC&C should be used. The UCC must not be on the tax summary page. In either Summary of Charges or Other Charges and Credit display a follows:

Summary of Tax Application

- The charge consists of the Universal Connectivity Charge (UCC).
- The UCC is charged the applicable % based on Net Revenue each month.
- The charge elements are; Sales and Use tax, Gross Receipts Surcharges, and Federal Access Tax
- Universal Connectivity Charge is taxed as MTS, business, interstate, international, or intrastate, recurring, other. The tax status on the customer service address.

Chargeable and Excluded Services

Chargeable services include all AT&T usage as well as any AT&T charges on the bill excluding taxes.

Customers that have calls that originate in the United States but “Bill To” address outside of the United States are not excluded from UCC.

Any bills for customers whose billing address is outside of the United States, such as a foreign to foreign call on World Connect, are excluded from the UCC. Additionally, Multiquest 900 calls, Wireless Cellular, and local are excluded from the UCC.

User must add parameters to include the new tax for the Universal Connectivity Charge (UCC). A new tax code must have a tax relationship created to reflect the tax liabilities to be calculated on top of the UCC. All AT&T billing elements should be modified to include the new surcharge. Multiquest 900 calls and local calls are excluded from this ruling.
