Problems fixed

The following is the complete list of problems found since the GA of TLM, version 1.1.1 and fixed with this Fix Pack:

For both the administration and the runtime servers:

APAR IY44786

When you created an account for a server, the GUI did not limit the length of the password you were asked to supply. However, if the password was longer than 8 characters, when you tried to log on the password was not accepted, and an error was given as if the password had been typed incorrectly.

After you have installed the fix, the GUI now prevents you from creating an account with a password longer than 20 characters. Any characters can be used in the password.

APAR IY48133

If the bootstrap port used by the WebSphere® Application Server was not at the default setting the Tivoli License Manager servers were not able to start.

For Tivoli License Manager servers you have already installed, and with which you are still experiencing the problem, you will need to manually configure WebSphere Application Server for the first time, install the fix pack, and then start the servers.

To manually configure the WebSphere Application Server, refer to Chapter 9, paragraph "WebSphere Application Server configuration" of the *IBM Tivoli License Manager: System Administrator's Guide*, for details of how to do this.

If you have already manually configured the WebSphere Application Server, then after installing the fix pack, after any future installations of Tivoli License Manager servers, all the servers will be able to start, even if the bootstrap port is not at the default setting.

APAR IY49281

If an agent has an operating system name longer than 40 characters, the agent plugin failed. The runtime server log file showed the following error:

errors.com.ibm.it.rome.slm.runtime.data.AgentHandler ERROR COM.ibm.db2.jdbc.DB2Exception: IBM CLI Driver DB2/6000 SQL0433N Value "Windows NT 5.0 - Service Pack 4, RC 4.66" is too long. SQLSTATE=22001

This was because in the runtime server database, the AGENT table field for the operating system was too small.

After applying the fix the database table field (AGENT.OS_VERSION) is increased to 60 characters, and the problem does not occur.

APAR IY51221

Refer to the "Problems fixed" on page 21 for Fix Pack 1.1–TLM_WEP–FP01 for details.

APAR IY54884

Startup of the Tivoli License Manager administration or runtime servers needed adjusting to create errors if startup encountered problems. During the startup of the Tivoli License Manager administration or runtime server, if the initialization of the database failed or a failure occured before tracing was initialized, there was insufficent information to perform problem determination. If Tivoli License Manager tracing failed to initialize, there were no log files.

After installing the fix, an error should be logged in the WebSphere Application Server logs that clearly directs the user to the cause of the problem and the servers should not start.

For the administration server:

APARS fixed:

APAR IY47457

In the Manage License Settings panel, trying to set the Expiration date greater than 2022 and lower than 2050 returned an internal error 9891 and the date was not saved in the database. If the expiration date was set or changed to a date greater than 2050, this date was saved incorrectly.

After installing the fix these dates will be saved correctly in the future. However, if you have already set dates on these panels that have been saved incorrectly, after the fix has been installed you should go into those panels and correct the dates.

APAR IY49698

If the administration server is installed on an AIX® platform, and its DB2® database is on another computer, (which means that the AIX computer has only the DB2 client software installed on it), the administration server could start. The error shown in the stdout.txt file in the directory <*INSTALL DIR*>\<*SERVER TYPE*>\was is the following:

Failed to load servlet:

java.lang.NoClassDefFoundError:sqlj/runtime/ref/ConnectionContextImpl
 the class ConnectionContextImpl is part of the runtime.zip archive.
The classpath for runtime.zip is not correct.

After installing the fix, the problem is resolved and the server starts.

Defects fixed:

Java out-of-memory exception

It was possible to cause a Java out-of-memory exception in the Java virtual machine of the administration server if a backup of the database was restored and the restored database was older than 30 days. The administration server consumes all the memory allocated to the Java virtual machine, finally causing a Java out-of-memory exception.

After installing the fix, it is now possible to restore a database older than 30 days.

For the runtime server:

APARs fixed:

APAR IY46975

The values of the updateAgentEnabled parameter in the system.properties file were limited to **no** and **yes**, but the documentation of those values in the *IBM Tivoli License Manager: System Administrator's Guide* reports them as **No** and **Yes**. Supplying the incorrect values could mean that some product functions did not work correctly, as the parameter value was not recognized by the product. For example, a scheduled scan might not be performed on the agents belonging to that division. The following error messages were reported in the traceagt.log if you used **Yes** instead of **yes**:

```
ERROR - Bad update enable string 'Yes' ERROR - No parameters downloaded
```

After installing the fix the parameter values can be written in any of the following ways: "YES", "Yes", "yes", "NO", "No", "no".

APAR IY55165

The agent sends a list of unknown applications that were detected when they started. When this list of unknown applications included a corrupted entry, the runtime server gave an error and incorrectly rolled back all the entries already added into the UNKNOWN table.

After applying the fix, the runtime server will ignore the corrupted entry and complete the processing of all the other entries.

APAR IY53694

After an upgrade of the agent code on the runtime, even if the value of the parameter updateAgentEnabled was changed from **yes** to **no** in the runtime's system.properties file, it was possible that the agents would still download any update available on the runtime server. This happened if the new agent parameter was downloaded to the agent after the **updateAgent** service was performed.

After the Fix Pack installation the runtime will double check the value of this parameter in its system.properties file before allowing any agent to be upgraded.

Defects fixed:

Runtime server or HTTP server unexpected stop

Every thread that runs in the runtime server locks the resource it is processing. If another request arrives, the server thread waits for the resource to become available. If many requests arrive in a short space of time, or if a thread needed to keep the resource locked for a long time, either the runtime server or the HTTP server, or both, may stop, or go into an endless loop.

After you have installed the fix, the runtime server will allow a thread to wait for a maximum of 60 seconds for a requested resource to be made available. If the request cannot be satisifed within this period, an event of type "internal error" is sent to the agent. The agent has processes for handling such an event, and the load on the runtime server and HTTP server is lightened.

Unhandled Java[™] exception

If an HTTP request arrives without a body, the Java exception was not correctly managed by the runtime server. This error was particularly evident when the server received many requests from agents in a short space of time. In this case, the error log contains the following error:

After installing the patch these Java exceptions are handled correctly.

Scheduling of the runtime server services

It was not possible to customize a start time for certain services which the runtime server runs to perform some internal activities, and certain services which make requests to the administration server. By default, these services are started at midnight, GMT, regardless of the timezone of the runtime server. The affected services all have customizable frequencies, but without a customizable start time you cannot ensure that the running of these services avoids times of the day when the runtime server is busy communicating with its agents.

After installing this fix you will be able to choose the time of day when all these services start. The installation of the fix will add a new parameter: runtimeBaseTime to the system.properties file on the runtime server. The default value of this parameter is 23:00 (11 pm), according to the clock of the runtime server. After you have installed the fix, the service requests will be made according to this parameter, and each will be satisfied in turn. The existing individual frequency parameters will then determine when the service is next run. Thus, for example, if the frequency interval of a service is 1440 minutes (24 hours), and you leave the runtimeBaseTime at its default value, the service will start at 23:00 (11 pm) every day. The server uses the runtimeBaseTime parameter only immediately after it has started; from that point on it will determine the next service start by adding the appropriate frequency to the time of the previous service start.

Note: There is no particular advantage in staggering the frequency interval of the services, as if they all have the same frequency they will be started in a pre–determined sequence, and each service request will be satisfied in turn. However, you should schedule them to take place at a time when the workload of the runtime server is low.

In conjunction with this, after installing the fix, the following parameters in the system.properties file on the runtime server have new default values, different from those documented in the *IBM Tivoli License Manager: System Administrator's Guide*:

# Time interval for internal inventory update (minutes)
inventoryUpdatePeriod=1440
# Time interval for internal cache update (minutes)
cacheUpdatePeriod=1440
# Time interval for data transfer (download) with admin server (minutes)
adminDownloadPeriod=1440
# Time interval for data transfer (upload) with admin server (minutes)
adminUploadPeriod=1440
# Time interval for license cleanup checking (minutes)
licenseCleanupPeriod=1440
# Time interval for usage data resynch with admin server (minutes)
usageSnapshotPeriod=1440
```

Note: During the fix installation, if you have modified any of these values from the original defaults, the changed values will not be changed to the new ones.

For the agent:

APARs fixed:

APAR IY45495

A memory leak has been solved on agents running on Windows platforms, which, over a period of time, was causing excessive resource consumption.

After installing the fix, the problem is resolved.

APAR IY46294

On the agent there were a large number of sockets opened by the tlmagent executable, and hanging in listening state.

After installing the fix, the problem is resolved.

APAR IY49454

On certain Windows platforms detailed below, the agent contacted the domain server to determine information about the user of a Windows application too frequently. This was causing performance problems.

The Windows agent platforms to which this problem applies are as follows:

Windows 2000 Professional

Windows 2000 Server

Windows 2000 Advanced Server

Windows NT 4.0 Server (service packs 6 and 6a)

Windows NT 4.0 Workstation (service packs 6 and 6a)

Windows XP (32-bit only)

After installing the fix, the agent will store the user information in its cache memory after the initial contact with the domain server.

APAR IY50092

On SUN platforms some scripts were prevented from running by the agent's kernel extension. For example, if you run the following command: export DISPLAY= $^who -m \mid awk -F"(" \{'print $2'\} \mid awk -F")" \{'print $1'\}^:0$

the following error is received:

awk can not be executed

After installing the fix, the kernel extension no longer prevents such scripts from running.

APAR IY50094

On AIX platforms, the agent caused the operating system to loop if more than 15 different processes failed in less than 8 seconds. An operator cannot telnet or log in to the console.

After installing the fix, the agent correctly manages large numbers of failing processes in a short time.

APAR IY50187

On Windows, AIX and SUN platforms, under heavy system stress and in exceptional circumstances, a system kernel panic could occur during the unload of the Tivoli License Manager agent kernel extension. An unload occurred when the agent code was uninstalled, upgraded, or reinstalled, by any method (Web registration, the installagent command, or the agent self-update option on the runtime server).

The agent platforms to which this problem applies are as follows:

All AIX platforms

All SUN platforms

Windows 2000 Professional

Windows 2000 Server

Windows 2000 Advanced Server

Windows NT 4.0 Server (service packs 6 and 6a)

Windows NT 4.0 Workstation (service packs 6 and 6a)

Windows XP (32-bit only)

Other platforms are not affected by the problem that this fix resolves, and the fix should not be applied to agents running on them.

The fix requires the upgrading of the agent code on the runtime servers that serve agents running the above-listed operating systems. It then requires you to upgrade the agent code at each agent by first applying a utility provided with the fix, and then updating or re-installing the agent code. Full details are provided in "Fix pack Installation" on page 13.

After installing the fix, the agent software can be unloaded without causing a kernel panic.

APAR IY50491

On Windows 9x platforms, after the agent is installed, some in-house programs, for example those developed using Power Builder version 4 or Sybase version 11.0.3, could not run.

After installing the fix these programs can run.

APAR IY53138

The following problem on SUN Solaris platforms only has been fixed:

A kernel driver conflict was found between IBM Tivoli Access Manager for Operating Systems and Tivoli License Manager If both kernel extensions are loaded into memory at the same time, the Tivoli License Manager kernel extension may be rendered incapable of being enabled or disabled. Interim fixes must be applied to both Tivoli License Manager and Tivoli Access Manager for Operating Systems if both applications are installed. The problem is solved only after both have been fixed and the corresponding agent software has been updated.

Attention: The fix for Tivoli Access Manager for Operating Systems must be installed on the computers before the fix for Tivoli License Manager. For your information, the interim fix for Tivoli Access Manager for Operating Systems is:

- Tivoli Access Manager for Operating Systems, version 3.8
 3.8-PDO-FP06
- Tivoli Access Manager for Operating Systems, version 4.1 4.1–PDO–FP06
- Tivoli Access Manager for Operating Systems, version 5.1
 5.1-PDO-FP01

APAR IY54139

An agent cannot plug—in to the runtime server because the **gethostbyname** system call used to retrieve the hostname of the machine returns an empty string as the name. One of the required values to plug—in is empty and the plug—in service fails.

Solution: The agent, if it is not able to retrieve the hostname from a machine, can also use an alias or the IP address as the parameter to send, instead of the hostname.

APAR IY55407

In very specific timing conditions, a defect in the licensing process caused the TLM agent to hang, taking 99% CPU.

After installing the fix, the problem is resolved.

APAR IY57127

The Tivoli License Manager agent on Windows platforms prevented the starting of embedded applications on Windows. These applications started with a delay of about one minute. An embedded application is an application that has been added through the OLE interface.

After installing the fix the agent allows these applications to start.

APAR IY57440

Under very heavy process load, on AIX platforms only, a defect in the TLM agent licensing process caused the agent to hang, using 99% CPU.

After installing the fix, the problem is resolved.

Defects fixed:

Inventory scan transmission algorithm

On all platforms, if a large number of agents belong to the same division, the inventory scans cannot be handled by the runtime server because they are occurring in too short a time frame.

After receiving a request for a scan from the runtime server, the agent determines when to send the scan by using an algorithm that generates a random time for the transmission, based in part, on the number of agents, information supplied to it by the runtime server. This algorithm has, a maximum timeframe of 9 hours. Thus, with many agents in the division, the runtime server is experiencing a severe backlog of requests from agents, which affects its capability to respond immediately to license requests.

After installing the fix, the algorithm no longer has this limitation, and correctly schedules the scan transmission so that the runtime server can handle all requests.

Agent self-update on Windows NT®

On Windows NT platforms, the self–update of the agent did not work after installing the TLM–1.1.1–0002 interim fix (agent version 1.1.1.10). Agents attempting to self–upgrade terminated abnormally.

After installing this fix, the agent should self-update without problems.

Agent self-update on Windows 98 and ME

Agents on Windows 98 and ME platforms can now use the self-update facility, which did not work prior to the fix.

Deploying agents on unsupported platforms

It is possible to attempt the Web deployment of an agent on the unsupported Windows 2003 platform. The deployment appears to have worked, but as there is no kernel extension available to these agents, no license enforcement is possible..

After installing the fix, a Web deployment request for the Windows 2003 platform will be refused by the runtime server.

Specific scenario on AIX where an IBM Tivoli License Manager agent was running

During ITLM internal testing at IBM, a problem was identified on AIX in a very specific scenario where an IBM Tivoli License Manager agent was running. The AIX APAR IY52121 documents this problem. All the information about the problem is reported at the following link:

A check has been added in the agent code to not install the kernel extension if the APAR IY52121 is not installed on AIX 5.1 platforms.

Agent writes too much data to trace file, causing the agent to fail

An agent can fail if the agent writes lots of data in the trace at a very high speed. The file trace has a defined size; when the traceagt.log is full it is copied to the traceagt.log.bck file. This event is not synchronized with all agent threads and in a very particular situation the agent can fail. The trace now is synchronized with all the threads of the agent.

Problem fixed:

Agent "out-of-sync" monitoring

The runtime server stores the kernel extensions of the latest agent version that needs to be downloaded by the agents at installation time. The kernel extension can also be downloaded by the agents if their local kernel extension gets corrupted. After you have upgraded the agent code on the runtime server by installing a maintenance fix, it is possible for an agent to become "out–of–sync" with the available kernel extension on the runtime server, and to be forced to run without a kernel extension. The agent is "out of sync" because the version of the agent code on the agent no longer matches the version of the agent and the relative kernel extension available on the runtime server.

This problem impacts the agent's ability to perform an accurate usage monitoring, and any kind of license enforcement. A full description of how this problem can occur, and the measures you can take to avoid it and to correct affected agents, is provided in *IBM Tivoli License Manager: Release Notes (revised December 2003)*, which is available from the Tivoli Software Information Center Web site. The Tivoli Software Information Center is located by using the following Web address:

An important aspect of recovering from this problem is discovering which agents are affected. After you have installed this fix, every time a runtime server is unable to supply an agent with a kernel extension file, a notification flag is set in the agent table of the runtime database. This information is propagated to the administration server, together with the rest of the agent information.

To list the agents running without a kernel extension, you will need to issue the following SQL command from the DB2 command line on the administration server:

select hostname,ip_address,os_version,storage as kernel_status
 from adm.agent where storage <> 0

This query displays the following fields:

hostname

The hostname of the agent

ip address

The IP address of the agent

os_version

The operating system name at the agent, and its version

kernel status

The possible values are -1, 0, 1, 2, 3, 4, 5, 6.

kernel status=0

Agents with this value as kernel status are filtered out by the query as this indicates that the kernel extension has been download correctly and that the agent is not reporting any problem with it.

kernel status=-1

There are two possible causes for this error condition:

- The agent has tried to download the kernel extension from the runtime server but the agent version is prior to the one available on the runtime server. This can happen because:
 - You manually installed the agent using the
 installagent command with a version of the agent
 code prior to the one available on the runtime server.
 In this case you will need to upgrade the agent
 installation package in any copy, zip, tar or
 distribution package that you are using to install the
 agent code.
 - An installed agent had problems with the kernel extension and tried to download a new copy from the runtime server but the agent version is prior to the agent version available on the runtime server. In this case you will need to ensure that you take all the appropriate steps to upgrade the agent, as described in the original product documentation and IBM Tivoli License Manager: Release Notes (revised December 2003).
- The tlmagent –p command has been run on the identified agent and this causes the agent flag to be reset to -1.

If you know or believe this to be the case, to get the true status of the agent kernel extension you should stop and start the agent, and wait the appropriate interval for the data to be propagated to the administration server (the maximum time to wait is determined by the adminUploadPeriod parameter in the system.properties file on the runtime server). Then rerun the query.

kernel_status=2

This indicates that the agent is running on an unsupported platform. You should uninstall the agent, as its behavior on an unsupported platform cannot be guaranteed, and the functions that require the kernel extension will not work.

kernel_status=1, 3, 4, 5, 6

These values report internal errors that should be reported to IBM Software Support.

For the Catalog manager Tool:

APAR IY52226

In the panel of the catalog manager tool **IBM Tivoli License Manager**, **1.1.1** – **Unknown file Manager**, click on **Search**. A warning message should be displayed if the number of unknown extracted from the administration server is higher that 1000. Instead the following message was displayed:

Denied access to UnknownFilesManager.properties or file missing

After installing the fix the correct warning message is displayed:

The search returned too many results. Only the first 1000 will be displayed. Please refine the search criteria.

APAR IY55908

The catalog manager tool does not show the **unknown files manager** panel if the file catalog.data (which is used to manage signatures) contained an unknown file that has a very large size (greater than 1 GB).

After installing the fix, the problem is resolved.

Other changes as a result of this fix pack

This fix pack creates a file called <INST DIR>\product.xml (where <INST DIR> is the directory where Tivoli License Manager is installed), which keeps track of the current Tivoli License Manager version. After applying the fix, servers and agents, as indicated in this file, will have a new version number of 1.1.1.30. However, the displayed version in the GUI and CLI of the servers will remain at version 1.1.1. The individual agents' software will be updated only when you specifically re-install the agent software, or after you have used the agent self-update facility in the agent configuration file, as described in the IBM Tivoli License Manager: System Administrator's Guide.

Note: The product.xml file already exists, and will only be updated, if you have already installed one of the previous interim fixes: 1.1.1–TLM–0002, 1.1.1-TLM-0005, 1.1.1-TLM-0007LA, or 1.1.1-TLM-0008LA.

After installing this fix, also most of the agent's kernel extension files associated with the various operating systems will be updated. The final kernel extension files are as follows::

Fix pack Installation

The fix pack installation upgrades all the Tivoli License Manager components installed on the machine. Depending on the components you have installed on your machine, different initial steps must be performed.

Once you have installed the fix pack, you cannot uninstall it automatically. For details of how to revert to the previous version see "Revert to the previous version" on page 16.

To install the fix pack, perform the following steps on every machine where you have at least a Tivoli License Manager server, or a Tivoli License Manager database, or the Tivoli License Manager catalog manager tool installed:

- 1. Log on to the computer using the 'Administrator' account on Windows system or as 'root' user on AIX systems.
- 2. Only if you have Tivoli License Manager servers installed on the machine. Ensure that WebSphere Application Server is up and is running. If you apply the fix pack with the WebSphere Application Server not running, the fix pack might not be correctly installed.
- 3. Only if you have the Tivoli License Manager databases installed. Ensure that the DB2 server or client installed on the machine is up and is running. The fix pack will not be installed correctly if DB2 is not running.
- 4. Only if you are upgrading servers or databases. Stop the TLM servers on this machine and remote Tivoli License Manager servers connected to the database installed on this machine.

To do this:

- a. If the computer is running a Tivoli License Manager administration server.
 Stop the server by issuing the command:
 - <INSTALL_DIR>\admin\cli\srvstop
- b. If the computer is running a Tivoli License Manager runtime server. Stop the server by issuing the command: <INSTALL_DIR>\runtime\cli\srvstop
- 5. If the computer is running a Tivoli License Manager runtime server. Check that the Agent self update parameter is disabled, by taking the following steps:
 - a. Ensure the runtime server is stopped
 - b. Edit the file <INSTALL_DIR>\runtime\conf\system.properties
 - c. Check that the following parameter is set to no, modifying it, if necessary: #Agent self-update enablement updateAgentEnabled=no
- 6. To install the fix pack, run one of the following, depending on your platform: **Windows** setupwin32.exe

AIX setupaix.bin

During the installation you will need to choose a valid directory where you want to back up the changed files. The default path is: <INSTALL_DIR>\1.1.1-TLM-FP01, where 1.1.1-TLM-FP01 is a directory created by the backup process. This directory will subsequently referred to in this document as <BACKUP DIR>.

In this directory you will find all the changed files in the same tree structure as they are in the product. To avoid any confusion with the product files, a tilde (~) has been suffixed to each file name in this directory.

The fix pack installation creates (or upgrades if the file was already present) a file called product.xml in the <INSTALL_DIR> directory. This file contains information about product and fix pack versions. In order to verify that the fix pack is correctly installed check that the "FP01" entry is present for each TLM installed component. An install.log file is also created in the <INSTALL_DIR> directory if any error or warning is generated during the fix pack installation.

Any changes to the configuration files that you have made prior to installing this fix pack will be preserved by the install process.

- 7. After the fix pack is installed, the runtime server configuration parameter parm.useproxy is set to n. If you are using a proxy server between your runtime server and its agents, set this parameter to y. The parameter parm.useproxy is in the agent_install.properties file in the <INSTALL_DIR>\runtime\conf directory, and the only valid values are y, Y, n and N.
- 8. If you stopped Tivoli License Manager servers restart them:
 - a. If the system has a Tivoli License Manager administration server installed, restart the server by issuing the command:
 - <INSTALL_DIR>\admin\cli\srvstart
 - b. If the system has a Tivoli License Manager runtime server installed, restart the server by issuing the command:
 - <INSTALL_DIR>\runtime\cli\srvstart

Verify that the fix pack has been correctly applied

Verify that the fix pack has been installed correctly, as follows:

1. Verify that the file product.xml in the <INSTALL_DIR> directory specifies:

```
<Product>
      <Name>IBM Tivoli License Manager
      <Version>1.1.1.30
```

2. Verify that no errors have been logged in the ITLM install.log file in the computer's *<TEMP>* directory.

Upgrading the agents

The following details the steps required to upgrade the agents:

1. If the agent has a version prior to 1.1.1.20 (the agent has not been upgraded with the interim fix 1.1.1–TLM–0005 or later maintenance fixes) then run the kfixer utility before the agent code is upgraded or uninstalled. The kfixer utility is provided with this fix pack, or in the interim fix 1.1.1–TLM–0005 package available on the IBM Support Web site. This utility prevents the agent kernel extension from being unloaded while the fix pack is applied, and ensures that when the agent code is upgraded, the kernel extension will be safely upgraded, as well. The kfixer utility MUST be used before any agent's software is upgraded, by any method.

This utility is only required to upgrade existing agents. After you have applied the fix pack to the runtime server, any new agents can be deployed, by any method, WITHOUT using the kfixer utility.

The kfixer utility comes with a readme file telling you how to run it.

- 2. Update the agent software, WITHOUT uninstalling the agent first. This can be done by any of the methods available to you:
 - Use the Web registration facility at the agent, as described in "Deploying an agent on a node", in the section "Defining a monitoring structure for a customer" in the chapter "Managing a customer infrastructure" in IBM Tivoli License Manager: License Administrator's Guide. In this case you would leave the agent self-update facility disabled.
 - Run the installagent command at the agent, as described in "Deploying an agent manually", in the section "Agent deployment and upgrade", in Chapter 5: "The agent", in IBM Tivoli License Manager: System Administrator's Guide (page 49 in the English language pdf of the guide). In this case you would leave the agent self-update facility disabled.
 - Use the agent self-update facility at each runtime server. This facility can be used ONLY if you have run the kfixer utility at ALL the agents registered with the runtime server. To use this facility, perform the following steps:
 - a. Stop the runtime server by issuing the command: <INST_DIR>\runtime\cli\srvstop.
 - b. Edit the file < INST DIR > \runtime \conf\system.properties
 - c. Modify the following parameters to the shown values:

```
# Agent self-update enablement
updateAgentEnabled=yes
# Time interval for self-update checking (seconds)
updateAgentPeriod=43200
```

The period you have set is 12 hours.

Note: The updateAgentPeriod default setting is higher than that given in the readme files for some prior interim fixes.

- d. Restart the runtime server by issuing the command: <INST DIR>\runtime\cli\srvstart.
- e. Verify that the version number of the agents becomes '1.1.1.30' within a reasonable period of time. The agents will be upgraded automatically as each is contacted by its runtime server, but depending on the number of

agents and the updateAgentPeriod setting, this process could take several days. The updateAgentPeriod setting is defined in the <INSTALL_DIR>\runtime\conf\system.properties file.

To check the version, review the details of selected agents on the Web interface of the administration server. For details, see "Reviewing and deleting agents" in the section "Managing components" in IBM Tivoli License Manager: License Administrator's Guide. Alternatively, run the command tlmagent -v on the agent computer. The command is described fully in the section on agent commands in the IBM Tivoli License Manager: System Administrator's Guide.

Note: If you use the self-update facility, you should be aware that if an agent is rebooted between running the kfixer utility and enabling the agent self-update facility, the agent will not regain its full functionality until the self-update has taken place.

- f. When you are sure that all agents have been updated, perform these steps to disable the self-update function so that it does not degrade performance unnecessarily:
 - 1) Stop the runtime server by issuing the command: <INST DIR>\runtime\cli\srvstop.
 - 2) Edit the file < INST DIR > \runtime \conf\system.properties
 - 3) Modify the following parameter to the shown value: # Agent self-update enablement updateAgentEnabled=no
 - 4) Restart the runtime server by issuing the command: <INST DIR>\runtime\cli\srvstart.

Using a software distribution program for bulk updating: If you have a software program that allows you to install and run programs remotely, like the Software Distribution component of IBM Tivoli Configuration Manager, you can create a software package that runs the kfixer utility and distribute it to all your registered agents. When the software distribution program has reported that the utility has been successfully run on ALL agents, you can enable the agent self-update facility at the runtime server.

Alternatively, you can create a software package that runs the kfixer utility followed by the installagent command, and distribute it to all agents. The software distribution package should contain all of the files required by the installagent command for the platform to which it is being distributed. In this case you would leave the agent self-update facility at the runtime server disabled.

Revert to the previous version

You can revert to the previous version of the product (undo the fix pack) but if updates of the agent software have taken place you must also revert those updates. See "Reverting the agents to the previous version" on page 19 for instructions on reverting updated agents to the previous version.

The following instructions for reverting to the previous version of the servers refer to WebSphere 4.0.x. (see "Reverting to the previous version when WebSphere application server, version 4.0.x is installed" on page 17). If you have installed WebSphere 3.5 please contact IBM Customer Support for instructions on how to revert to the previous version.

Reverting to the previous version when WebSphere application server, version 4.0.x is installed: The steps must be performed on all systems where the administration server, the runtime server, or both are installed, and are as follows:

- 1. Log on to the system with administration authority.
- 2. Stop the Tivoli License Manager servers from the WebSphere Application Console.
- 3. Copy the backed-up original files from the backup directories to their original locations. The files are listed below, and they must be copied from the backup directory (that you defined in step 6 on page 14 of the install procedure) to the product's install directory, maintaining the same subdirectory structure, and removing the final tilde (~). For example, copy

```
<BACKUP_DIR>\admin\conf\agent_install.properties~ to
<INSTALL_DIR>\admin\conf\agent_install.properties.
```

5. Run the following scripts to uncompress the backed-up .ear files in the backup directories and move them into the live directories. The script names depend on your operating system:

<INSTALL DIR>\runtime\setup\installRuntime.bat

From any directory, run the following scripts:

6. Start the Tivoli License Manager servers from the WebSphere Application Console.

Reverting the agents to the previous version: To revert any updated agents, the same process applies, regardless of the version of the WebSphere Application Server in use.

You need to follow these steps:

1. Revert the administration server and all runtime servers, as described above.

- 2. Identify the agents that have been updated by viewing the agent details in the GUI. Upgraded agents will have a version of 1.1.1.30.
- 3. Manually uninstall the new agent software from the systems to which it has been distributed, following the instructions for uninstalling the agent given in the installation chapter of the *IBM Tivoli License Manager: System Administrator's Guide*.
- 4. Register the agents again with their runtime servers, either using the Web registration described in the *IBM Tivoli License Manager: License Administrator's Guide*, or by issuing the **installagent** command from the agent system's command line (using the **installagent** package created with the version of code that was installed before this fix pack was installed), as documented in the agent chapter of the *IBM Tivoli License Manager: System Administrator's Guide*.

Tips

Occasionally, when installing this fix pack, even if WebSphere Application Server is running, on the last panel of the GUI you may receive this error:

Errors occurred: IBM WebSphere could be not be configured or was not running. Refer to the install log for additional information. Refer to the installation instructions for manual configuration.

If this message is displayed, you must manually configure the administration or runtime server again. To configure the administration or runtime server, refer to WebSphere Application Server configuration, in the Common Problems section in the Problem Determination chapter of the *System Administration Guide*. Refer to the symptom "A Tivoli License Manager server is missing from the WebSphere Application Server list of application servers".

This fix pack is the first fix pack to be issued for Tivoli License Manager. version 1.1.1. This fix pack also contains all the fixes from the Interim Fix 1.1-TLM WEP-0001.

Tivoli License Manager 1.1 Warehouse Enablement Pack patch fails to install on Tivoli Data Warehouse version 1.2 with the error "CDWIC5066E An error was detected while running the pre-script"

It is not possible to install the interim fix 1.1–TLM_WEP-0001 on Tivoli Data Warehouse version 1.2.

After applying the fix, the problem does not occur.

NLS support

After you have installed the fix, the NLS support has been corrected. The resource bundles are loaded within the patch and all the strings in all supported languages are correct.

Agent name longer than 40 characters

Running Tivoli License Manager Warehouse Enablement Pack, version 1.1.1, an error occurs if the agent version is 1.1.1.xx (two digits).

After applying the fix, the problem does not occur.

Slow extraction of data

Extraction of the Tivoli License Manager data for Tivoli Enterprise[™] Data Warehouse, was slow.

After you apply this fix pack the speed of the process is improved.

Agents not included in Tivoli Enterprise Data Warehouse reports

When a fix pack is applied to the agent code of Tivoli License Manager, the agent version number is changed to reflect the new fix pack level. However, agents with this new version were not being included in Tivoli Enterprise Data Warehouse reports.

After you apply this fix pack, the upgraded agents are included in the reports and are also shown at the GA level. This means that after the installation of this fix pack, the reports will show Tivoli License Manager version 1.1.1, but the agent will be at the maintenance level 1.1.1.xx.

Extraction of the Tivoli License Manager data fails

Extraction of the Tivoli License Manager data for Tivoli Enterprise Data Warehouse fails if the Tivoli License Manager environment in which it was being run had a large number of agents (for example, more than 1000).

After you apply this fix pack the problem no longer exists.

Tips

Two versions of reports on Tivoli Data Warehouse 1.2

If you have installed Tivoli License Manager Warehouse Enablement Pack

and the fix pack 1.1–TLM_WEP–FP01, on Tivoli Data Warehouse version 1.2, there are two versions of reports displayed in the Crystal Management console. Remove the old version as follows:

- 1. Connect to the Crystal Management console. Log on as administrator.
- 2. Click Manage folders.
- 3. Select Tivoli reports, then Tivoli License Manager v1.1.0.
- 4. Click **Delete** to remove the Version 1.1.0 reports.

After you perform this task, only Tivoli License Manager Warehouse Enablement Pack, reports are shown in the Crystal Management console.

In addition to the instructions given here, you can also look in the file wep_patch.txt, which is included in the file 1.1-TDW-FP03.tar of the fix 1.1-TDW-FP03 that you can download from the IBM Customer Support Web site.

Perform the following steps to install the fix pack:

- 1. Log on to the system using an account with administration authority.
- 2. From the Tivoli Enterprise Data Warehouse console stop the active extract, transform, and load (ETL) processes.
- 3. Backup the following components before starting the fix pack installation (backup procedures are described in the chapter on maintaining Tivoli Enterprise Data Warehouse in Installing and Configuring Tivoli Enterprise Data *Warehouse*):
 - The Tivoli Enterprise Data Warehouse databases

- 8. Edit the twh_app_patcher.cfg configuration file to complete the section marked USER SUPPLIED SECTION. These are all the fields that you must fill in:

APP_MEDIA_DIR

This tag must be assigned the directory path of the source files for the application warehouse enablement pack patch that you are currently installing. This directory must contain a file named "twh_install_props.cfg".

PS HOME

This tag appears only on a system where the Tivoli Enterprise Data Warehouse Reporting Interface (RPI) component is installed. This tag must be assigned a value that is the directory path where Tivoli Presentation Services is installed.

DB2PASS

This tag must be assigned the password of the user indicated by the DB2USER tag in the AUTO-GENERATED SECTION that appears immediately below the USER SUPPLIED SECTION. This is a DB2 user defined for the current system.

COPT_CTRL_DB2PASS

This tag must be assigned the password of the user indicated by the COPT_CTRL_DB2USER tag in the AUTO-GENERATED SECTION that appears immediately below the USER SUPPLIED SECTION. This is a DB2 user defined for the system where the Tivoli Enterprise Data Warehouse Control Server component is installed, as indicated by the COPT_CTRL_DB2H0ST tag in the AUTO-GENERATED SECTION.

COPT_CDW_DB2PASS

This tag must be assigned the password of the user indicated by the COPT_CDW_DB2USER tag in the AUTO-GENERATED SECTION that appears immediately below the USER SUPPLIED SECTION. This is a DB2 user defined for the system where the Tivoli Enterprise Data Warehouse Central Data Warehouse database is installed, as indicated by the COPT_CDW_DB2HOST tag in the AUTO-GENERATED SECTION.

Reverting to the previous version

The instructions for reverting to the previous version are as follows:

- 1. Log on to the system with administration authority.
- 2. From the Tivoli Enterprise Data Warehouse console stop the active ETL processes.
- 3. Restore all the files that you backed up in step 3 on page 23 of the install procedure.
- 4. Reboot the computer where you installed the interim fix.
