### Functions for the Job Scheduling Console Fix Pack 03 version 8.3.0

This version of the Job Scheduling Console supports the following new Tivoli Workload Scheduler for z/OS<sup>®</sup> version 8.3 functions:

#### SLES 10 support

Tivoli Workload Scheduler V8.3 Fix Pack 03 has been successfully certified on Sles 10. You can now install Tivoli Workload Scheduler V8.3 (December 2006) and then V8.3 Fix Pack 03. Using the following configuration you can run on SLES 10.0:

SuSE SLES 10.0 32bit xSeries, TWS 8.3 FP03 (server and FTA)  
 SuSE SLES 10.0 64bit pSeries, TWS 8.3 FP03 (server and FTA)  
 SuSE SLES 10.0 64bit AMD64/EM64T, TWS 8.3 FP03 (server and FTA)

### Functions for the Job Scheduling Console Fix Pack 02 version 8.3.0

This version of the Job Scheduling Console supports the following new Tivoli Workload Scheduler for z/OS version 8.3 functions:

#### Critical path

Job Scheduling Console supports the critical path enhancements. For each job defined as critical, a specific critical path is calculated during daily planning processing. See Tivoli Workload Scheduler General Information manual version 8.3.0 for a detailed explanation.

#### Delay between jobs

Using this feature you can define a workstation on which to run a general job that waits for the period of time defined in its duration. In this way you obtain a controlled delay between a sequence of jobs. See Tivoli Workload Scheduler General Information manual version 8.3.0 for a detailed explanation.

#### Every option in application run cycles

Using this feature you can specify the frequency with which you want to run a job stream starting from the input arrival time. See Tivoli Workload Scheduler General Information manual version 8.3.0 for a detailed explanation.

## Restart and Cleanup

This feature has been enhanced to perform:

- **Restart and cleanup functions with the JCL not expanded**

When you create a job by default the JCL is not expanded, during the restart and cleanup you cannot change it. Therefore the standard restart and cleanup functions runs with the JCL not expanded.

- **Fast Job Restart**

From the List of all scheduled jobs you can restart a job from the first step using the default values. You cannot modify the list of data sets with the related steps, or the JCL.

- **Fast Step Restart**

From the List of all scheduled jobs you can restart a job from the best step determined by the scheduler. You cannot select a different step or modify any other aspects of the job.

## Workload Manager (WLM) integration

Using this feature you can:

- Associate a WLM scheduling environment to a job either directly in the database or in the plan.
- Filter for job streams that contain jobs associated with this WLM scheduling environment.
- Filter for job instances with this WLM scheduling environment.
- Filter for job stream instances that contain jobs associated with this WLM scheduling environment.
- Filter for job stream instances according to whether the associated jobs are waiting for a WLM scheduling environment.
- Filter for job instances waiting for a WLM scheduling environment.

## System automation integration

Using this feature you can interface with Tivoli System Automation for z/OS. In detail you can:

- Define an Automation workstation in the database.
- Define an Automation job in the database.
- Modify an Automation job in the plan.

## Special resource availability switch

Special resources are enhanced with the capability to automatically change their availability to OFF upon any of the following events:

- At the completion of an operation
- After *n* operations have started
- After a specified interval of time

See Tivoli Workload Scheduler General Information manual version 8.3.0 for a detailed explanation.

## Kill a job instance running on a fault-tolerant agent

Using the kill function you can stop a job instance that is currently running on a fault-tolerant agent or on a standard agent.

## Start the Job Scheduling Console from an external application

Using the `LIC_JSC_operating_system` script, you can start the Job Scheduling Console from an external application to display a list of jobs or job streams in the plan.

### **HP-UX 11iv2 for Integrity**

Full support is extended on HP-UX 11iv2 for Integrity to the Job Scheduling Console and to both Connectors.

### **Dep Support**

Tivoli Workload Scheduler is fully compatible with the Data Execution Prevention (DEP) feature of MicroSoft Windows® operating systems.

### **Working with Windows Vista in compatibility mode**

Tivoli Workload Scheduler runs on Windows Vista in compatibility mode.

### **jvm sr5 Support**

For every platform jvm is redistributed with this fix pack. New jvm is jvm 1.4.2 sr5: With this jvm service release Australia, US and Canada Daylight Saving Time changes are correctly managed. Another CD is available for this fix pack with <jvm 1.4.2> file to permit software distribution via CM.

### **Daylight Saving Time (DST) changes**

This fix pack automatically applies the required adjustments to the 2008 DST start and end dates in the US in accordance with the change mandated by the US Energy Policy Act of 2005.

To apply similar time zone adjustments for:

- Bermuda
- Brazil
- Canada
- Western Australia

you must run the IBM Time Zone Update Utility for Java™ (JTZU) manually after applying the fix pack.

## Disk space requirements

Before starting the fix pack installation in undoable mode, make sure you have at least 200 MB of free space in the root/Administrator home directory for the installation backup.

## Installing the fix pack

The Job Scheduling Console fix pack installation is based on ISMP technology. You can install the fix pack only after you have installed the Job Scheduling Console.

## Installing using the ISMP wizard

Before installing the fix pack, create a backup copy of the Job Scheduling Console preferences file located inside the `.twconsole` directory. Follow these steps to install the fix pack using the wizard:

1. Insert the CD for your operating system in the CD ROM drive. See "Fix pack structure" on page 11.
2. Navigate to the `INSTALLER` directory.
3. Download the specific TAR or ZIP file for the operating system and unpack it. If you are installing on a UNIX operating system, run the following command:  

```
chmod -R 755 <imagesDir>
```
4. Depending on the type of operating system run:

### On Windows:

`setup.exe`

### On UNIX:

`./setup.bin`

5. Select the language of the installation wizard. Click **OK**.
6. Read the welcome information and click **Next**.
7. Read and accept the license agreement. Click **Next**. A discovery action is launched. A panel listing the discovered conditions is displayed. In the list below the possible conditions and the corresponding actions you must perform to install the fix pack:

### No JSC instance is installed (V8.3 or previous instances) => error message.

If no instance is discovered an error message is displayed. This means that the Job Scheduling Console is not installed on the workstation or the registry has a problem. Click **Next**, and exit from the installation panel.

### No JSC V8.3 FP is installed => only APPLY action is possible.

If there are no previous fix packs applied to the Job Scheduling Console, then you can only select the **Apply** action. With this action the fix pack is installed in undoable mode and a backup copy of the product is stored on your workstation.

### Previous JSC V8.3 FP is installed => APPLY current FP or ROLLBACK or COMMIT previous FP are permitted

If there are previous fix packs already installed, **Apply**, **Rollback** and **Commit** actions are available. Select one of the following actions:

**Apply** Use this action to install the fix pack without making it permanent. If you apply the fix pack in "undoable" mode you can use the roll back action to return to the previous fix pack.

**Note:** If you have a Job Scheduling Console fix pack installed in "undoable mode" (IU state) on your workstation and you are applying a more recent Job Scheduling Console fix pack on it, all the changes that you have made when installing the previous Job Scheduling Console fix pack will be committed before applying the newer ones. Therefore, if you undo the fix pack you last installed, you will restore the previous fix pack changes.

### Rollback

Use this action to roll back to the previous level.

### Commit

Use this action to make the fix pack permanent. If you commit the fix pack you cannot roll it back.

### Repair

Use this action (only after **Commit** action) to restore an existing Tivoli Workload Scheduler instance to the current committed level when a problem arises with a binary files.

8. Click **Finish** to complete the installation.

If you have a Job Scheduling Console fix pack installed in "undoable mode" (IU state) on your workstation and you are applying a more recent Job Scheduling Console fix pack on it, all the changes that you have made when installing the previous Job Scheduling Console fix pack will be committed before applying the newer ones. Therefore, if you undo the fix pack you last installed, you will restore the previous fix pack changes.

## Installing using the ISMP silent installation

The silent installation requires the customization of a response file. A sample response file is available on all CDs, in the Response\_File directory.

Run the following command from the path were the SETUP file is located to start the installation in silent mode:

- **On Windows:**

```
setup.exe -options JSCFixPackinstallation.txt -silent
```

- **On UNIX:**

```
./setup.bin -options JSCFixPackinstallation.txt -silent
```

where JSCFixPackinstallation.txt is the name of the response file you customized with your environment settings.

Table 5 lists the keywords you can set in the `-W beanActionsPanel.selectedAction` parameter to custom the JSCFixPackinstallation.txt response file to your needs:

Table 5. Response file keywords

APPLY_AND_COMMIT	Repair an installed and committed fix pack <b>Notes:</b> 1. This action is available only when you install a fix pack. It is not available on General Availability (GA) versions.

## Uninstalling the fix pack

You can uninstall the fix pack only if you installed it in undoable mode.

To uninstall the fix pack perform the following steps:

1. Launch the installation setup related to your operating system (from the installation CD or from the directory where you downloaded the tar file).
2. Select the instance you want to remove.
3. Select the **UNDO** option.

4. Click **Finish**.

### **Installation log files**

When using the installation wizard, a log file is generated in the following location:

**On Windows:**

`%temp%/twsconsole_ismp.log`

**On UNIX:**

`$TMP/twsconsole_ismp.log`

### **Known Limitations for installing this fix pack**

The following are known problems, together with information to help avoid them, that you might encounter when installing this fix pack:

- Defect 37302 - To connect a Job Scheduling Console 8.3 fix pack 4 to a Tivoli Workload Scheduler MDM 8.3 Fix Pack 01, you need to install the PK47309 WebSphere Application Server patch on the MDM. This is a known problem due to WebSphere Application Server patch.
- The window displaying the installation summary shows the wrong disk space size.
- During the installation process a warning message might be displayed for replacing the Java Virtual Machine. You must answer YES.
- Time zone errors have been reported against Java 1.4.2 version 5 or later.  
8.3.0-TIV-TWSJSC-FP0003 has been built using this level of Java to include the DST 2007 changes for US and Canada.

There is a major incompatibility issue in the recent Java service refreshes (1.4.2 SR5 or above; 5.0 SR1 or above) due to the reassignment of the three-letter time zone IDs ("EST" and "MST") introduced into the standard Olson time zone table. As a result, Job Scheduling Console 8.3 Fix Pack 02 that uses "EST" or "MST" will have incorrect time zone offset from Java APIs during the Daylight Saving Time period. During the period of DST, the time returned by the API call is now incorrect by one hour. If these are used, change the code to use the long time zone ID such as "America/New\_York" or GMT based time zone ID such as "GMT-05:00".

From Tivoli Workload Scheduler V8.2.1 the long time zone ID has been implemented so it is recommended to use these long time zones. In addition to previous bug Java 1.4.2 SR5 or greater level remove the "AGT". AGT can now be accessed as America/Argentina/Buenos\_Aires. If you apply Fix Pack 02 on the Job Scheduling Console version 8.3 do not use the "AGT" time zone definition. The Job Scheduling Console 8.3 Fix Pack 02 incorrectly displays or submits ad hoc job and job stream with these time zones and time-dependencies. "AGT" is no longer recognized by Java 1.4.2 SR5.

## **Software limitations and workarounds**

This section contains software limitations, problems, and workarounds for Job Scheduling Console.

The following are software limitations that affect Job Scheduling Console.

### **Communication problems with the engine when using IPv6**

If you are using the Job Scheduling Console in environments where you are using the IPv6 protocol or in mixed environments where both the IPv4 and IPv6 protocols are in use, you might experience connection problems.

#### **Workaround**

To fix this problem set a configuration parameter in the application server, as follows:

1. Open the following file for editing:

```
$TWS_HOME/appserver/profiles/twsprofile/config/cells/  
DefaultNode/nodes/DefaultNode/servers/server1/server.xml
```

2. Locate the variables

```
java.net.preferIPv4Addresses
```

and

```
java.net.preferIPv6Addresses
```

3. Set the variables as follows:

#### **Pure IPv6 environment**

```
java.net.preferIPv4Addresses=false  
java.net.preferIPv6Addresses=true
```

#### **Pure IPv4 environment**

```
java.net.preferIPv4Addresses=true  
java.net.preferIPv6Addresses=false
```

#### **Mixed IPv4 and IPv6 environments**

```
java.net.preferIPv4Addresses=false  
java.net.preferIPv6Addresses=false
```

4. Stop and restart the application server, using the commands **stopappserver** and **startappserver**

### **Properties of recovery jobs with the same name not displayed properly**

Due to a defective identification process in the distributed connector, the properties of recovery jobs having the same name within the same job stream instance are not displayed properly. If you have more than one recovery job with the same name in the Job Scheduling Console list of job instances, and you select the one that was run last to see its properties, the properties displayed might not be those of the instance you expect but of a previous instance with the same name.

This applies to recovery jobs with the same name that are in the rerun chains of different jobs within a job stream as well as multiple instances of the same recovery job.

### **Estimated duration filter**

In job and job stream plan lists you cannot filter the Estimated Duration by days.

### **Importing "All scheduled job instances"**

Importing "All scheduled job instances" Job Scheduling Console V1.4 filters in Job Scheduling Console V8.3, the values of "Actual Start Time Range" refer to an older date.

## **Documentation updates**

These are the fixes for the documentation APARs and internal defects that are made available.

In "Chapter 3. Planning and installing the z/OS connector", section "Installing the z/OS connector", replace the description of Step 7 with the following description:

Specify the user name and password of the *TWSuser* for which you are installing the connector.

When installing in a Windows domain,

- If the specified user does not exist it is created with the permission necessary to work with Tivoli Workload Scheduler.
- If the *TWSuser* is a local user it must be specified in the form *hostname\username*, otherwise if you supply only the *username* the z/OS connector installation considers it as a user domain.

Click **Next**.

**41369** Add the following chapter in "Part 1. Planning and Installation" as Chapter 5:

#### **Starting the Job Scheduling Console with no engine connection**

This chapter describes how to set the user preferences to change the Job Scheduling Console default behavior to not connect to any engines when you start it.

To do this modify, the preferences.xml file, by performing the following steps:

1. Open the preferences.xml file stored in the *user\_home\_directory/.twconsole/userdata* directory.
2. Add the **TryToConnect** key under the consoleUserPreferences node and set it to **false** as follows:

```
<!-->  
<entry key="TryToConnect" value="false"/>
```

When you start the Job Scheduling Console, no engine connection is made. When you want to connect an engine, double-click its icon. When you want to change this behavior and start all the engines that you defined, you can either set the key to **true** or remove the key from the preferences.xml file.

**40935** In "Part 4. Defining Objects", "Chapter 23. Creating Domains", **Domain name** field, replace the description with the following:

The workstation domain name. The name must start with a letter and can contain alphanumeric characters, dashes, and underscores. The maximum length is 16 characters. Domain names must be unique and cannot be the same as workstation and workstation class names.

**35439** In "Chapter 26. Creating job streams, section "Creating distributed job streams", subsection "Time Restrictions page" replace the description of the **Time Zone** field with the following description:

This is a read-only field that displays the time zone you selected in the General page. All the time restrictions are expressed using this time zone. For information about enabling the time zone, refer to the *IBM Tivoli Workload Scheduler: Planning and Installation Guide*.

**40433** In "Chapter 30, Creating Plan lists", perform the following changes:



In the section "Creating distributed job stream instance lists in the plan", **Dependencies** page, add the following note after the explanation of the **Job Stream** field:

**Note:** If you specify an asterisk (\*) in the **Workstation** field or in the **Job Stream** field filters, you select all the job instances for which at least one job stream dependency was defined on each workstation or on each job stream. If you want to filter the job stream instances with at least one follows dependency from a job, you must specify also a value in the **Job** field.

In the section "Creating distributed job instance lists in the plan", **Dependencies** page, add the following note after the explanation of the Job/Job Stream Dependency sub-section:

**Note:** If you specify an asterisk (\*) in the **Workstation** field and or in the **Job Stream** field filters, you select all the job instances for which at least one job stream dependency was defined on each workstation or on each job stream. If you want to filter the job instances with at least one follows dependency from a job, you must specify also a value in the **Job** field.

38787 In Chapter 47, "Managing Distributed Job Stream Instances in the Plan", perform the following changes:

In section "Releasing a job stream instance, add the following note:

**Note:** When you release a job stream instance that was created with priority 0 in the Job Scheduling Console, the job stream priority should remain at zero and the job stream instance should not start. However, the job stream starts immediately, because of an error in the way the Job Scheduling Console sets the priority information. To avoid this problem, use conman or JnextPlan to release the instance. The full explanation of why this happens is described in the online Release Notes<sup>®</sup> under the heading: "The release of jobs or job streams submitted by the Job Scheduling Console with priority 0 does not work properly".

In the section "Changing the priority of a job stream instance", add another note:

**Note:** If you change the priority of a job stream instance to 0, the job stream instance should not start. However, the job stream starts immediately, because of an error in the way the Job Scheduling Console sets the priority information. However, the job starts immediately, because of an error in the way the Job Scheduling Console sets the priority information. To avoid this problem, use conman or JnextPlan to release the instance. The full

explanation of why this happens is described in the online Release Notes in the section "The release of jobs or job streams submitted by the Job Scheduling Console with priority 0 does not work properly".

**IZ10959**

In Chapter 47, "Managing distributed job stream instances in the plan", section "Cancelling a job stream instance" add the following sentence before the "For more information" sentence in the first paragraph:

If you cancel a job stream instance that contains jobs with a repeat range, only the last instance of these jobs is marked as canceled in the All scheduled Job list.

**40746** In Chapter 5 "Installing and Adding Language Packs" after the "Adding language packs to an existing installation" section add the following section:

**Changing language**

To change a language, you must edit the console file for your operating system (for example, NTConsole.bat, LinuxConsole.sh) and add the following options on the **START** command immediately following the `-Dcom.ibm.ssl.keyStore="$KEYSDIR/JSCDefaultKeyFile.jks"` option:
