About this document

This document provides details of all the APAR service fixes that impact upon documentation, for IBM File Manager for z/OS Version 6.1, since the most recent edition of the product manuals in May 2006. These editions are:

The Addendum document is divided into two parts:

- **Part One: PTF/APAR Documentation Changes**

This section lists the changes to the File Manager for z/OS Version 6 Release 1 documentation that are required to reflect new behavior resulting from the application of APAR fixes.

Initial problem description

1. When using the Find/Change utility to change JCL and a trailing space is specified in the CHANGE command, no match will be found because trailing spaces are not included in the logical JCL statement built by File Manager.
2. The Find/Change utility does not recognize the VCONTEXT command when the JCL option has been selected.

Outline of solution

1. Trailing spaces will be include in the logical JCL statement against which the Find parameter is compared.
2. The VCONTEXT command parameters will be taken into consideration when producing the Find/Change utility report and the LIST=LONG and JCL options have been specified.

Chapter 18, Customizing FM/IMS

In the section: "Customizing to use File Manager/IMS in DLI mode", change the first bullet point, to read:

- The IMS RESLIB load library names, that is, the fully qualified data set names as specified on the DFSRESLB DD for a DLI batch job. Supply these names in the RESLIB1 option (and also the RESLIB2, RESLIB3, RESLIB4, RESLIB5, and RESLIB6 options, if required), in FMN1POPD.

In the section: "Customizing to use File Manager/IMS in BMP mode", change the second bullet point, to read:

- The IMS RESLIB load library names used by the dependent region. Supply these names in the RESLIB1 option (and also the RESLIB2, RESLIB3, RESLIB4, RESLIB5, and RESLIB6 options, if required), in FMN1POPI.

In section: "Examples of FMN1POPI and FMN1AGNT macros", change example IF22 to read:

In the section: "Changing the default options", figure 11, parts 2 and 3, (FMN1POPD and FMN1POPI), add three new options after RESLIB3 in each case:

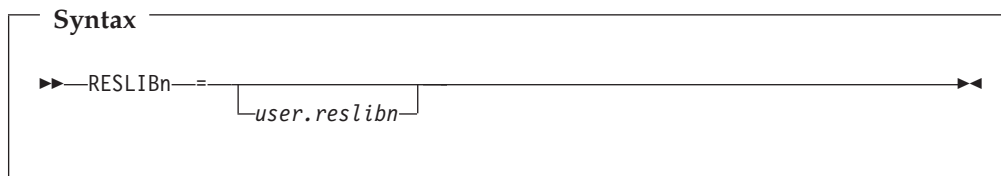

Add the following new File Manager/IMS option to appendix C, FMN1POPD, where RESLIBn is RESLIB4, RESLIB5 and RESLIB6:

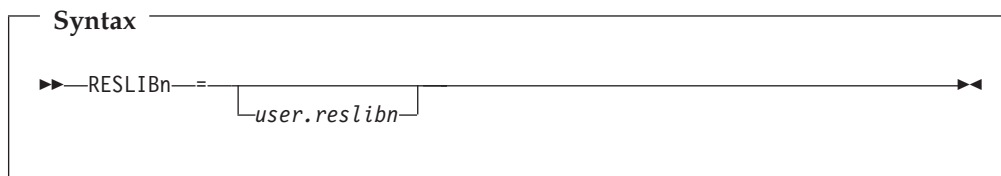
RESLIBn:



RESLIBn specifies an additional user-defined library, if required, for File Manager/IMS in DLI mode: for example, a library containing dynamic allocation or user exit routines. If an additional library is not required, leave this option blank.

Add the following new File Manager/IMS option to appendix C, FMN1POPI, where RESLIBn is RESLIB4, RESLIB5 and RESLIB6:

RESLIBn specifies an additional user-defined library, if required, for File Manager/IMS in BMP mode: for example, a library containing

Chapter 9, Panels and Fields

In section, "DLI Mode Data Sets panel", update the DLI Mode Data Sets panel:

Under the RESLIB header, add entries for the new fields: Data set name #4, Data set name #5, and Data set name #6. Text should be the same as that for Data set name #3.

Chapter 11, Functions

In sections "IEB (IMS Edit Batch)", "ILB (IMS Load)", "IPR (IMS Print)" and "IXB (IMS Extract)", add optional parameters:

to the DLI parameter section of the syntax diagrams.

Initial problem description

1. ABENDS0C4 abend S0C4 in FMNEDJPN may be reported when performing a FIND command in a member list (for example LOAD MOD MEMBER SELECTION 3.10)
2. Users in DBCS-enabled environment are unable to enter lower-case File Manager commands.

Outline of solution

1. Program logic has changed to make sure that the "pair table" is always allocated before creating FIND argument pairs for DBCS processing.
2. File Manager is being enhanced to allow for a user-customizable command verbs and command keywords translation table and allowing lower case command verb and keyword input in DBCS environments.

Chapter 3, Customizing File Manager

In the section: "Changing the print and display tables":

- Remove the fourth paragraph.
- Add the following new translate table to the list, before TRUP.

TRUPC used to translate lower case characters to uppercase characters for File Manager command verbs and command keywords only. This table generally does not need to be customized in an SBCS environment.

Chapter 6, Customizing File Manager for national languages

In the section: "Changing the print and display translation tables for languages other than English", add the following paragraph to step 4.b:

File Manager provides support under ISPF for command verbs and command keywords entered in lower or uppercase as long as they are a valid SBCS-only strings and the a - z codepoints in the host codepage used correspond to the standard EBCDIC a-z codepoints. If this is not the case, and you want to be able to enter lower or mixed case command verbs and command keywords, then the TRUPC translation table in FMNTRTBS needs to be modified to specify the uppercase A - Z EBCDIC codepoints at locations corresponding to the a - z codepoints in the codepage used.

Add the same paragraph to step 2, in the section: "Customizing for the Japanese national language - Modifying the Japanese translation tables".

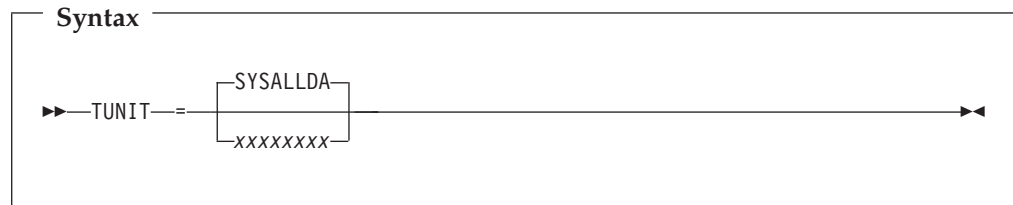

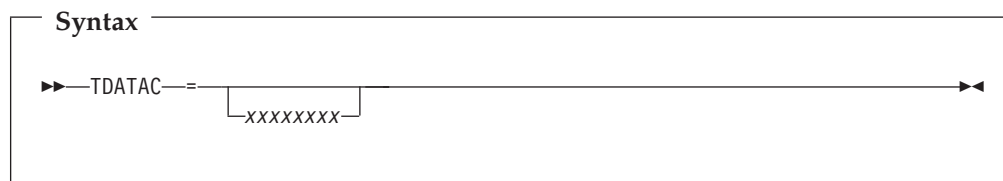

TUNIT specifies the default temporary unit that File Manager will use when allocating work data sets for internal use.

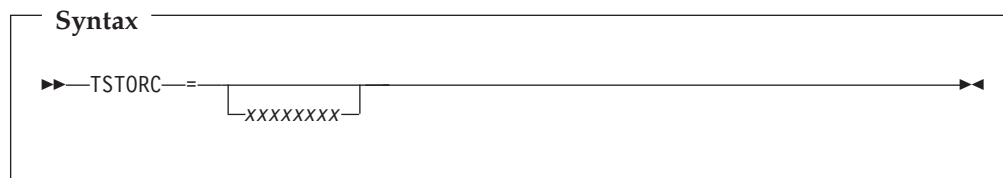
The default is SYSALLDA. The maximum length you can specify for TUNIT is eight (8) bytes.

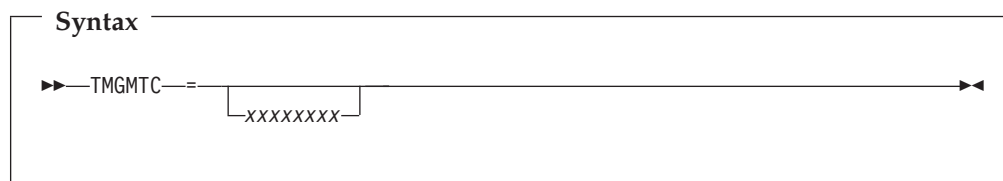

TDATAAC is optional. The maximum length you can specify for TDATAAC is eight (8) bytes.

1. Error "FMN0355I Record size (80) invalid for FIXED,90 output" may be reported and changed member corrupted.
2. When creating a template from PLI copybooks where the template is created using multiple copybooks and 01 field names are supplied for each of the copybooks, some supplied field names are ignored and an asterisk (*) is substituted (PK33914).
3. FM job may abend with ABENDS978, abend S978 (PK35058).
4. ABENDS0C4 in IRXINIT, ABENDS978 in ISPF, ABENDS0C4, ABEND S0C4, or unpredictable results after specifying template criteria using the by field panels and RG operators (PK33920).

Outline of solution

1. Program logic has been corrected to allow for JCL records to be up to 160 bytes, regardless of PAD setting. Only data in columns 1 - 72 is considered to be JCL statements, data past column 72 will be treated as non-changeable sequence numbers/comments. Note that when change causes a JCL record to spill over and cause a continuation record to be created then any data in columns 72-end-of-record will be copied from the original record to the newly inserted record.

For all FM components, the SET function has been enhanced to allow for a change of the TEMPHLQ value dynamically in batch processing (for the duration of the batch job).

2. When creating a template from PLI copybooks where the template is created using multiple copybooks and 01 field names are supplied for each of the copybooks, some supplied field names will be used.
- 3 to 7. Program logic has been corrected.
4. The storage overlay has been corrected.

In the section, "FCH (Find/Change)", in the description for the JCL=YES option, replace the following text:

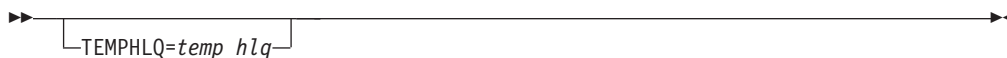
"The data in columns 73-80 for new physical records is copied from the last related original physical record."

with

"The data in columns 73-record length for new physical records is copied from the last related original physical record. Data past column 72 will be treated as non-changeable sequence numbers/comments."

Chapter 17, "Functions"

In the section, "SET (Set Processing Options)", add the following to the syntax diagram:



In the descriptions following the syntax diagram, add the following:

TEMPHLQ

TEMPHLQ specifies an installation-specific high-level qualifier for the temporary data sets created during a File Manager session. You can specify any valid qualifier, including multilevel if required, up to a total length of 24 characters. If you specify &USER. for any part of the qualifier, this is replaced with the user's userid. A multilevel qualifier with symbols follows the same rules as in the specification of a data set name with symbolic parameters in JCL procedures. Thus, a single period used after a symbol combines the symbol with the text following it (See Example 1 below); a period separating parts of a multilevel qualifier must be doubled (see Example 2 below).

Example 1

If the userid is XXXX, then specifying &USER.1.TEMP results in a high-level-qualifier of XXX1.TEMP

Example 2

If the userid is ZZZZ then specifying FMN.&USER..ABCD results in a high-level-qualifier of FMN.ZZZZ.ABCD

Notes:

1. The TEMPHLQ parameter can be up to 24 characters long. However, temporary data sets can have different lengths, and the system part of the data set name may be longer than 20 characters. In this case, minor levels of TEMPHLQ are ignored, to the extent that the final data set name is less than or equal to 44 characters.
2. Concatenation of &USER.string could result in a part of the high-level qualifier being longer than 8 characters. In this case, the string is shortened to the extent that the final part of the qualifier is 8 characters long.

DSC may copy records truncating them (because of record length difference between input and output). No specific return code value is associated with such condition and value of 0 is being returned.

Outline of solution

File Manager has been enhanced to provide a customizable return code for the conditions of dsc_rectrc (record truncation occurred) and dsc fldtrc (field truncation occurred). These return codes default to 0 (to match

existing behavior) and can be user-customized using the procedures described in the File Manager Customization Guide.

When executing the DSP batch function twice in the same job and the first function execution include the PROC parameter the second execution of the function expects the PROC parameter to be supplied (PK28839).

When producing an IMS Audit report File manager may ABENDS0C4 (PK29446).

When changing JCL and the replace string is longer than the search string the changed JCL statement may be corrupt (PK29597).

File Manager may ABENDS0C4 when generating the DB2 Audit report (PK29754, PFM01526).

File Manager may ABENDS0C4 when generating the Audit Report if the record and the template do not match and the record is shorter than the record definition in the template (PK30204).

ABEND0C4 S0C4 may occur in FMNFCH when the user specifies a user proc with no REXX/FASTREXX statements in FCH batch (PK30703).

Datasets/DDNAME not found condition may be reported when multiple functions reference the same VSAM dataset DDNAME (PFM02084).

User IO exit never called for term and other IO exit processing problems (PFM01917).

When comparing data sets using a template containing arrays, array elements may be incorrectly reported as changed when they are not (PMR 06888,101,616).

Outline of solution

When comparing data sets using read-ahead synchronization with synchronization length greater than one all records will be reported correctly.

Skeleton and code have been corrected to allow for proper SHOWATTR generation.

The JUST option has been added to the skeleton and the roadmap.

When executing the DSP or DSC batch functions twice in the same job and the first function execution includes the PROC parameter the second execution of the function will execute successfully if the PROC parameter is not supplied.

When producing an IMS Audit report File Manager will confirm that the current template is for the same DBD as the log record being report. If this is not the case a message will be issued and an unformatted report generated.

The changed JCL statement will not be corrupted when the replace string is longer than the search string.

If an invalid template is found when generating the DB2 Audit report a message will be generated and an unformatted report will be produced. This APAR also resolves internally reported problem PFM01526.

File Manager will not examine fields whose boundaries exceed the record boundary.

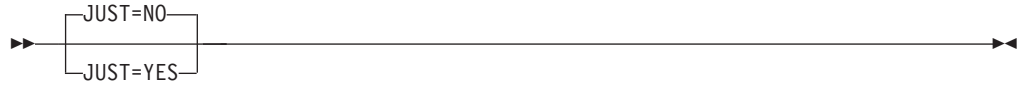

Initial problem description

All components:

1. If the cursor is in the data when a FIND, CHANGE, RFIND or RCHANGE command is issued and the search reaches the end of the search range without finding an occurrence of the search string, the cursor moves back to the command line. It should remain where it was before the command was issued.

FM/IMS component:

2. When editing or browsing a Fast Path database with a view that has selection criteria on the root segment, FM/IMS does not display all the segments that satisfy the selection criteria. The problem occurs when FM/IMS converts the selection criteria into a qualified SSA that specifies a range of root key values.

3. FM/IMS Edit and Browse functions go into a loop repeatedly issuing the message: 'FMN1POSN+00000708 fail get first sc=GE' after pressing the Enter key on the View Specification panel. This error occurs when the database becomes empty after the function has accessed the database.

4. The Edit and Browse functions do not always correctly handle an IMSabend.

5. When a view with a selection criteria on the root segment is used to edit or browse an HDAM database, FM/IMS does not always display all the segments that satisfy the selection criteria.

6. Segment Update/Delete Warning popup displayed when another user hasn't updated or deleted the segment you were attempting to update or delete. The problem occurs when:

- Editing with a view and there is a selection criteria either on the segment you were attempting to update or on a parent of the segment you were attempting to update, and
- The selection criteria is on a segment with a nonunique key or no key and FM/IMS converts the selection criteria to a qualified SSA that does not specify key fields.

7. When multiple line commands are entered on the Edit or Browse data panel, FM/IMS does not validate them all before processing them.

8. If the FIND...ALL command is issued when the scope is DBREC and the top of window line is displayed, the editor scrolls down one line.
9. A CHANGE...ALL command issued when the scope is DBREC does not change an occurrence of the search string in the current database record and after the command is executed the editor displays a different database record.
10. A FIND...ALL command issued when the first occurrence of the search string is on the current page scrolls the data. The editor should only scroll when the first occurrence of the search string is not on the current page.
11. A FIND...ALL command issued when the first occurrence of the search string is before the start of the current page does not always display the target string at the top of the page.
12. An RFIND command issued after a FIND...REC command searches for strings outside of the search range when you place the cursor outside of the search range.
13. An RFIND command issued after a FIND...ALL command doesn't wrap to the top of the search range after the bottom of the search range has been reached.
14. A FIND...NOREC...FIRST command issued when the scope is DBREC does not find the first occurrence of the search string in the database.
15. The FIND...REC command and the FIND...CHILD command highlight occurrences of strings that are outside the search range.
16. The FIND...SEGMENT(segment-name) command highlights strings in all segments.
17. An RFIND command issued after a FIND...CHILD command issues message 'Segment has no dependents' when you place the cursor outside of the search range.
18. An RFIND command issued after a FIND...CHILD command wraps to the start of the database (rather than to the start of the search range) when the bottom of the search range has been reached.
19. If you:
 - Issue a FIND...CHILD command, then
 - Scroll the occurrence of the search string that is found to the top of the page, then
 - Issue RFIND commands
 the RFIND command does not wrap when it reaches the bottom of the range. It issues the message 'No chars found' instead.
20. Message "DFS0929I BLDL FAILED" and IMS U929 abend PFM1634 in the Edit or Browse dialog when you return to the Database Data Set Specification panel and then go forward in the dialog again.
21. Key Specification panel displays garbage data in key value field when a segment has no key. When a segment has no key, the panel should not display a line for the segment.
22. Garbage data displayed and some Cmd and Key Value fields missing after issuing the HEX ON or HEX OFF command on the Database Positioning panel.

23. On the IMS data panel, fields of segments that IMS does not allow you to update should:

- Be highlighted,
- Be protected when in SNGL or TABL display format, and
- Not be translated to uppercase when the user has CAPS ON.

But FM/IMS does not highlight or protect the key field of the destination parent in a concatenated segment and when the user has CAPS ON, it translates the characters in this field to uppercase, which causes the REPL call to fail with a status code of DA.

FM/IMS IEB (IMS Edit Batch):

24. A DELIMS, REPLIMS or ISRTIMS call without a WHERE clause issues message 'IMS error occurred for the function GET HOLD Status code=GE' and receives a return code of 8 when there is a PRINT call between the preceding GETIMS call and the failing update call. The error occurs when the concatenated key of the segment that the PRINT call prints has unprintable characters.

25. A GETIMS call with the NEXT parameter and a WHERE clause should retrieve the next segment in the database that satisfies the WHERE clause. But it retrieves the first segment in the database that satisfies the WHERE clause.

26. A REPLIMS/DELIMS call with a WHERE clause replaces/deletes the first segment in the database that satisfies the WHERE clause. But the call doesn't allow you to replace/delete the next segment in the database that satisfies the WHERE clause.

27. A REPLIMS/DELIMS call without a WHERE clause should replace/delete the segment that the preceding GETIMS call retrieved. But when this segment or one of its parents has a nonunique key or no key, the REPLIMS/DELIMS call may replace/delete the wrong segment.

28. If you position on the parent of the segment that you want to insert and then issue an ISRTIMS call without a WHERE clause, the segment should be inserted under this parent. But when the parent or one of its parents has a nonunique key or no key, the ISRTIMS call may insert the segment under the wrong parent.

29. A GETIMS call with the ROOT parameter should retrieve the root segment that the current segment is under. But when the root segment has no key, the GETIMS call retrieves the first root segment in the database. When the root segment has a nonunique key, the GETIMS call retrieves the first root segment with the same root key as the current segment.

30. A GETIMS call with the TOP and the USING_VIEW parameters may retrieve the first root segment in the database even when the root segment is not included in the view. This call should retrieve the first segment in the database that is in the view.

31. An ISRTIMS call without a SET clause should obtain the data for the new segment from the OUTREC variable. But when the ISRTIMS call has a WHERE clause, it may obtain the data from the first segment in the database that satisfies the WHERE clause.

32. A REPLIMS call without a SET clause should replace the segment in the database with the data in the OUTREC variable. But when the REPLIMS call has a WHERE clause, it may not modify the I/O area before it executes the DL/I REPL call.

Outline of solution

File Manager has been modified to correct all the listed defects.

2. FM/IMS has been modified to generate a different qualified SSA that will retrieve all the root segments that satisfy the selection criteria. Please note, however, that for this qualified SSA to retrieve the required segments, you also need to apply APAR PK22138 (UK14330) to IMS V9 or APAR PK24421(UKxxxxx) to IMS V8. Without these IMS fixes, the qualified SSA still won't retrieve all the root segments that satisfy the selection criteria.

3. FM/IMS Edit and Browse functions have been modified to check whether the database is empty immediately prior to the display of the Database Positioning panel. The empty database check has been integrated with the unavailable partition/area check and some other Database Positioning calls to make it more reliable and to reduce the number of IMS calls. When in Edit, FM/IMS no longer checks whether the database is empty when the database is first accessed. It now checks immediately prior to the display of the Database Positioning panel. If it is empty, FM/IMS bypasses the display of the Database Positioning panel.

When in Browse, FM/IMS now only performs the initial empty database check when the Use view option on the Browse Entry panel is selected. When this option is not selected, this check is not required because, as with Edit, FM/IMS now checks whether the database is empty immediately prior to the display of the Database Positioning panel. If either of these checks find that the database is empty, FM/IMS returns the user to the Browse Entry panel.

The FM/IMS IEB function has been modified as follows: 24. The PRINT call has been modified to use a copy of the concatenated key.

25. You may now specify either the NEXT parameter or the FIRST parameter on a GETIMS call with a WHERE clause. With the NEXT parameter, the call retrieves the next segment in the database that satisfies the WHERE clause. With the FIRST parameter, the call retrieves the first segment in the database that satisfies the WHERE clause. The default has been changed to NEXT.

26. You may now specify either the NEXT parameter or the FIRST parameter on a REPLIMS/DELIMS call with a WHERE clause. With the NEXT parameter, the call replaces/deletes the next segment in the database that satisfies the WHERE clause. With the FIRST parameter, the call replaces/deletes the first segment in the database that satisfies the WHERE clause. The default has been changed to NEXT.

Please note that with modifications 25 and 26, existing EXECs may behave differently. But by adding the FIRST parameter to all GETIMS, REPLIMS and DELIMS calls with a WHERE clause, you can preserve the behavior that they had prior to this APAR fix.

27. When the preceding GETIMS call has the USING_VIEW parameter, a REPLIMS/DELIMS call with no WHERE clause will replace/delete the segment that the GETIMS call retrieved (as it should). But when the preceding GETIMS call does not have the USING_VIEW parameter and the segment you are attempting to replace/delete or one of its parents has a nonunique key or no key, you will be required to add the new HOLD parameter to the GETIMS call (see 35 below). IEB will let you know if this parameter is required.

28. If you position on the parent of the segment that you want to insert and then issue an ISRTIMS call without a WHERE clause, the segment will be inserted under this parent.

29. A GETIMS call with the ROOT parameter and the USING_VIEW parameter will retrieve the root segment that the current segment is under (as it should). But when a GETIMS call with the ROOT parameter does not have the USING_VIEW parameter and the root segment has a nonunique key or no key, the GETIMS call will issue a diagnostic and the EXEC will be terminated.

30. A GETIMS call with the TOP and the USING_VIEW parameters will retrieve the first segment in the database that is in the view.

31. An ISRTIMS call without a SET clause will obtain the data for the new segment from the OUTREC variable.

32. A REPLIMS call without a SET clause will replace the segment in the database with the data from the OUTREC variable.

33. The dynamic PSB that is generated for the IEB function will have one database PCB. Before this APAR fix, the dynamic PSB had two database PCBs -- a read PCB that the GETIMS call used and an update PCB that the REPLIMS, DELIMS and ISRTIMS calls used.

34. The GETIMS, REPLIMS, DELIMS and ISRTIMS calls all use the same PCB.

35. You may now specify the HOLD parameter on a GETIMS call that does not have the USING_VIEW parameter. A GETIMS with a HOLD parameter will retrieve the segment with a hold. Although in most cases it is not required, if you add a HOLD parameter to each GETIMS call that precedes a REPLIMS or DELIMS call your EXEC will execute less DL/I calls and run more efficiently.

36. When a GETIMS call with a HOLD parameter precedes a REPLIMS/DELIMS call without a WHERE clause, the REPLIMS/DELIMS call skips the GET HOLD DL/I call that, previously, it always executed.

37. An ISRTIMS call with no WHERE clause will only reposition on the current segment when the previous IMS call was a GETIMS call with a USING_VIEW parameter. In all other cases, repositioning before the insert is no longer required because all the calls now use the same PCB.

Please note that with modifications 27 through 37, existing EXECs may behave differently.

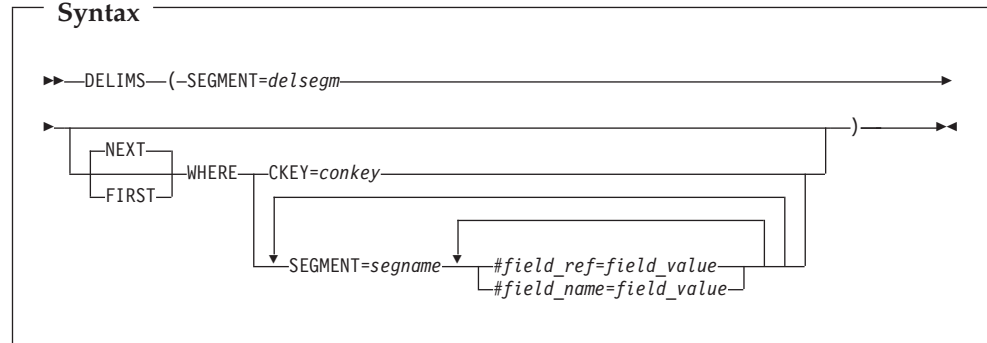

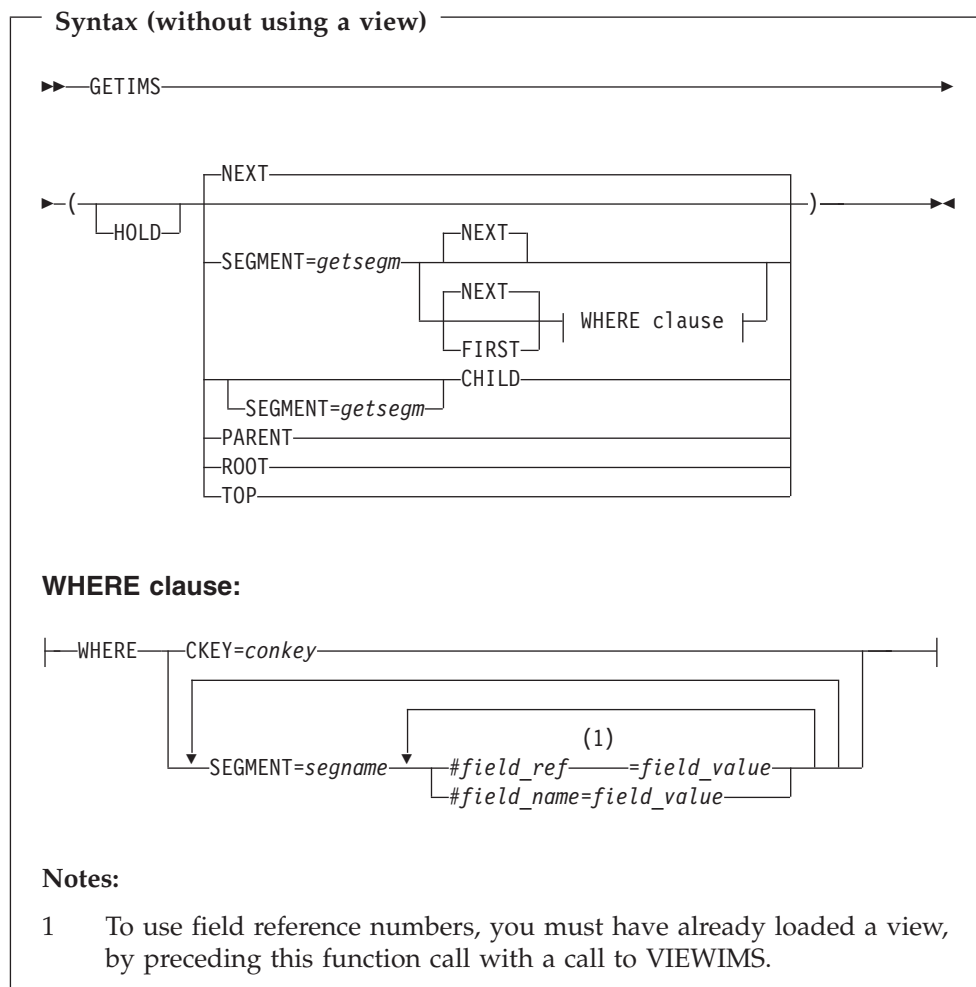
- After the description for the parameter, **delsegm**, add:

NEXT Deletes the next segment in the database after the current segment that satisfies the WHERE clause.

FIRST Deletes the first segment in the database that satisfies the WHERE clause.

In the section, "GETIMS (Retrieve an IMS segment)":

- Replace the syntax (without using a view) diagram with the following:



- Add the following to the list of parameters that follows the above syntax diagram:

HOLD

Retrieves the segment with a hold. Code this parameter when the GETIMS call is followed by a REPLIMS call without a WHERE clause, or a DELIMS call without a WHERE clause.

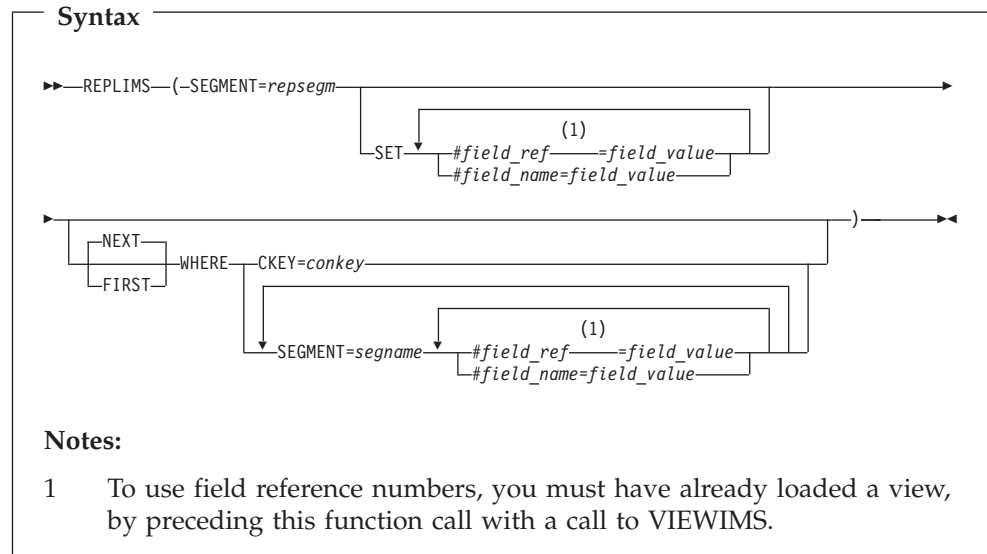
If the segment or one of its parents has a nonunique key or no key, this parameter is mandatory. Without it, the REPLIMS call or DELIMS call fails. The REPLIMS call or DELIMS call will not fail if the segment and its parents have unique keys but, if you do code it, your EXEC executes less DL/I calls and runs more efficiently.

- After the description for the parameter NEXT, add:

FIRST Retrieves the first segment in the database that satisfies the WHERE clause.

In the section, "REPLIMS (Update an IMS segment)":

- Replace the syntax diagram with the following:



- After the description for the parameter repsegm, add:
 - NEXT** Replaces the next segment in the database after the current segment that satisfies the WHERE clause.
 - FIRST** Replaces the first segment in the database that satisfies the WHERE clause.

SBPXTENU concatenated to ISPTLIB DDname

If you do not have these libraries available, you may get 'panel not found' errors when you invoke 8.1 or 8.2.

• Chapter 4, "Customizing the File Manager security environment"

In the section: "Controlling access to File Manager functions with SAF" replace the opening sentence and two bullet points with the following new paragraphs and box.

SAF controls access to File Manager functions as follows:

- If access to the profile FACILITY(FILEM.FUNCTION.*fc*) in the FACILITY class is defined (where *fc* is the function code), this controls access to the function.
- If access to the profile FACILITY(FILEM.FUNCTION.*fc*) in the FACILITY class is not defined, the profile name shown in the table "File Manager function to profile name cross-reference" (in the form FILEM.*group.name*) is used.
- If no profile name as shown in the table "File Manager function to profile name cross-reference" is defined, then FILEM.OTHER.ALL is used. If this does not permit access then access is denied.

Some File Manager functions are protected, by default, by the FILEM.OTHER.ALL profile. These functions are listed in the table "File Manager functions protected by FILEM.OTHER.ALL".

Important information for users of non-IBM security products

File Manager issues a RACROUTE TYPE=AUTH for the required profile, and if the required profile is not defined, RACF returns RC=4. If RC=4 is returned, File Manager issues a RACROUTE for FILEM.OTHER.ALL. If a higher return code is returned, no RACROUTE is issued for FILEM.OTHER.ALL and the access request fails immediately.

You should be aware that not all non-IBM security products issue RC=4 when a RACROUTE TYPE=AUTH for a profile fails; in this case no RACROUTE is issued for FILEM.OTHER.ALL and the access request fails immediately. If this applies to your security product, you will have to provide individual profiles for all File Manager functions listed in the table "File Manager functions protected by FILEM.OTHER.ALL".

• **Chapter 4, "Customizing the File Manager security environment"**

Replace the section: "Unprotected functions and profile names for protected functions", including all text and the two tables, with the following new text, and three tables.

Table 1, Table 2 on page 43, and Table 3 on page 44, show File Manager functions with their descriptions and (where applicable) the equivalent File Manager panel you can use under ISPF.

Table 1 lists the functions that cannot be protected by RACF or an equivalent security product, or by the FMNSECUR exit. Functions not listed in Table 1 are protected, and Table 3 shows the profile name used in the FACILITY class to protect a specific function.

All protected functions not listed in Table 3 are protected by the FILEM.OTHER.ALL profile.

In particular, the File Manager functions listed in Table 2 are protected by default when you receive File Manager. They are protected by the profile "FILEM.OTHER.ALL", and if you want to use these functions, you must first give the users access to these functions, by defining the profile "FILEM.OTHER.ALL" to RACF or your equivalent security product.

For information on File Manager profiles, and defining them to your security product, refer to the section "Setting up the security environment by using RACF or an equivalent security product" in chapter 4 of the File Manager Customization Guide. In particular, if you use a non-IBM security product, see the warning in "Important information for users of non-IBM security products".

Note: In Table 3, where more than one function code is listed for the same function, and the first function code is in **bold** letters, you should use this function code when defining the relevant function profile.

- **Chapter 19, "Customizing the File Manager/IMS security environment"**

In the final section: "Protected functions in File Manager/IMS" replace the first paragraph with the following new paragraphs and box. (The table remains the same.)

The File Manager/IMS functions listed in the table "File Manager/IMS protected functions" are protected by default when you receive File Manager/IMS. They are protected by the profile "FILEM.OTHER.ALL", and if you want to use these functions, you must first give the users access to these functions, by defining the profile "FILEM.OTHER.ALL" to RACF or your equivalent security product. For information on File Manager profiles, and defining them to your security product, refer to chapter 4 of the File Manager Customization Guide.

Important information for users of non-IBM security products

File Manager issues a RACROUTE TYPE=AUTH for the required profile, and if the required profile is not defined, RACF returns RC=4. If RC=4 is returned, File Manager issues a RACROUTE for FILEM.OTHER.ALL. If a higher return code is returned, no RACROUTE is issued for FILEM.OTHER.ALL and the access request fails immediately.

Functions described as **(batch)** are only available in batch processing.

Add the following section to Chapter 12, "Customizing File Manager/DB2", after the section "Binding DB2 (required)":

Running multiple versions of File Manager/DB2

If you intend to install multiple (different) versions of File Manager/DB2, you need to ensure that each File Manager/DB2 installation is **COMPLETELY INDEPENDENT** of the other(s).

In particular, you must ensure that:

- Different (and unique) plan and package names are used for each File Manager/DB2 installation.
- The File Manager/DB2 plan and packages are bound using the appropriate DBRM modules for each version of File Manager/DB2.
- Each version of File Manager/DB2 uses a unique FMN2POPT module, and that module must specify the correct plan name for that version of File Manager/DB2.
- When File Manager/DB2 is used to access remote DB2 systems, the plan and packages for each File Manager/DB2 version must be bound on every DB2 system that might be accessed using File Manager/DB2.

The notes below cover the situation where an existing version (say version n) of File Manager/DB2 is installed. A new version (say n+1) of File Manager/DB2 is available and will be installed. The two versions of File Manager/DB2 are to be run concurrently while acceptance testing is completed for the new version of File Manager/DB2.

The default plan names are used for the existing version of File Manager/DB2 that is already installed:

- FMN2PLAN
- FMN2GEN

Similarly, the default package names are used for the existing version of File Manager/DB2 that is already installed:

- FMN2PLPK
- FMN2GNPK

For the new version of File Manager/DB2, select new plan and package names, for example:

- FMN2PLNA (instead of FMN2PLAN)
- FMN2GENA (instead of FMN2GEN)
- FMN2PLPA (instead of FMN2PLPK)
- FMN2GNPA (instead of FMN2GNPK)

Note that any new plan/package names can be selected, as long as the new names are different to all other File Manager/DB2 plan/package names already in use.

For the new version of File Manager/DB2, modify the sample FMN2BIND job to specify the amended plan and package names, as shown above. Run the FMN2BIND job on every DB2 system that the new version of File Manager/DB2 will have access to, either via direct or remote connection. Ensure that the DBRM library specified in the new bind job is for the new version of File Manager/DB2.

Modify the sample FMN2POPT job for the new version of File Manager/DB2. Specify the new plan names in the FMN2SSDM macro definition for each DB2 system that File Manager/DB2 will access, either directly or remotely, as shown below:

```
FMN2SSDM  SSID=XXXX,PLAN=FMN2PLNA,PLAN2=FMN2GENA
```

Assemble the new FMN2POPT module, and ensure that is available when a user executes the new version of File Manager/DB2.

Chapter 7, "Customizing File Manager to use library management system libraries"

Completely replace the sections in this chapter, from the start, up to "Capabilities provided by File Manager via FMNCRAEX", with the following:

File Manager provides the facility to allow you to access source code stored in either library management (LM) or source code management (SCM) systems.

The difference between library management systems and source code management systems is not well defined, but in general, SCM systems tend to provide software packaging, version management of packages, and build management in addition to the typical LM functions. LM systems tend to be simpler and focus on efficiently storing data (files) in a library and managing versions or levels of the individual files. An example of a library management system is CA-Panvalet. An example of a source code management system is IBM's SCLM.

In this chapter both LMs and SCMs are referred to as library management systems or LMSs.

There are three possible scenarios to accessing source code in LMSs:

- the LMS is CA-Panvalet.
- the LMS (not CA-Panvalet) provides a SUBSYS interface.
- the LMS (not CA-Panvalet) does not provide a SUBSYS interface.

If you want to use File Manager to access COBOL copybooks and PL/I include books stored in LMS libraries, the customization tasks you must perform are different, depending on which of the above scenarios applies to your LMS. The possible customization tasks are listed in Table 4. Perform only the tasks that apply to your LMS.

Table 4. Summary of steps for customizing File Manager to use LMS libraries

Step	Description
__ 1	Determine if your LMS provides a SUBSYS interface.
__ 2	Set the LMS and LMSUBSYS options, as necessary.
__ 3	Ensure that the correct release of Language Environment is available to File Manager.
__ 4	Determine if your LMS requires your exit to run below the 16MB line.
__ 5	Write your own File Manager exit and link edit it into a load library available to File Manager, as load module FMNCRAEX.

Accessing source code in CA-Panvalet libraries:

File Manager provides an interface to CA-Panvalet, enabling you to use File Manager to work with COBOL copybooks and PL/I include books stored in CA-Panvalet libraries. Before you can do this, you must change the default options to specify one of:

- **LMS=PANVALET**

Running multiple versions of File Manager/DB2

- LMS=(USERLMS,PANVALET)
- LMS=(PANVALET,USERLMS)

If you want to access only CA-Panvalet libraries, specify **LMS=PANVALET**.

For information about the LMS option, see Appendix A. For more information on how to change the default options, see "Changing the default options", in chapter 3.

If you do not change the LMS option to one of the above values, you will receive an error message if you attempt to access copybooks in a CA-Panvalet library.

Notes:

1. This support is provided for CA-Panvalet release 14 and above.
2. Ensure that your CA-Panvalet library is defined with DSORG=DA.

Accessing source code in an LMS with a SUBSYS interface

If your LMS provides a SUBSYS interface, you need to perform tasks #2 and #3 from Table 4 on page 47, as described here.

- Set the LMSUBSYS option to the value for the SUBSYS interface provided by your LMS vendor, (for example, LMSUBSYS=LAM).
- Ensure that the LMS option is set to NO.
- Ensure Language Environment is available to File Manager, if you have not already done so.

You can do this by one of the following methods:

- Add the Language Environment runtime library, SCEERUN, to your concatenated LINKLIST.
- Place SCEERUN in the STEPLIB DD statement of the logon proc.
- Your users can use the TSO command, TSOLIB, to add SCEERUN to the search list.

Note: You cannot access source code from an LMS with a SUBSYS interface and also from CA-Panvalet. The two are mutually exclusive.

Accessing source code in an LMS without a SUBSYS interface

If your LMS does not provide a SUBSYS interface, you need to perform tasks #2, #3, #4, and #5, from Table 4 on page 47, as described here.

- Set the LMSUBSYS option to a blank (the IBM-supplied default in FMN0POPT.)
- Set the LMS option to USERLMS.
- Ensure Language Environment is available to File Manager, if you have not already done so.

You can do this by one of the following methods:

- Add the Language Environment runtime library, SCEERUN, to your concatenated LINKLIST.
- Place SCEERUN in the STEPLIB DD statement of the logon proc.
- Your users can use the TSO command, TSOLIB, to add SCEERUN to the search list.
- Code and link your own user exit, a load module named FMNCRAEX, into the File Manager load library. If you have installed File Manager in the default libraries this will be FMN.SFMNMOD1. You can access source code in multiple LMSs through a single FMNCRAEX exit.

If you are using an LMS without a SUBSYS interface, you cannot run File Manager APF-authorized.

Sample user code for FMNCRAEX, written in COBOL, is distributed in the File Manager sample library, FMN.SFMNSAM1. The following sections discuss the functions and requirements for FMNCRAEX. Appendix D, discusses the sample exit itself.

Appendix A, File Manager options

LMS option

Replace the description of the LMS option with the following:

LMS	Specifies whether or not File Manager will use COBOL copybooks or PL/I include books stored in CA-Panvalet libraries or other Library Management System libraries.
NO	File Manager will not use any library management system libraries.
PANVALET	File Manager will use COBOL copybooks or PL/I include books stored in CA-Panvalet libraries.
USERLMS	File Manager will use COBOL copybooks or PL/I include books stored in a library management system, other than CA-Panvalet, that does not provide a SUBSYS interface.
(PANVALET,USERLMS) or (USERLMS,PANVALET)	File Manager can use COBOL copybooks or PL/I include books stored in CA-Panvalet together with any other library management system that does not provide a SUBSYS interface. (PANVALET,USERLMS) and (USERLMS,PANVALET) are equivalent.

Note: You cannot specify LMS=PANVALET together with LMSUBSYS=xxxx, since you cannot access source from CA-Panvalet together with source from an LMS that provides a SUBSYS interface.

LMSUBSYS option

Replace the description of the LMSUBSYS option with the following:

LMSUBSYS

specifies that File Manager will, when accessing COBOL copybooks or PL/I include books, attempt the access via an I/O subsystem using the DFSMSdfp SUBSYS=xxxx allocation parameter.

This access is only available to copybooks and include books that exist in data sets controlled by the LMS. Data set organizations of BDAM, VSAM, and PS (sequential) are supported.

This facility is used to access COBOL copybooks or PL/I include books in OEM library management system data sets.

Specify *xxxx* as provided by your library management system vendor.
