This document provides an overview of the IBM<sup>(R)</sup> WebSphere<sup>(R)</sup> Partner Gateway product family and, in more detail, the WebSphere Partner Gateway Enterprise and Advanced Editions.

In version 6.0.0.1 of Partner Gateway, support has been added for using WebSphere Process Server as the backend integration system.

#### New in release 6.0

This section highlights the changes to Partner Gateway for version 6.0:

- WebSphere Business Integration Connect has been renamed WebSphere Partner Gateway.
- Enhanced EDI document processing capabilities, provided by the Data Interchange Services feature, expand on the passthrough processing offered in previous releases. New support includes:
  - Enveloping, de-enveloping and splitting provide the ability to handle or generate EDI interchanges with multiple heterogeneous documents as well as input files with multiple heterogeneous interchanges.
  - Extensive validation and functional acknowledgments support.
  - Robust, any-to-any mapping capability for EDI, XML, and record oriented data (both fixed length fields and comma-separated values) using the Data Interchange Services client. This graphical user interface includes a drag-and-drop mapper with extensive on-line help, a library of built in functions for string handling, date manipulation, arithmetic operations, and the ability to combine maps.
  - Enhancements to the Community Console for:
    - Configuring Partner Gateway to receive, process, and send EDI documents.
    - Importing transformation and validation maps from the Data Interchange Services client graphical user interface.
    - Viewing EDI document content and transaction details.
    - Trading-partner-level control: all aspects of transformation, validation and acknowledgment can now be controlled at the individual trading partner level.
- Extended transport and business protocol support:
  - Added FTP Scripting transport support for the Receiver and Gateway.
  - Additional Receiver transport handlers added for splitting files containing multiple EDI Interchanges, SML and Record Oriented Data (ROD) documents.
  - Support for additional RosettaNet PIPs.
- Enhancements for reliability, availability, and serviceability:
  - Ability to copy a document to the file system.
  - Full message repository support including the ability to view status and images of interchanges sent or received and drill down to the individual documents within the interchanges to see their functional acknowledgment status.
  - Added ability to re-send documents that have been sent successfully or unsuccessfully.
  - New support for handling multiple leaf or root certificates prevents outages when certificates expire or are revoked.

  - A utility is available for archiving the non-repudiation data store.

## **Chapter 1. Product introduction**

WebSphere Partner Gateway enables the establishment and maintenance of a business-to-business (B2B) trading community for secure, automated, cost-effective exchange of business documents between companies and their suppliers.

Partner Gateway is fully scalable and designed to support the diverse protocol, document-processing, and security requirements of large and small companies alike. Using back-end systems such as WebSphere Process Server, WebSphere InterChange Server or WebSphere Business Integration Message Broker, companies can seamlessly integrate the information received from trading partners with their business-critical applications . A Web-based graphical user interface makes it easy to enable and manage trading partner interactions, and to administer the trading community.

## Overview of a trading community




Figure 1. A trading community consisting of a Community Manager and community participants.

A trading community typically revolves around a hub—an enterprise that acts as the Community Manager. Businesses of various sizes, known as community participants, connect to the hub through the Internet. In addition, participants themselves can act as a hub. Figure 1 on page 2 illustrates a trading community consisting of a Community Manager and a set of participants.

Partner Gateway provides a solution for each type of participant in the trading community.

- WebSphere Partner Gateway Enterprise Edition is ideal for the larger enterprise that wants to connect to an unlimited number of trading partners using a variety of transports and message formats. This enterprise acts as the Community Manager, establishing the community, getting partners on board, and monitoring the activity of all participants in the community.
- WebSphere Partner Gateway Advanced Edition is suited to the customer who
  wants the flexibility of transport and message formats but has a more limited
  number of trading partners. This type of enterprise can act as a Community
  Manager (of its own smaller community) as well as a community participant in
  a larger community. The right side of the previous illustration shows an example
  of a client who is both a community participant (to the Community Manager) as
  well as a hub to its own community.
- WebSphere Partner Gateway Express is designed for small to medium-sized businesses that want to integrate with a very small number of partners using a limited protocol support as quickly, simply and affordably as possible. Typically, the Express customer connects to a trading community operated by a large and important trading partner at that partner's request.

The remainder of this document focuses on Partner Gateway Enterprise and Advanced Editions. For information on Partner Gateway - Express, refer to the InfoCenter for WebSphere Partner Gateway - Express.

## Benefits of a trading community

The benefits of participating in a trading community and exchanging business documents electronically include the reduction in cost associated with a traditional, paper-based exchange as well as a reduction in the number of errors inherent in such an exchange. After all, critical transactions involving purchase orders, invoices, shipping notices, and other documents drive your business. The ability to participate in a trading community to exchange this information efficiently and securely is essential to success.

Partner Gateway provides benefits to all types of participants in a trading community. For the Community Manager, it provides real-time visibility into the entire supply chain, which helps improve data accuracy and decrease cycle times. Community participants who use Partner Gateway - Express can join the trading community with minimal cost and effort.

Additional benefits of a Partner Gateway trading community include scalability, ease of use, and flexibility.

## Scalability

Partner Gateway is scalable. For example, an enterprise acting as the Community Manager can easily add additional servers to accommodate growth in the size of the trading community. See "System configuration options" on page 21 for additional details.

The Partner Gateway - Express customer can upgrade to Enterprise or Advanced Edition should the enterprise require more sophisticated functionality or enterprise-level trading volume. For example, customers who must support additional document formats or who want to connect to additional community participants can install the Advanced Edition.

#### Ease of use

Ease of use is essential to the successful deployment and maintenance of a trading community. The tasks involved in planning, setting up, and running a trading community can be performed either by the enterprise itself or by an IBM Community Integration Services team. See your IBM representative for information about these services.

Joining a trading community is easy. The community participant provides some basic information (such as the types of protocols it can support) to the Community Manager. The Community Manager uses this information to define a connection between the hub and the participant. After these steps are completed, the participant is ready to send test documents.

Once defined to the community, participants can administer their own profiles and monitor the flow of their own documents, subject to the level of authorization defined by the Community Manager.

For community participants using Partner Gateway - Express or another connectivity tool, joining a trading community is equally simple.

## **Flexibility**

Another key requirement for a trading community is the ability to handle diverse transports, protocols, and document formats. Partner Gateway supports a wide

range of industry-standard transport and business protocols, while also providing superior customization options for tailoring document-handling and workflow to the specific needs of your enterprise.

For example, you might exchange purchase orders with a subset of your trading partners through RosettaNet PIPs. With other trading partners, you might have an agreement to exchange EDI-formatted documents. You can accommodate both types of participants in your trading community.

Similarly, you can use Partner Gateway to make a Web service available to your community participants. You can also access the Web services of your community participants. Partner Gateway acts as a SOAP proxy.

You can exchange a wide variety of documents with community participants, using industry-standard business protocols such as RosettaNet, AS1, AS2, SOAP, cXML, XML, EDI, and binary over a variety of transports:

- The HTTP or HTTPS transport protocols can be used by all types of documents (except for binary documents with no associated packaging sent from a community participant).
- The FTP or secure FTP transport protocol can be used for EDI, XML, and binary documents that do not have packaging associated with them.
- An FTP-script-based transport protocal can be used to send and receive EDI documents over multiple types of value-added (VAN) and non-value-added networks, such as General Electric Information Services (GEIS).
- The SMTP transport protocol can be used for EDI, XML, and binary documents that conform to the AS1 protocol
- The JMS transport protocol can be used for XML, EDI or binary documents.
- File directory can be used for XML or EDI documents.

Depending on the transport protocol, Partner Gateway supports either synchronous or asynchronous business document exchange, or both. The HTTP and HTTPS transport portocols both support synchronous and asynchronous document exchanges. For AS2, cXML, RNIF, or SOAP documents that will be used in synchronous exchanges, you must specify the associated SyncCheck handler on the HTTP or HTTPS target. Asynchronous document transfer is supported in other transport protocols such as File System, FTP, SMTP, etcetera.

You have a variety of choices for how the documents are processed--everything from passthrough routing to translation into custom XML.

If the transports, business protocols, and processing options offered by Partner Gateway do not meet your requirements, you can customize document-handling and workflow with user exits. User exits are breaks in the natural process flow designed to permit developers to insert customized processing. Through the use of user exits, you can send and receive documents using customized protocols and seamlessly invoke customized packing, unpacking, validation, translation, and transformation routines. User exits can be used to extend or modify an existing document-handling function or to create entirely new ones.

For communication with your back-end systems, you can exchange RosettaNet Service Content (RNSC), SOAP, cXML, XML, EDI, and binary documents over a variety of transport protocols:

- The HTTP or HTTPS transport protocols can be used by all types of documents (except for binary documents with no associated packaging send from the back-end system). Note that SOAP and cMXL documents can use synchronous communication.
- The JMS transport protocol can be used for RNSC, XML, EDI, and binary documents.
- File-based transfer can be used for XML or EDI documents that have no packaging associated with them.

Partner Gateway supports multiple security standards including third-party certificate authorities from VeriSign and Thawte, SSL support, and Non-Repudiation as required for full AS2 compliance.

## **Partner Gateway components**

The three major runtime components of Partner Gateway are the Receiver, Document Manager, and Community Console. A brief overview of these components is provided in the following sections. For more detailed information and for a description of prerequisite and related software, see Chapter 3, "Key concepts and technical overview," on page 11.

#### Receiver

Documents sent by community participants enter the system through the Receiver. The Receiver stores the documents in a file system for the Document Manager to process.




Figure 2. A document from a participant flows to a back-end system through the Receiver and Document Manager

In Figure 2, a document intended for processing by a back-end system, such as WebSphere Process Server, InterChange Server (ICS) or WebSphere Business Integration Message Broker, is sent from a community participant to the Receiver.




Figure 3. A document from a back-end system flows to a participant through the Receiver and Document Manager

Documents sent from the Community Manager to community participants reverse the process. The back-end system sends the outgoing document to a directory or through the HTTP, HTTPS, or JMS transport protocol to a Receiver set up for the directory or protocol type. The Document Manager detects the document and routes it to the community participant. In Figure 3, a document from a back-end system such as Interchange Server is received by the participant.

### **Document Manager**

The Document Manager polls the file system for documents, performs any user-configured processing, and then delivers the document to its final destination as shown in Figure 3.

Subsystems of the Document Manager also decrypt the document (if required), perform digital signature verification (if required), perform XML, EDI, ROD (record oriented data) transformation and validation (if required), and log entries about the processing of the document in the database repository.

## **Community Console**

The Community Console provides a Web-based graphical user interface for configuring and administering the trading community, and for monitoring the flow of documents and processes within the community. With the Community Console, you can manage and troubleshoot current or past event, document, and process activity.

For example, if you find that documents are repeatedly failing for the same reason or from the same source, you can use the Community Console to quickly identify and resolve the problem. The Community Console gives you access to detailed reports and analysis on business processes, trends, and exception activity.

The Community Console is available to both the enterprise running Partner Gateway as well as to all the participants in the trading community. The Community Manager has visibility to the entire community on a 24 x 7 basis. Participants can access the Community Console through a Web browser to get a real-time view of the documents, processes, and events that relate to their trading activities.

- If you are planning to use the Simple Mail Transport Protocol (SMTP) transport protocol, an SMTP -based e-mail relay server for e-mail alert delivery and SMTP message delivery.
- Dedicated servers are recommended for your database and for WebSphere MQ. Components of Partner Gateway Enterprise and Advanced Editions and prerequisite products can be installed on one server or can be split among multiple servers. However, the use of multiple servers is recommended for production to prevent resource constraints. For more information about Partner Gateway configurations, see "System configuration options" on page 21.

## Chapter 2. WebSphere product family overview

This chapter describes how WebSphere Partner Gateway fits into the WebSphere product family.

## **About WebSphere**

IBM WebSphere is the leading software platform for e-business. It includes more than 150 Internet infrastructure software or middleware products designed to help businesses become on demand e-businesses. The WebSphere product family features broad support for open standards. Its products include application servers, messaging software, business integration tools, portal creation tools, and integrated development environments for creating Web-based business applications.

The WebSphere platform can help you to:

- Accelerate the delivery of products and services.
- Respond quickly to market changes and customer demand.
- Integrate and automate business processes.
- Create portals to simplify access to information and applications.
- Reuse and leverage existing and legacy assets.

## **About WebSphere Partner Gateway**

WebSphere Partner Gateway is layered with other WebSphere products to build comprehensive, flexible business integration solutions. Partner Gateway's role is to enable enterprises and their trading partners to exchange business documents. Through the use of back-end systems such as WebSphere Process Server, WebSphere Business Integration Message Broker or WebSphere InterChange Server, business information contained in the exchanged documents is easily integrated with the business-critical applications on which companies depend.

## Chapter 3. Key concepts and technical overview

This chapter provides a brief technical overview of Partner Gateway, its main components, and its architecture.

It consists of the following topics:

- "WebSphere Partner Gateway architecture" gives an overview of the architecture of Partner Gateway and its major run-time components.
- "Summary of supported protocols" on page 16 lists the transport, messaging, and business protocols supported by Partner Gateway. Other protocols can be supported through customization.
- "Configuration requirements" on page 17 provides an overview of the Partner Gateway components you need to configure when you establish a trading community.
- "Integration with enterprise systems" on page 19 discusses the different options for integrating Partner Gateway with a back-end system.
- "Sample message flow" on page 20 describes the sequence of steps involved in a sample exchange of documents between a community participant and the Community Manager.
- "System configuration options" on page 21 discusses the different ways to configure Business Integration Connect for scalability, performance, and fail-over support.

## **WebSphere Partner Gateway architecture**

The runtime environment of Partner Gateway consists of the following components:

- The Receiver to handle secure and reliable receipt of documents over the supported transport protocols.
- The Community Console, a standard J2EE component that provides Community
  Console access to the Community Manager and to community participants. The
  Community Manager can view the entire community. Participants have a more
  limited view, which allows them to modify their profiles and monitor the flow
  of their documents.
- The Document Manager, consisting of one or more routing and processing servers, which implement the reliable routing, validation, and translation services within Partner Gateway. When validation is required, it is performed through the use of XML schemas. When translation is required, it can be performed through the use of transformation maps. If you are sending or receiving EDI interchanges (that will be de-enveloped into individual transactions) or XML or record-oriented data (ROD) documents, you will probably receive a transformation map from the Data Interchange Services client mapping specialist. The transformation map describes how to translate a document from one format to another format. Transformations can be performed among any combination of EDI transactions, XML documents, and ROD documents. For example, suppose you receive an EDI interchange that contains one transaction. After the interchange is de-enveloped, the transaction is transformed into an XML document before being delivered. The Hub Configuration Guide describes all possible document flows associated with EDI

interchanges and XML and ROD documents. Note that translation can also be performed through the use of XSLT-based transformations, optimized for performance.

- The queue manager and publish/subscribe broker, which routes messages and events to other components within the system and to external applications.
- A database to store trading partner profile information and state information about ongoing processes in Partner Gateway.
- Common storage, typically consisting of a large stand-alone storage device, where documents are stored during and after processing by Partner Gateway.




Figure 4. WebSphere Partner Gateway runtime components

Figure 4 shows how the components work together:

The sections that follow describe in more detail the runtime components as well as other key elements of WebSphere Partner Gateway.

#### Receiver

The Receiver component accepts documents from community participants and from back-end systems and stores them. Specifically, it:

- Receives a document over a supported transport protocol
- Writes the document and metadata relating to the document to shared file services.

Receivers are responsible for accepting the inbound document from a particular transport. The Receiver records any transport-specific data (for example, the source IP address and certificate information about the SSL connection) to the metadata file and completes any transport-specific technical acknowledgment (for example, sending a 200 response to an HTTP POST).

## **Document Manager**

The Document Manager retrieves stored data, processes it, and routes it, both to community participants and to enterprise systems. Specifically, it:

- 1. Reads the raw document and metadata and saves the inbound document to the non-repudiation directory on shared storage
- 2. Processes the data to the destination format (performing tasks such as validation and transformation, if specified) and saves the destination document to the non-repudiation directory on shared storage
- 3. Delivers data to its intended destination, which could be a JMS queue, a directory, or a URL.

The following sections describe how the subcomponents of the Document Manager perform the tasks presented in the previous list.

#### **Document Processing Engine**

The Document Processing Engine performs all of the processing of documents. The Document Processing Engine is responsible for:

- Unpacking documents
- Ensuring that the source of the document is authorized
- Filtering out duplicate documents
- Validating the structure and content of the document
- Translating the document into the format required by the destination
- Packaging the document for the destination, including digitally signing and encrypting the document, if needed
- Storing both the original inbound document and the final outbound document in the non-repudiation repository
- Passing the packaged document to the outbound transport engine

#### State Engine

The State Engine encapsulates the business rules on a per-protocol basis and executes instructions based on those rules (for example, initiating a retry when no acknowledgment has been received in the defined interval).

#### Alert Engine

The Alert Engine monitors activity and generates e-mail notifications. You can configure the Alert Engine to specify which alerts are generated, to whom the alerts are sent, and when the alerts are delivered.

#### **Delivery Manager**

The Delivery Manager component is responsible for transporting documents to specific destinations, maintaining a separate queue of documents for each destination. A dedicated transport mechanism exists for each destination, so problems delivering to one destination should not affect transport to other destinations.

## **Community Console**

The Community Console is a Web-based, J2EE application for configuring, administering, and monitoring trading community activities, and responding to events. Its users are primarily: the Community Operator, the Community Manager, and the community participant. The console provides role-based access control to the various features and views. The features of the console include:

- Screens for configuring the hub community and for managing participants.
- · Tools for monitoring business-process events and exceptions
- · Detailed reports and analysis on business process, trend, and exception activity
- Tools to troubleshoot document processing
- The ability to drill down to events and raw documents.

#### **Profile**

Partner profile information, which is largely read-only once the system is configured. Changes occur only when profiles are added or deleted, or when an existing profile is updated. See "Profile" on page 18 for more information.

#### Gateway

A gateway specifies the destination information needed for the Document Manager to send a document to the Community Manager or to another participant. See "Gateway" on page 18 for more information.

#### Participant connection

Connections define valid interactions between community participants, one of which is the Community Manager. They include information about the document protocol, document type, sending participant, receiving participant, connection type, and source and destination gateways. The Document Manager uses the information in the connection to determine if translation is required and to determine the destination gateway information. See "Participant connection" on page 19 for more information.

#### **Database**

A prerequisite DB2 Universal Database Enterprise or Oracle database is used as the data repository. It is used to store data that can be classified in two broad categories: profile information and state management information. The database stores partner profile information and event logs. A single document exchange results in the logging of many events to capture the state transitions of the document.

All information configured through the Community Console is stored in the database.

The data repository is also where guidelines and maps (for validation and translation) are stored, where the state of various processes is recorded, and where trading activity is tracked.

The information stored in the data repository is used by Partner Gateway to provide the administrator with visibility into the entire trading community.

The information stored in the data repository is used by Partner Gateway to provide the administrator with visibility into the entire trading community.

Note that some information (for example, the raw message data in the non-repudiation and message stores) is kept on the shared file system, as described in "File System" on page 16.

The database is used to store the following types of information.

#### Certificates and IP addresses

The following security information is stored:

- Certificate information used to certify the sending community participant based on the client certificate used during the SSL connection
- Certificates used for encryption and digital signature validation
- IP addresses used to confirm that the source IP address is correct and that documents can be posted from that address.

#### **Alerts configuration**

Alerts are defined at a participant level and consist of a variety of attributes to describe event-based alerts or volume alerts.

You can define event-based alerts so that they will be triggered each time the event occurs or so that they will batched, based on an interval. You can also configure the alert with a contact list for notification based on a defined schedule.

#### **Document activity**

Partner Gateway logs information to describe documents as they are routed. Details are logged about the document as it was received and as it was transmitted. The following types of information are logged:

- The format of the document, including the source participant, target participant, source protocol, target protocol, source document type, and target document type
- The format of the document, including the source participant, destination participant, source protocol, destination protocol, source document type, and destination document type
- Metrics that describe the size of the document and the time it was received and transmitted
- The state that is logged against a document, describing whether it was transmitted to the participant.

#### **Document events**

Partner Gateway uses events to track activities and logs the events in a central event log. The events, which are classified as Informational, Warning, or Critical Errors, can be generated by different components in Partner Gateway.

Events can be tied back to document activity when they are in relation to a document that was routed by Partner Gateway. The events can also track non-document related activities, such as logging into the system.

#### **Summary data**

Partner Gateway summarizes key metrics, which can be displayed in the console. The information that is summarized includes:

- The number of documents received, sent, and failed. These counts are summarized by certain attributes by hour.
- The number of events that were generated. These counts are summarized by certain detail attributes by hour.

These counts are rolled up by hour and can be correlated back to the document activity logs.

### File System

The following information is stored in the shared file system:

#### Non-Repudiation data repository

Documents are stored on a disk that has shared access from all components of Partner Gateway (Receiver, Console, and Document Manager). Both the original document (as it was received) and the final document (as it was sent) are stored.

#### Message data repository

Documents are stored in an unencrypted form for displaying to the console. This disk also has shared access from all components of Partner Gateway (Receiver, Console, and Document Manager).

## **Communication using JMS**

Communication between some components is done using JMS. JMS queues with reliable storage allow the flexibility of locating components on different machines while still maintaining a standard inter-component communication method.

## Summary of supported protocols

Partner Gateway includes built-in support for the following transport, messaging, and business protocols. However, with customization, Partner Gateway can support virtually any customer-required protocol.

- Transport protocols: documents can be exchanged with participants over any of the following transports:
  - HTTP or HTTPS
  - FTP or FTPS
  - FTP scripting
  - JMS
  - SMTP
  - File-directory-based
- Business protocols:
  - AS1 and AS2
  - RosettaNet 1.1 and 2.0
  - SOAP (Web services)
  - cXML
- Data types:
  - EDI X12 and EDIFACT
  - XML

- Custom XML.
- Flat files.

The following illustration shows the numerous supported transports for integrating trading participants with Partner Gateway, and Partner Gateway with a back-end system such as WebSphere Process Server, WebSphere InterChange Server, or WebSphere Business Integration Message Broker.




Figure 5. Supported transports for integrating trading participants with Partner Gateway, and Partner Gateway with a back-end system.

## **Configuration requirements**

The configuration process define the particular transports, messaging protocols, and business protocols the trading community will support. It also defines the trading community participants, as well as the specific types of documents and protocols valid for each participant to send and receive. To make configuration easier, Partner Gateway comes with predefined configuration elements for all of the industry-standard protocols and formats it supports.

The following elements need to be configured. For detailed configuration information, see the *Hub Configuration Guide*.

## **Target**

A target is an entry point into Partner Gateway. It is an instance of a receiver configured for a particular deployment. You may have multiple targets configured from one receiver. For example, you may configure multiple JMS targets using the JMS receiver. Each JMS target can be configured to poll for inbound documents on separate inbound queues. Each target's configuration specifies which inbound queue the target polls.

A target listens or polls for new documents to be processed by Partner Gateway. For example, it can poll a folder on the file system, a JMS queue, or listen on an HTTP URL for incoming documents from business partners or from a back-end system. A target is used for both inbound and outbound flows. Inbound are coming into Parterner Gateway and outbound are leaving Partner Gateway.

### **Gateway**

A gateway is an exit point out of Partner Gateway. It is used by Partner Gateway to deliver documents to a back-end system or a trading partner. For example, when sending a document to a partner, your WebSphere Partner Gateway server needs a gateway that points to a URL configured on your partner's server. In this case, the gateway points to a remote target on the partner's server. However, a gateway can also point to a resource in an internal network, such as a JMS queue configured as the input queue for WebSphere Business Integration Message Broker.

A gateway is defined by a *gateway definition*, which includes a destination URI, optional login information, and transport-level settings for the gateway.

#### **Profile**

A profile is required for each trading community participant. The profile holds participant data, routing information, and console-access authorizations. The participant profile consists of partner information, configuration data for document routing, and console access authorizations. The profile includes information such as:

- · Partner data
- Users
- · Contacts.

The participant data includes participant names and business identifiers such as DUNS numbers. A single partner can have one or more business identifiers.

Users are accounts that have access to the Partner Gateway console. A user account gets its permissions to interact with the console based on group membership.

Contacts are similar to users; however, they cannot interact with the console, and they can only be configured to receive notifications from the alert system.

#### **Document flow definition**

A document flow definition must be defined for each type of document to be processed by Partner Gateway. The document flow definition gives information to the hub about how to process the document:

- The packaging that surrounds the document
- The business protocol that defines the document
- The type of document flow.

There are several parts to a document flow definition. A package defines how a document is to be packaged per a specification for the transport, such as AS2. A protocol describes the general standard that a document adheres to, such as EDI-X12. A *document flow* details what needs to be done with the contents of a flow. All of these parts have attributes that may apply, providing the runtime the information required to help process the document.

#### Interaction

An interaction specifies how the document gets processed through Partner Gateway, independent of any participants.

The interaction defines for a received document (package, protocol, and document flow):

- The document to send (package, protocol, document flow)
- The actions to be performed on a document and, optionally, the Transformation map to use.

### **B2B** capabilities

B2B capabilities identify to Partner Gateway the specific document types each trading community participant is authorized to send and receive. Depending on the document type, some characteristics can be set on how the Community manager wants to send or receive the document (as pertains to the participant). A participant's B2B capabilities are defined as:

- The valid document flow definitions for documents to be sent by the participant
- The valid document flow definitions for documents to be received by the participant.
- Any document attributes specific to the participant.

**Note:** Attribute values set in the B2B capabilities take precedence over the Document Flow Definition attribute values.

You need to specify the B2B capabilities for each participant by selecting the applicable document flow definitions from the pool that has been defined for the trading community.

### Participant connection

A participant connection specifies a valid type of document exchange between a specific participant and the Community Manager. The participant connection is an Interaction that has been associated with specific sending and receiving partners. A participant connection also specifies the gateways and other routing information necessary for that exchange.

Partner Gateway derives a list of valid participant connections for document exchange between the participant and the Community manager using the defined Interactions and partner B2B capabilities.

From the list of valid connections, you need to activate those connections that are actually needed by the participant to send or receive its business documents.

## Integration with enterprise systems

Each edition of Partner Gateway provides the ability to connect to back-end integration systems. Partner Gateway - Express provides file-based integration, while Partner Gateway Enterprise and Advanced Editions provide both file-based integration and integration over HTTP, HTTPS, and JMS transports.

Partner Gateway is the entry point for documents coming into the enterprise. It validates, transforms, and otherwise processes the documents, based on their type, and passes them on to a back-end system that integrates the information with other applications. The back-end system can be a business process integration server, such as WebSphere Process Server, an integration broker such as WebSphere InterChange Serveror WebSphere Business Integration Message Broker, or it can be a customer-developed system.




Figure 6. Document flow over the internet or a VAN through Partner Gateway to InterChange Server

In this illustration, the back-end integration system is WebSphere InterChange Server. A document intended for WebSphere InterChange Server (ICS) can be sent to Partner Gateway by a community participant in a variety of formats such as XML, EDI, RosettaNet, or binary. Partner Gateway can send the document (after transformation, if necessary) to ICS through the HTTP or JMS transport protocol.

Integration with back-end systems is described in more detail in the *Enterprise Integration Guide*.

## Sample message flow

The scenario below describes the sequence of events in a Partner Gateway document exchange scenario.

In this scenario, a partner sends an AS2 packaged XML document payload over HTTP. Partner Gateway unpackages the document extracting the XML payload, validates the payload and sends the payload to the back-end using JMS transport. The Partner Gateway also sends back an MDN receipt to the partner.

- 1. The AS2 request with the XML document enters the Receiver component of Partner Gateway.
- 2. The Receiver saves the document to persistent shared storage.

- 3. The Receiver returns an HTTP 200 response to the community participant.
- 4. The Document Manager picks up the document for processing by the Document Processing Engine and saves the original document to the non-repudiation database. The Document Processing Engine processes the document, which includes:
  - a. Performing decryption and verification
  - b. Performing authentication and duplicate checks
  - **c**. Determines the sending and receiving of participants based on the business IDs
  - d. Determines the payload document type
  - **e**. Based on the sending and receiving partners, AS2 packaging and the XML document type for the participant connection is looked up.
  - f. From the participant connection, the Action, Transformation Map (if specified), the document type to send, document attribute values, and gateways are determined.
  - g. Performs structural validation per the Action that was specified.
  - h. Adds packaging information such as Back-end Integration per the document type to be sent.
  - i. Saving the final packaged document to the non-repudiation database.
- 5. The Delivery Manager sends the document (in this case, using the JMS transport) to the back-end system
- 6. A message disposition notification (MDN) is sent to the community participant.
- The community participant acknowledges the receipt of the MDN by sending an HTTP 200.

## System configuration options

The component-based structure of Partner Gateway means that it can be configured in a variety of ways—from a single-server configuration to a redundant configuration for high performance or failover support—to meet the needs of your business.

For example, you can install the Partner Gateway components on one server and the prerequisite programs on another, with a firewall in front of each server. Or, you can divide the components and programs among three servers.

To achieve scalability and high performance, you might divide the components and programs among six servers. The following illustration shows such a configuration. Two servers contain instances of the Receiver and the Console, two servers contain the Document Manager, one server contains WebSphere MQ, and one server contains the DB2 database. Firewalls are set up between servers as illustrated. Note that network-attached storage, while recommended, is not required.




Figure 7. A sample WebSphere Partner Gateway configuration.

All of the components in Partner Gateway are designed to scale both horizontally and vertically, where horizontal scaling is characterized as running multiple instances across multiple servers, and vertical scaling is characterized as adding processing power to a single server.

Having the ability to run any of the components on any server allows for greater flexibility with regard to scaling the system. I/O or compute-intensive components can be deployed on servers optimized for their needs. Also, the shared work queue mechanism allows each component to scale independently of other components.

## Chapter 4. Fast paths

This section describes, at a high-level, the tasks involved in setting up and running a Partner Gateway trading community. It also includes pointers to documentation, code samples, and PIP information, you might need to help you get started.

The major steps required to establish a Partner Gateway trading community are the following:

- 1. Analyze the needs of your enterprise and trading partners:
  - Identify the types of documents that will be sent and received.
  - Examine the content of the documents that will be exchanged and determine how this data needs to be processed.
  - For each document exchange scenario between a participant and the Community Manager, identify the every action that needs to be performed on the document and its contents on its path from the sender, to Partner Gateway, to the back-end system, and finally to the business application.
  - Identify any documents that will require customized processing and determine the customizations you need to make to support those documents. Explore customization options and decide whether you will need to customize any document-handling or workflow.
  - If necessary, work with trading partners to modify the formats or protocols
    of their business documents to enable their participation in the trading
    community.
  - Use the Data Interchange Services client to create validation and transformation maps for document content that requires them.
- 2. Plan the trading community:
  - Estimate the volume of documents that will be exchanged
  - Determine the number of WebSphere Partner Gateway instances you need to deploy.
  - Determine your security requirements. Assess whether your installation requires a reverse proxy server.
  - Determine how you will integrate Partner Gateway with your back-end system.
  - Define the process you will follow for connecting businesses to the trading community.
  - Consider how you will adjust the community to respond to changing business needs.
- 3. Install Partner Gateway.
- 4. Configure the hub and define community participants.
- 5. Perform administrative tasks as needed to maintain the trading community.

The documentation available to help you perform these tasks is listed below.
