- Polycarbonate/ Acrylonitrile butadiene styrene (PC/ABS blend) Sabic Cyclicoloy RCX7233 with 30% postconsumer recyclate.

When the product is fully populated with all of the plastic resin parts, the total plastic resin use can be 2363.08 grams. The postconsumer recycled resin mass can be 386.417 grams, which calculates to 16.35% recycled resin in the product for the total resin mass.
