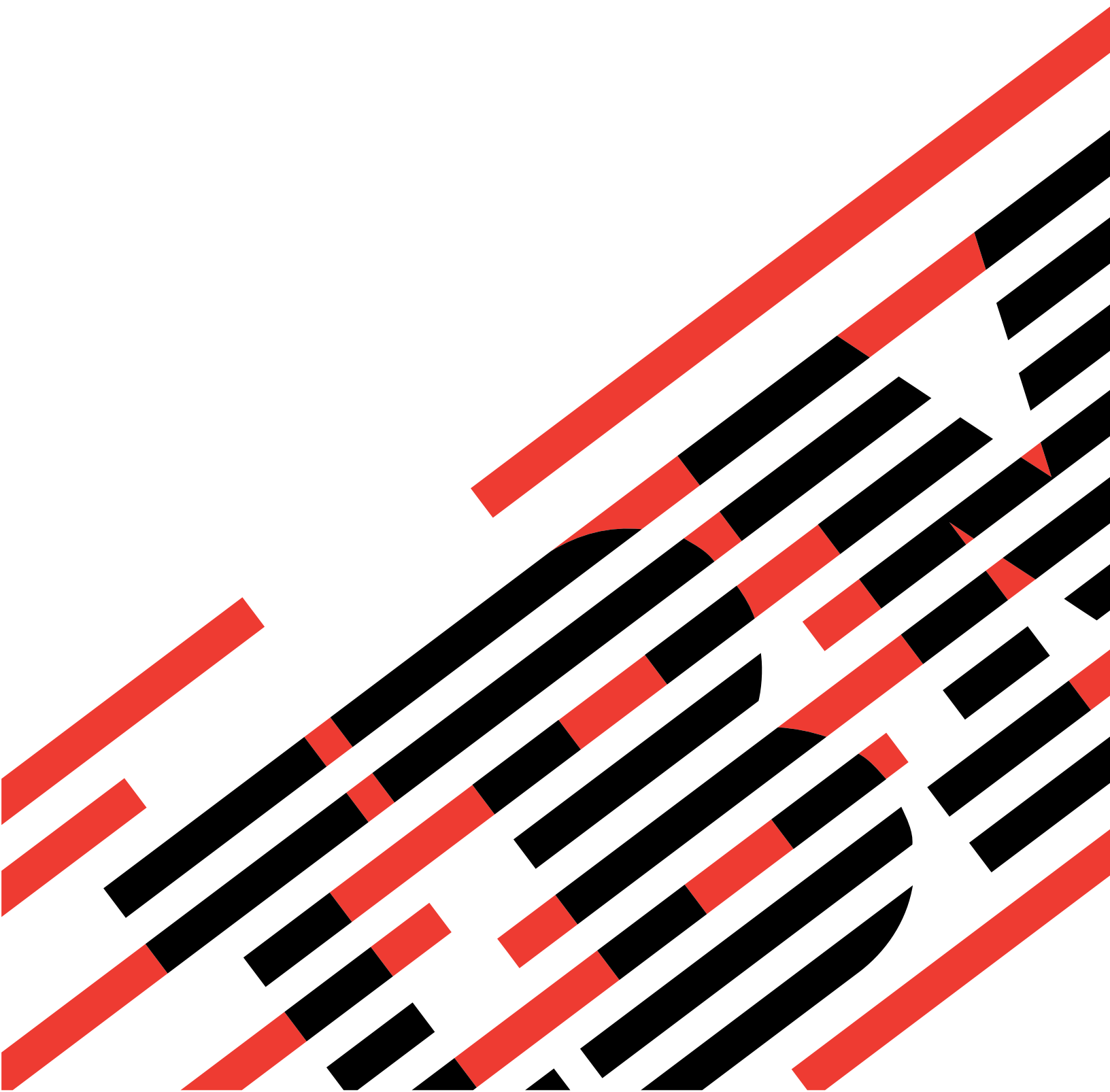

Command Descriptions

DLTJRRCV (Delete Journal Receiver) Command Description

DLTJRRCV Command syntax diagram

Purpose

The Delete Journal Receiver (DLTJRRCV) command deletes the specified journal receivers from the system, which frees the storage space allocated to the journal receivers. Exit point QIBM_QJO_DLT_JRRCV is provided for the DLTJRRCV command. See the Application Program Interfaces (APIs) topic in the Information Center for more information.

Restrictions:

1. The journal receiver must not be attached to a local journal at the time the command is issued.
2. If an attempt is made to delete a journal receiver that is attached to a remote journal, and that remote journal is not actively receiving journal entries or replicating journal entries, and DLTOPT(*IGNINQMSG) is not specified, an inquiry message (CPA705E) is sent to the requesting workstation. If the request is made from a batch job, the message is sent to the system operator. This inquiry message can be automatically replied to. For more information, refer to the INQMSGRPY parameter of the Create Job Description (CRTJOB) command.
3. The journal receiver must not be in the middle of a chain of online receivers unless it is damaged or if its dual receiver is damaged. (The receivers must be deleted in the same order in which they were detached, to prevent gaps from occurring in the range of receivers).
4. If an attempt is made to delete a journal receiver that has not been saved and DLTOPT(*IGNINQMSG) is not specified, an inquiry message (CPA7025) is sent to the requesting work station. If the request is made from a batch job, the message is sent to the system operator. This inquiry message can be automatically replied to. For more information, refer to the INQMSGRPY parameter of the Create Job Description (CRTJOB) command.
5. The user must have *ALLOBJ and *SECADM authority in order to specify the *IGNEXITPGM special value.
6. This command is conditionally threadsafe if exit programs are registered for exit point QIBM_QJO_DLT_JRRCV as follows:
 - If no exit programs are registered or DLTOPT(*IGNEXITPGM) is specified, the command is threadsafe.
 - If all exit programs are threadsafe and registered to run in a multithreaded job, the command is threadsafe.
 - If any exit program is registered to not run in a multithreaded job and is being attempted to run in a multithreaded job, the command will fail and the journal receiver will not be deleted.

Use the MLTTHDACN parameter on the ADDEXITPGM command to specify whether an exit program can run in a multithreaded job. See the ADDEXITPGM command for more information.

Required Parameters

JRRCV

Specifies the qualified name of the journal receivers being deleted.

The name of the journal receiver can be qualified by one of the following library values:

***LIBL:** All libraries in the job's library list are searched until the first match is found.

***CURLIB:** The current library for the job is searched. If no library is specified as the current library for the job, the QGPL library is used.

***USRLIBL:** Only the libraries in the user portion of the job's library list are searched.

***ALL:** All libraries in the system, including QSYS, are searched.

» ***ALLUSR:** User libraries are all libraries with names that do not begin with the letter Q except for the following:«

» Although the following libraries with names that begin with the letter Q are provided by IBM, they typically contain user data that changes frequently. Therefore, these libraries are also considered user libraries:«

library-name: Specify the name of the library to be searched.

journal-receiver-name: Specify the name of the journal receiver being deleted.

generic-journal-receiver-name:* Specify the generic name of the journal receiver being deleted. A generic name is a character string of one or more characters followed by an asterisk (*); for example, ABC*. The asterisk substitutes for any valid characters. A generic name specifies all objects with names that begin with the generic prefix for which the user has authority. If an asterisk is not included with the generic (prefix) name, the system assumes it to be the complete object name. If the complete object name is specified, and multiple libraries are searched, multiple objects can be deleted only if *ALL or *ALLUSR library values can be specified for the name. For more information on the use of generic names, refer to generic names.

DLTOPT

Specifies whether additional checking should not be done before a journal receiver is deleted.

***NONE:** The journal receiver delete is attempted without ignoring any of the protective checks which are done before a journal receiver is deleted.

***IGNTGTRCV:** The system does not verify that all remote journals associated with this journal that are immediately downstream on a target system have full copies of this journal receiver. The delete operation continues even if any of those remote journals does not have a full copy. This protection on a journal receiver only applies beginning when the remote journal was added using the Add Remote Journal (QjoAddRemoteJournal) API, until it is removed using the Remove Remote Journal (QjoRemoveRemoteJournal) API, or until the journal is deleted. For more information about APIs, see Application Program Interfaces (APIs) topic in the Information Center for more information.

***IGNINQMSG:** Ignore inquiry message. Inquiry message CPA7025 is not presented to the user, even if this receiver has not been fully saved (for example, a save after the receiver was detached). Also, inquiry message CPA705E is not presented to the user even if the receiver is attached to a remote journal. The delete operation continues.

***IGNEXITPGM:** Ignore user exit programs. Any user exit programs registered for exit point QIBM_QJO_DLT_JRNRCV are not called and not included in the decision of whether this journal receiver can be deleted.

Example for DLTJRNRCV

This command deletes the journal receiver JRNRCCLA in library MYLIB from the system.

DLTLIB (Delete Library) Command Description

DLTLIB Command syntax diagram

Purpose

The Delete Library (DLTLIB) command deletes a specified library from the system after all objects in the library have been deleted. If a library being deleted contains objects, this command first deletes all of the objects and then deletes the library. If the user submitting this command does not have the authority to delete every object in the library, only those for which the user has the authority are deleted. In this case, the library and all the other objects in the library do not change. If any object in the library is in use (locked to a program) when this command is entered, the object cannot be deleted.

If a library has been damaged, the user should not delete it without first trying to resolve the damage. In most cases, the damage can be resolved by starting the initial program load (IPL) sequence to rebuild a user library (including the QGPL library). Then, if the library is still damaged, it should be deleted. Either a saved version of the library can be restored in its place or the library can be recreated.

Restrictions:

1. To delete a library, the user must have use and object existence authority for the specified library and object existence authority for every object in it. If the user does not have object existence authority for the library, nothing is deleted. If the user does not have object existence authority for one or more objects in the library, those objects and the library are not deleted.
2. >> The user must have *USE authority to the auxiliary storage pool (ASP) device if a specific ASP device name is specified on the ASPDEV parameter.<<<
3. >> A library cannot be deleted if it is in the library list of the current thread.<<<
4. >> A library cannot be deleted if it is in the library list of any primary thread that is active on the system when the QLIBLCKLVL system value is set to lock libraries in the library list.<<<
5. >> This command cannot be used to delete the QQALIB, QRECOVERY, QRCYxxxxx, QSPL, QSPLnnnn, QSYS, QSYSxxxxx, QSYS2, QSYS2xxxxx, QSYSCGI, QTEMP, SYSIBM, or SYSIBxxxxx libraries (where 'xxxxx' is the number of a primary auxiliary storage pool (ASP) and 'nnnn' is the number of a basic user ASP.) <<<
6. If the library QDOC is deleted, it is created again during the next IPL.
7. This command is conditionally threadsafe. The following restrictions apply:
 - a. In multithreaded jobs, this command is not threadsafe for distributed files and fails for distributed files that use relational databases of type *SNA.

Required Parameter

LIB Specifies the name of the library to be deleted.

>> Optional Parameter

ASPDEV

Specifies the auxiliary storage pool (ASP) device name where storage is allocated for the library being deleted (LIB parameter). If the library is in an ASP that is not part of the thread's library name space, this parameter must be specified to ensure the correct library is the target of the delete library operation.

***:** The ASPs that are currently part of the thread's library name space will be searched to locate the library. This includes the system ASP (ASP 1), all defined basic user ASPs (ASPs 2-32), and, if the thread has an ASP group, the primary and secondary ASPs in the ASP group.

***CURASPGRP:** If the thread has an ASP group, the primary and secondary ASPs in the ASP group will be searched to locate the library. The system ASP (ASP 1) and defined basic user ASPs (ASPs 2-32) will not be searched.

***SYSBAS:** The system ASP (ASP 1) and all defined basic user ASPs (ASPs 2-32) will be searched to locate the library. No primary or secondary ASPs will be searched, even if the thread has an ASP group.

auxiliary-storage-pool-device-name: The device name of the primary or secondary ASP to be searched to locate the library. The primary or secondary ASP must have been activated (by varying on the ASP device) and have a status of 'Active' or 'Available'. The system ASP (ASP 1) and defined basic user ASPs (ASPs 2-32) will not be searched. <<<

Example for DLTLIB

```
DLTLIB LIB(W)
```

This command deletes library W after all of its objects have been deleted. If library W contains objects and the user has the authority to delete all of those objects, library W and all of the objects are deleted. If the user does not have authority to delete all of the objects, only those for which he has authority are deleted and the library is not deleted.

DLTLICPGM (Delete Licensed Program) Command Description

DLTLICPGM Command syntax diagram

Purpose

The Delete Licensed Program (DLTLICPGM) command is used to delete the objects contained in the licensed program.


Restrictions:

1. This command is shipped with public *EXCLUDE authority.
2. To use this command, you must have *ALLOBJ authority.
3. Some licensed programs can be deleted only if the user is enrolled in the system distribution directory.
4. The licensed programs 5716SS1 *BASE (operating system) and 5716SS1 option 1 (extended base support) cannot be deleted.
5. You must use the LICPGM menu to delete the secondary language library for the operating system and option 1 of the operating system.

Required Parameter


LICPGM

Specifies the 7-character identifier of the licensed program to be deleted. The user can select only one licensed program to delete.

A list of the IBM-supplied licensed programs is in the Software Installation  book.

Optional Parameters

OPTION

Specifies which of the parts of the licensed program specified on the LICPGM parameter are deleted. A list of options is in the Software Installation  book.

***ALL:** All of the optional parts and base parts associated with the licensed program listed in the LICPGM parameter are deleted.

Note: If licensed program 5716SS1 is specified, only the optional parts are deleted except option 1 (option 10 on a 9406 system). If any other licensed program is specified, all parts are deleted.

number-of-optional-part: Specify the number of the optional part of the listed licensed program being deleted.

RLS Specifies which version, release, and modification level of the product is deleted.

***ONLY:** Delete the version, release, and modification level installed for the product option.

***ALL:** All installed versions of the product are deleted.

release-level: Specify the release level in VxRyMz format, where Vx is the version number, Ry is the release number, and Mz is the modification level. The variables x and y can be a number from 0 through 9, and the variable z can be a number from 0 through 9 or a letter from A through Z.

LNG Specifies which national language version (NLV) objects are deleted for the licensed program specified on the LICPGM parameter.

***ALL:** All NLV objects and program objects for the licensed program specified on the LICPGM, OPTION, and RLS parameters are deleted.

feature-code: Specify the NLV identifier of the language that is deleted. Only the specified NLV is deleted. The program objects for the product are not deleted. The IBM-supplied language feature

codes are listed in the Software Installation  book or can be displayed using GO LICPGM, option 20.

Examples for DLTLICPGM

Example 1: Deleting all Licensed Program Objects:

DLTLICPGM LICPGM(5716WP1)

This command deletes all of the objects associated with the OfficeVision (5716-WP1) licensed program.

Example 2: Deleting Specific Licensed Program Objects:

DLTLICPGM LICPGM(5716CB1) LNG(2929)

This command deletes only the German (NLV 2929) objects for all options of the ILE COBOL/400 licensed program 5716-CB1.

Error messages for DLTLCIPGM

DLTLIND (Delete Line Description) Command Description

DLTLIND Command syntax diagram

Purpose

The Delete Line Description (DLTLIND) command deletes one or more specified line description. The lines identified in the line description must be varied off before this command is issued.

If any controllers are attached to the lines, they (as well as their associated devices) must also be varied off before the DLTIND command is issued. The controllers are detached when the command is started; a controller cannot be used until it is associated with another line. If a new line description is created, the controllers are either specified when the line is created, or the controllers are attached to other lines that already have line descriptions. In this case, the controller descriptions are deleted and created again, and the new line names are given in the LINE (if just one) or SWTLINLST (if several, for switched network) parameter of each controller command.

Note:

If you are deleting a line attached to a frame relay network interface, the network interface (NWI) must also be varied offline.

If a switched line or a nonswitched line with the switched network backup feature is deleted, the name of the deleted line description is automatically removed from every controller description that contains that name in its SWTLINLST parameter.

Required Parameter

LIND Specifies the name of the line descriptions being deleted. A specific line description or a generic line description is specified.

line-description-name: Specify the name of the line description being deleted.

generic-line-description-name:* Specify the generic name of the line description being deleted. A generic name is a character string of one or more characters followed by an asterisk (*); for example, ABC*. The asterisk substitutes for any valid characters. A generic name specifies all objects with names that begin with the generic prefix for which the user has authority. If an asterisk is not included with the generic (prefix) name, the system assumes it to be the complete object name. For more information on the use of generic names, refer to generic names.

Example for DLTIND

DLTLIND LIND(LINE01)

This command deletes the line description of the line named LINE01 from the system.

If the line description being deleted has any controller descriptions associated with it, they are detached and a message containing those controller names is sent to the system operator. The detached controller descriptions are associated with a new line description if their names are specified in the command that creates the line description.

DLTLOCALE (Delete Locale) Command Description

DLTLOCALE Command syntax diagram

Purpose

The Delete Locale (DLTLOCALE) command deletes a specified locale.

For more information about locales, see the Globalization topic in the Information Center.

Required Parameter

LOCALE

Specifies the path name of the locale being deleted.

Example for DLTLOCALE

```
DLTLOCALE  
  LOCALE('/QSYS.LIB/MYLIB.LIB/USLOCALE.LOCALE')
```

This command deletes the locale named USLOCALE in the MYLIB library from the system.

DLTMEDDFN (Delete Media Definition) Command Description

DLTMEDDFN Command syntax diagram

Purpose

The Delete Media Definition (DLTMEDDFN) command deletes a media definition from the system. The user who enters this command must have *OBJEXIST authority and *USE authority for the media definition being deleted.

Required Parameter

MEDDFN

Specifies the name of the media definition that is to be deleted.

The name of the media definition can be qualified by one of the following library values:

***LIBL:** All libraries in the job's library list are searched until the first match is found.

***CURLIB:** The current library for the job is searched. If no library is specified as the current library for the job, the QGPL library is used.

***USRLIBL:** Only the libraries in the user portion of the job's library list are searched.

***ALL:** All libraries in the system, including QSYS, are searched.

» ***ALLUSR:** User libraries are all libraries with names that do not begin with the letter Q except for the following:«

#COBLIB	#RPGLIB	
#DFULIB	#SDALIB

Example for DLTMEDDFN

DLTMEDDFN MEDDFN(LIBA/MEDDFNA)

***ALL**: All members that are identified by the FILE and MBR parameters are deleted. If a member name is specified, all members of that name are deleted. If *ALL is specified for the MBR parameter, all members of the file are deleted.

number: Specify the spool number of the file member being deleted. This value is valid only if a single name is specified on the MBR parameter.

USER Specifies the user to whom the deleted files were sent.

***CURRENT**: The user profile that is currently running is used.

Purpose

The Delete Network Server Storage Space (DLTNWSSTG) command deletes an existing network server storage space.

A storage space cannot be deleted if it is linked to a network server description. Before you can delete a linked storage space, the link must be removed by using the Remove Network Server Storage Link (RMVNWSSTGL) command.

Restriction: You must have *IOSYSCFG special authority to use this command.

Required Parameter

NWSSTG

Specifies the name of the network server storage space to be deleted.

Purpose

The Delete Output Queue (DLTOUTQ) command deletes the specified output queue or queues from the system.

Restrictions:

1. The output queue being deleted cannot contain any entries: the output for each file must be printed, deleted, or moved to a different output queue.
2. A subsystem cannot be active.
3. The queue cannot be in use by a spooling writer.
4. The queue cannot be deleted if it has been created by the system for a specific printer.

Required Parameter

OUTQ Specifies the qualified name of the output queue.

***LIBL:** All libraries in the job's library list are searched until the first match is found.

***CURLIB:** The current library for the job is searched. If no library is specified as the current library for the job, the QGPL library is used.

The Delete Overlay (DLTOVL) command deletes a specified overlay from the specified library. If the overlay is found, it is deleted. If the specified overlay is not found, a message is sent to the user stating that it cannot be found.

***LIBL:** All libraries in the job's library list are searched until the first match is found.

***CURLIB:** The current library for the job is searched. If no library is specified as the current library for the job, the QGPL library is used.

***ALL:** All libraries in the system, including QSYS, are searched.

DLTOVR (Delete Override) Command Description

DLTOVR Command syntax diagram

Purpose

The Delete Override (DLTOVR) command deletes one or more file overrides (including message file overrides) that were previously specified in a call level. That is, for each overridden file named in the DLTOVR command, the override specified in the same call level as the DLTOVR command is deleted. When the command is specified interactively or outside a program in a batch job, the file overrides for the call level are deleted; when the command is used in a CL program, the file overrides for that program call level are deleted. A file override is the result of an override file command.

The DLTOVR command can delete all the file overrides for all the files in the same call level or the file overrides for specified files in the same call level. Only the file overrides in the call level in which the command is specified are deleted. For example, if an override command is specified in one program in a routing step, and then another program is called that also contains override commands, a DLTOVR command specified in the second program can delete only overrides that occur in that program. The DLTOVR command has no effect on the override command that was specified before the program was called. The deleted file overrides have no effect on subsequent uses of the file.

Restrictions:

1. In a multithreaded job, this command may only be issued from the initial thread.

Required Parameter

FILE Specifies the names of the overridden files in the call level whose file overrides are being deleted. One or more overridden files can be specified by name, or all files can be specified.

***ALL:** All of the file overrides that exist in the call level where this command is specified are deleted.

***PRTF:** The *PRTF file override that exists in the call level where this command is specified is deleted.

overridden-file-name: Specify the names of one or more overridden files for which the overrides in the call level are deleted.

Optional Parameter

LVL Specifies the call level of the file overrides deleted. There is a one-to-one correspondence between the call stack entries shown on the call stack from the Work with Job (WRKJOB) command and the call level for that call stack entry.

The first call stack entry name on the call stack (at the top of the list) is the call program or procedure at call level one. The second call stack entry name is the program or procedure at call level two. The last call stack entry name is the program or procedure at the highest call level for the job.

***ACTGRPDFN:** The call level of the file overrides to be deleted is determined by the activation group of the program that calls this command. When the activation group is the default activation group, the call level of the overrides to be deleted equals the call level of the calling program. When the activation group is not the default activation group, the call level of the overrides to be deleted equals the activation group of the calling program.

***:** The call level of the file overrides to be deleted is the call level of the program that called the DLTOVR command processing program. If the DLTOVR command is called through QCMDEXC, the call level is the same level as that of the caller of QCMDEXC.

***JOB:** The call levels for the file overrides that are scoped to the job are deleted.

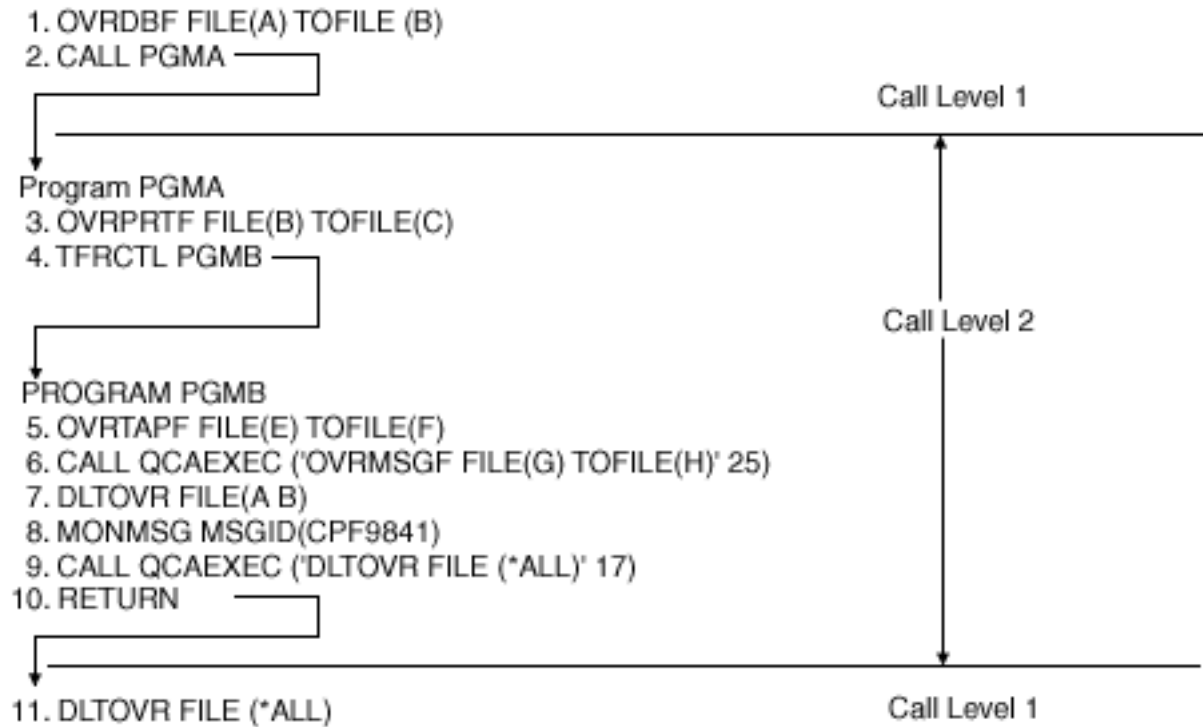
Examples for DLTOVR

Example 1: Deleting Call Level Overrides

1. OVRDBF FILE(A) TOFILE(B)
2. OVRPRTF FILE(C) TOFILE(D)
3. OVRTAPF FILE(E) TOFILE(F) * * *
4. DLTOVR FILE(A C)
5. DLTOVR FILE(*ALL)

If the first three override commands had been specified earlier in the call level, the files B, D, and F would override files A, C, and E. The fourth command deletes only the file overrides that affect files A and C. The last command deletes all the file overrides that exist in the call level, which in this case is the command overriding file E, the third command.

Example 2: Deleting an Override with Multiple Call Levels



This example assumes that commands 1, 2, and 11 are specified in the same call level, call level number 1. The rest of the commands are in call level 2.

Command 1 causes an override in call level 1 from file A to file B. Command 2 calls PGMA and creates another call level, call level 2.

In program PGMA, command 3 causes an override in call level 2 from file B to file C. Command 4 transfers control from PGMA to PGMB in the same call level, call level 2. Unlike the CALL command, the TFRCTL command does not create a new call level.

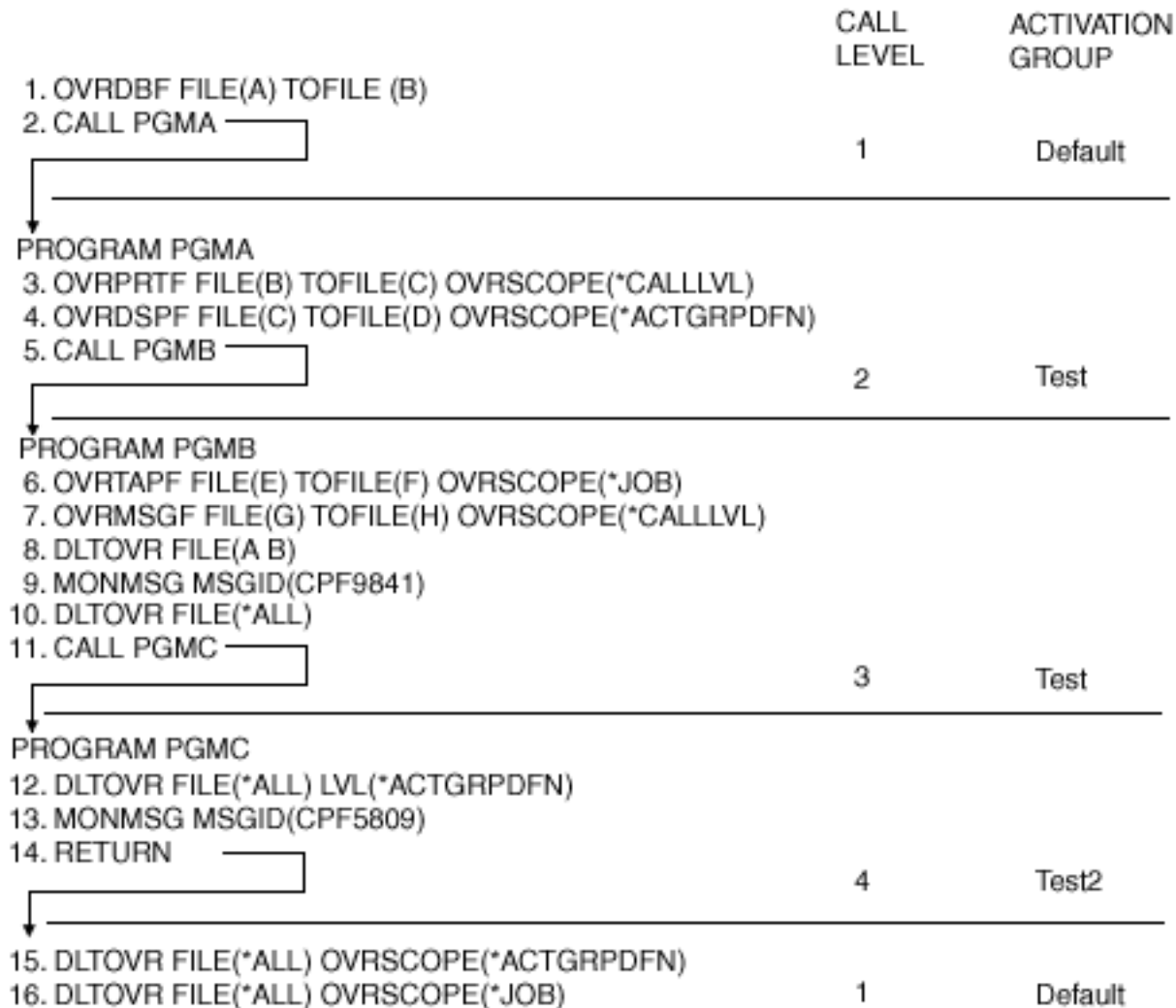
In program PGMB, command 5 causes an override in call level 2 from file E to file F. Command 6 calls QCAEXEC and causes an override from file G to file H. When it is called, QCAEXEC runs as though it is just another command in PGMB, rather than running as a called program. That is, QCAEXEC runs in the same call level (call level 2); it does not create another call level (call level 3).

Command 7 deletes any overrides affecting files A and B in call level 2. In this case, the override specified by command 3 is deleted, but the override specified by command 1 is not. Because an override for file A is not found in call level 2, the escape message, CPF9841, is sent to PGMB. To prevent a function check, a Monitor Message (MONMSG) command is needed after the DLTOVR command. In this example, command 8 monitors for CPF9841, but specifies no action to be taken if the message is sent. Therefore, when CPF9841 is received, it is monitored and ignored by command 8, and control is passed to the next command in the program.

Command 9 deletes all remaining overrides in call level 2. The overrides specified by commands 5 and 6 are deleted, but the override specified by command 1 is not.

Command 10 causes a return to call level 1, and call level 2 is ended. If any overrides had been specified in call level 2 that were not deleted by DLTOVR commands, they are deleted when call level 2 ends. Command 11 causes all remaining overrides in call level 1 to be deleted; the override specified by command 1 is deleted.

Example 3: Deleting Override with Multiple Call Levels and Activation Groups



This example assumes that programs PGMA and PGMB are ILE programs that run in activation group TEST, and that PGMC is an ILE program that runs in activation group TEST2.

Command 1 causes an override in call level 1 from file A to file B. Command 2 calls PGMA and creates call level 2, and creates the activation group, TEST, since it does not already exist.

In program PGMA, command 3 causes an override from file B to file C. Since OVRSCOPE(*CALLLVL) is specified, the override is scoped to call level 2. Command 4 causes an override from file C to file D. Since OVRSCOPE(*ACTGRPDEFN) is specified and PGMA is running in an activation group other than the default activation group, the override is scoped to the activation group, TEST. Command 5 calls PGMB and creates call level 3, but does not create a new activation group, since the activation group TEST already exists.

In program PGMB, command 6 causes an override to be scoped to the job from file E to file F. Command 7 causes an override at call level 3 from file G to file H. Command 8 deletes any overrides for files A and B that were scoped to the activation group TEST, because a value is not specified for the OVRSCOPE parameter. In this case, no overrides would be deleted. The only override for file A occurred when command 1 was issued, but it was in the default activation level and scoped to call level 1. The only override for file B was issued in PGMA; it does run in the activation group, TEST, but was explicitly scoped to call level 2. Because an override is not found for the activation group, TEST, escape message CPF9841 is sent to PGMB. To prevent a function check, a Monitor Message (MONMSG) command is required after the DLTOVR command has been run. In this example, command 9 monitors for message CPF9841, but takes no additional action when the message is sent; therefore, when CPF9841 is received, it is monitored and ignored as specified by command 9, and control is passed to the next command in the program.

Command 10 deletes all overrides scoped to the activation group, TEST. This deletes the override that was issued when command 4 was run. Command 11 calls PGMC, creates call level 4, and creates a new activation group, TEST2.

Command 12 deletes all overrides scoped to the activation group that PGMC is running in, which is TEST2. Because no activation group level overrides exist for TEST2, the escape message, CPF5809, is sent to PGMC. Command 13 monitors for an additional message, CPF5809, which must be sent in order to prevent a function check. When this message is monitored, no additional action is taken, and control passes to the next command in the program.

Command 14 causes a return to PGMB at call level 3, then to PGMA at call level 2, and finally back to call level 1. The call level overrides specified by commands 3 and 7 that were not deleted by running DLTOVR are deleted when the call level ends. Similarly, if there are any activation group level overrides for TEST and TEST2 that were not deleted by running DLTOVR, they are deleted when the activation group is ended.

Command 15 deletes the remaining call level override from command 1, and command 16 deletes the remaining override, which is scoped to the job level from command 6.

DLTOVRDEVE (Delete Override Device Entry) Command Description

DLTOVRDEVE Command syntax diagram

Purpose

The Delete Override Device Entry (DLTOVRDEVE) command deletes one or more program device overrides that were previously specified in a call level.

For each overridden program device named in the DLTOVRDEVE command, the override specified in the same call level as the DLTOVRDEVE command is deleted. When the command is entered interactively or outside a program in a batch job, the program device overrides for the call level are deleted; when the command is used in a CL program, the program device overrides for that program call level are deleted. A program device override is the result of an override program device command Override Intersystem Communications Function Device Entry (OVRICFDEVE).

The DLTOVRDEVE command can delete all the program device overrides in the same call level, or it can delete a specific program device override in the same call level. Only the call level in which the command is entered has its program device overrides deleted. For example, if an override command is entered in one program in a routing step, and then another program is called that also contains override commands, a DLTOVRDEVE command entered in the second program can delete only overrides that occurred in that program. The DLTOVRDEVE command has no effect on the override command that was entered before the program was called. The deleted program device override has no effect on subsequent uses of the program device.

Required Parameter

PGMDEV

Specifies program devices whose overrides can be specified and deleted.

***ALL:** All program device overrides that exist in the call level where this command is entered are deleted.

overridden-program-device-name: Specify the names of one or more overridden program devices for which the overrides in the call level are deleted.

Optional Parameter

LVL Specifies the call level of the program device overrides to be deleted. There is a one-to-one correspondence between the call stack entries shown on the call stack from the Work with Job (WRKJOB) command and the call level for that call stack entry.

The first call stack entry name on the call stack (at the top of the list) is the call program or procedure at call level one. The second call stack entry name is the program or procedure at call level two. The last call stack entry name is the program or procedure at the highest call level for the job.

***ACTGRPDFN:** The call level of the program device overrides to be deleted is determined by the activation group of the program that calls this command. When the activation group is the default activation group, the call level of the program device overrides to be deleted equals the call level of the calling program. When the activation group is not the default activation group, the call level of the program device overrides to be deleted equals the activation group of the calling program.

*****: The call level of the program device overrides to be deleted is the call level of the program that called the DLTOVRDEVE command processing program. If the DLTOVRDEVE command is called through QCMDEXC, the call level is the same level as that of the caller of QCMDEXC.

***JOB:** The call levels for the program device overrides that are scoped to the job are deleted.

Examples for DLTOVRDEVE

Example 1: Deleting Program Device Overrides With Calling Program in Default Activation Group

```
DLTOVRDEVE PGMDEV(*ALL)
```

This command deletes all program device overrides that exist in the call level, when the calling program runs in the default activation group. When the calling program runs in an activation group other than the default activation group, the program device overrides that are scoped to that activation group are deleted.

Example 2: Deleting Program Device Overrides With Calling Program in Any Activation Group

```
DLTOVRDEVE PGMDEV(*ALL) LVL(*)
```

This command deletes all program device overrides that exist in the call level, regardless of the activation group the calling program runs in.

Error messages for DLTOVRDEVE

No error messages.

DLTPAGDFN (Delete Page Definition) Command Description

DLTPAGDFN Command syntax diagram

Purpose

The Delete Page Definition (DLTPAGDFN) command deletes a page definition from the specified library. If the page definition is not found, a message is sent to the user stating that the page segment could not be found.

Restriction: The user must have *OBJEXIST authority to delete an object.

Required Parameter

PAGDFN

Specifies the qualified name of the page definition to be deleted. The user can specify a particular page definition or a generic page definition, and either one can be qualified by a library name.

Purpose

The user, typically a system operator or user responsible for handling system problems, uses the Delete Problem (DLTPRB) command to maintain the size of the problem log by deleting one or more entries. More information on controlling problem log size is in the Basic System Operations topic in the Information Center.

Restriction: This command is shipped with public *EXCLUDE authority and the QPGMR, QSYSOPR, QSRV, and QSRVBAS user profiles have private authorities to use the command.

Optional Parameters

PRBID

Specifies the problem identifier of the problem being deleted from the problem log. Problems with different system origins can have the same identifier. This parameter can be used with the ORIGIN parameter to select a single problem for deletion from a particular system origin.

***ALL:** All problems are deleted.

problem-identifier: Specify the 10 character problem identifier of the problem being deleted. If a problem identifier is specified, the STATUS and DAYS parameters are ignored.

STATUS

Specifies the status of the problem log entries. The seven status types are as follows:

*OPENED

The problem is in OPENED status. The problem has been identified and a problem record has been created.

***READY**

The problem is in READY status. Problem analysis information has been added to the problem record.

***PREPARED**

The problem is in PREPARED status. The problem has been prepared for reporting.

***SENT**

The problem is in SENT status. The problem has been sent to a service provider, but no answer has been returned.

***ANSWERED**

The problem is in ANSWERED status. An answer was returned by the service provider or added by an operator on this system.

***VERIFIED**

The problem is in VERIFIED status. The problem has been resolved and the system operator has verified that the problem has been corrected.

***CLOSED**

The problem is closed.

Note:

This parameter is valid only when PRBID(*ALL) is specified.

***ALL:** All problems that match the user-defined values on this command and any current status types are deleted.

status-type: Specify one of the seven status types. Up to six status types can be specified.

DAYS Specifies that all problems older than the value specified on this parameter are deleted. Problems with a status type other than CLOSED are deleted the specified number of days after the OPENED date. Problems with a CLOSED status type are deleted after the number of days following the CLOSED date.

This parameter is valid only when PRBID(*ALL) is specified.

30: The problem is deleted after 30 days.

number-of-days: Specify the number of days that can elapse before a problem is deleted. Valid values range from 0 through 999 days. If this value is smaller than the system value, QPRBHLDTV, the system value is used.

ORIGIN

Specifies whether only problem log entries originating on the specified nodes are deleted.

Element 1: Network Identifier

***NETATR:** Only entries originating on systems with the same network identifier as the one defined in the network attributes are deleted.

***ALL:** All entries are deleted regardless of the user's system origin network identifier.

network-identifier: Specify a network identifier. Only entries originating on systems with the specified network identifier are deleted.

Element 2: Control Point Name

***NETATR:** Only entries originating on systems with the same control point name as the one defined in the network attributes are deleted.

***ALL:** All entries originating on systems with the network identifier are deleted.

control-point-name: Specify a control point name. Only entries originating on systems with the specified control point name are deleted.

Example for DLTPRB

```
DLTPRB STATUS(*OPENED *READY *SENT) DAYS(15)
```

This command deletes all entries in the OPENED, READY, or SENT status that were added to the problem log prior to 15 days ago.

DLTPRDDFN Command syntax diagram

Purpose

The Delete Product Definition (DLTPRDDFN) command deletes a product definition object.

Note:

A user who has authority to this command can delete any *PRDDFN object regardless of whether you have authority to the *PRDDFN object.

Required Parameters

PRDDFN

Specifies the name of the product definition to be deleted.

Note:

You must specify either this parameter or PRDID, but parameters cannot be specified at the same time.

The possible library values are:

***CURLIB:** The current library for the job is used to locate the product definition.

library-name: Specify the name of the library where the product definition is located.

PRDID

Specifies the 7-character product identifier (ID) of the product for which a definition is being deleted.

The Delete Product Load (DLTPRDLOD) command deletes a product load defined by the Create Product Load (CRTPRDLOD) command.

If you have the authority to use this command, you can delete any *PRDLOD object whether or not you have authority to the *PRDLOD object.

Required Parameters

PRDLOD

Specifies the name of the product load being deleted.

The possible library values are:

***CURLIB:** The current library for the job is used to locate the product load.

library-name: Specify the name of the library where the product load is located.

product-load-name: Specify the name of the product load being deleted.

Note: You must specify either the product ID, option, load ID, and release, or the product load name and the library.

PRDID

Specifies the 7-character identifier (ID) of the product for which a product load is being deleted.

OPTION

Specifies the product option for which a product load is being deleted.

***BASE:** The product load is part of the base option of the product.

product-option-number: Specify the option number of the product to be deleted. Valid values range from 1 through 99.

LODID

Specifies the load ID of the product load being deleted.

***CODEDFT:** The default code load ID, 5001, is used.

product-load-ID: Specify the product load ID of the product load to be deleted.

Optional Parameter

RLS Specifies the version, release, and modification level of the product.

***ONLY:** The release level is determined by searching the system for a product load specified on the PRDID, OPTION, and LODID parameters. This value can be specified only when one release of the product is installed on the system.

version-release-modification: Specify the version, release, and modification level of the product being deleted.

Example for DLTPRDLOD

```
DLTPRDLOD PRDLOD(MYLIB/MYLOD)
```

This command deletes the product load MYLOD in library MYLIB.

DLTPGM (Delete Program) Command Description

DLTPGM Command syntax diagram

Purpose

The Delete Program (DLTPGM) command deletes a compiled program or group of programs. If the OPM program is currently being run, the program processing is abnormally ended when this command is issued

unless a specific Allocate Object (ALCOBJ) command is in effect in another job. ILE programs continue to run. Any high-level language (HLL) or CL program can be deleted.

Restrictions:

1. The user of this command must have *OBJEXIST authority to the program, and *EXECUTE authority to the library where it is stored.
2. If the program being deleted is currently being debugged, a function check occurs if an implicit reference is made to the deleted program (for example, if a Change Variable (CHGVAR) command specifies PGM(*DFTPGM)). To prevent function checks, use the Remove Program (RMVPGM) command to remove the program from the debugging session before deleting it. If the program is recompiled while the user is in debug mode, remove the program from debug mode (using the RMVPGM command), delete it from the system (using the Delete Program (DLTPGM) command), change and recompile the program, and add the new version of the program to debug mode (using the Add Program (ADDPGM) command).

Required Parameter

PGM Specifies the qualified name of the programs being deleted. A specific program or a generic program can be specified; either type optionally can be qualified by specifying a library name.

DLTSPADCT Command syntax diagram

Purpose

The Delete Spelling Aid Dictionary (DLTSPADCT) command deletes the specified spelling aid dictionary from the system.

More information on spelling aid dictionaries is in the Using OfficeVision/400 Word Processing book.

Restriction:

The user must have object existence authority or *ALL authority for the spelling aid dictionary being deleted.

Required Parameter

SPADCT

Specifies the qualified names of the spelling aid dictionaries being deleted. A specific spelling aid dictionary or generic spelling aid dictionary can be specified; either type can be qualified by a library name.

The name of the spelling aid dictionary can be qualified by one of the following library values:

***LIBL:** All libraries in the job's library list are searched until the first match is found.

***CURLIB:** The current library for the job is searched. If no library is specified as the current library for the job, the QGPL library is used.

library-name: Specify the name of the library to be searched.

spelling-aid-dictionary-name: Specify the name of the spelling aid dictionary being deleted.

generic-spelling-aid-dictionary-name:* Specify the generic name of the spelling aid dictionary being deleted. A generic name is a character string of one or more characters followed by an asterisk (*); for example, ABC*. The asterisk substitutes for any valid characters. A generic name specifies all objects with names that begin with the generic prefix for which the user has authority. If an asterisk is not included with the generic (prefix) name, the system assumes it to be the complete object name. If the complete object name is specified, and multiple libraries are searched, multiple objects can be deleted only if *ALL or *ALLUSR library values can be specified for the name. For more information on the use of generic names, refer to generic names.

DLTSPLF Command syntax diagram

Purpose

The Delete Spooled File (DLTSPLF) command is used to delete the specified spooled file from the output queue. If the spooled file is currently being produced on a device, it is immediately stopped and deleted. Output that has not been written is lost.

For information on deleting multiple spooled files of a job, see the “Additional Considerations” section of the Work with Job (WRKJOB) command description. For information on deleting all spooled files of a job, see the ENDJOB (End Job) command description.

Required Parameter

FILE Specifies the name of the spooled file being deleted from the output queue.

» ***SELECT:** All spooled files that meet the selection requirements specified in the SELECT keyword are deleted from the system. This value is mutually exclusive with the JOB, SPLNBR, JOBSYSNAME, and CRTDATE parameters. Specifying *SELECT causes the JOB, SPLNBR, JOBSYSNAME, and CRTDATE keywords to be ignored. «

spooled-file-name: Specify the name of the spooled file being deleted from the system.

Optional Parameters

JOB Specifies the name of the job that produced (or is producing) the spooled file being deleted from the output queue.

A job identifier is the special value * or a qualified name with up to three elements. For example:

*
job-name
user-name/job-name
job-number/user-name/job-name

More information on this parameter is in commonly used parameters.

***:** The job that issued this command is the job that produced the file being deleted.

job-name: Specify the name of the job that produced the file being deleted. If no job qualifier is given, all of the jobs currently in the system are searched for the simple job name.

user-name: Specify the name of the user of the job that produced the file being deleted.

job-number: Specify the number of the job that produced the file being deleted.

SPLNBR

Specifies the number of the job's spooled file being deleted from the output queue. More information on this parameter is in commonly used parameters.

***ONLY:** One spooled file from the job has the specified file name. The number of the spooled file is not necessary. If *ONLY is specified and more than one spooled file has the specified file name, a message is sent.

***LAST:** The spooled file with the highest number and the specified file name is used.

» ***ANY:** The spooled file number is not used to determine which spooled file is used. Use this value when the job system name parameter or the spooled file creation date and time parameter is to take precedence over the spooled file number when selecting a spooled file. «

spooled-file-number: Specify the number of the spooled file with the specified file name that is being deleted.

» JOBSYSNAME

Specifies the name of the system where the job that created the spooled file (JOB parameter) ran.

This parameter is considered after the job name, user name, job number, spooled file name, and spooled file number parameter requirements have been met.

***ONLY:** There is one spooled file with the specified job name, user name, job number, spooled file name, spooled file number, and spooled file creation date and time.

***CURRENT:** The spooled file created on the current system with the specified job name, user name, job number, spooled file name, spooled file number, and creation date and time is used.

***ANY:** The job system name is not used to determine which spooled file is used. Use this value when the spooled file creation date and time parameter is to take precedence over the job system name when selecting a spooled file.

system name: Specify the name of the system where the job that created the spooled file ran.

CRTDATE

Specifies the date and time the spooled file was created. This parameter is considered after the job name, user name, job number, spooled file name, spooled file number, and job system name parameter requirements have been met.

***ONLY:** There is one spooled file with the specified job name, user name, job number, spooled file name, spooled file number, and job system name.

***LAST:** The spooled file with the latest creation date and time of the specified job name, user name, job number, spooled file name, spooled file number, and job system name is used.

Element 1: Date spooled file was created

date: Specify the date the spooled file was created.

Element 2: Time spooled file was created

***ONLY:** There is one spooled file with the specified job name, user name, job number, spooled file name, spooled file number, job system name, and spooled file creation date.

***LAST:** The spooled file with the latest creation time of the specified job name, user name, job number, spooled file name, spooled file number, job system name, and spooled file creation date is used.

time: Specify the time the spooled file was created. <<

SELECT

Specifies which group of files is selected for deletion. Files can be selected based on user device, form type, and user data. Only files that meet each of the requirements are selected for deletion.

Element 1: User Names

***CURRENT:** Only files created by the user running this command are selected for deletion.

***ALL:** Files created by all users are selected for deletion.

user-name: Only files created by the specified user name are selected for deletion.

Element 2: Device Names

***ALL:** Files queued for any device are selected for deletion.

***OUTQ:** All files that are not queued for a device are selected for deletion. These files are on the output queue that are associated with printers.

device-name: Only files queued for the specified device name are selected for deletion.

Element 3: Form Types

***ALL:** Files for all form types are selected for deletion.

***STD:** Only files that specify the standard form type are selected.

form-type: Only files with the specified form type are selected for deletion.

Element 4: User Data Tags

***ALL:** Files with any user data tag specified are selected for deletion.

user-data: Only files with the specified user data tag are selected for deletion.

This command deletes the spooled file named WEEKLY (of job PAYROLL5, for user SMITH, job number 000146) from the output queue. DLTSQLPKG (Delete Structured Query Language Package) Command Description

DLTSQLPKG Command syntax diagram

Purpose

The Delete Structured Query Language Package (DLTSQLPKG) command is used to delete one or more SQL packages.

DLTSQLPKG is a local command and must be used on the iSeries 400 where the SQL package being deleted is located.

To delete an SQL package on a remote system that is also an iSeries 400, use the Submit Remote Command (SBMRMTCMD) command to run the DLTSQLPKG command on the remote system.

The user can do the following to delete an SQL package from a remote system that is not an iSeries 400:

- Use interactive SQL to run the CONNECT and DROP PACKAGE operations.
- Sign on the remote system and use a command local to that system.
- Create and run an SQL program that contains a DROP PACKAGE SQL statement.

Required Parameter

SQLPKG

Specifies the qualified name of the SQL package being deleted. A specific or generic SQL package name can be specified.

The name of the SQL package can be qualified by one of the following library values:

***LIBL:** All libraries in the job's library list are searched until the first match is found.

***CURLIB:** The current library for the job is searched. If no library is specified as the current library for the job, the QGPL library is used.

***USRLIBL:** Only the libraries in the user portion of the job's library list are searched.

***ALL:** All libraries in the system, including QSYS, are searched.

Note: A change request is automatically submitted which can be viewed to determine the status of this command. A message is returned identifying the name of the change request.

Restrictions:

1. The *LIBL object library cannot be specified.
2. The object cannot reside in the QTEMP library.
3. If a node list (NODL) value is specified, the node list can only contain entries that have a value of *SNA for the address type.

Required Parameters

OBJ Specifies the qualified name that is to be deleted.

The possible library values are one of the following:

***CURLIB:** The current library for the job is used to locate the object.

library-name: Specify the name of the library to be searched.

object-name: Specify only characters A through Z, and 0 through 9, dollar sign, at sign, and number sign are used in the object name.

OBJTYPE

Optional Parameters

Purpose

The Delete Trace Data (DLTTRC) command deletes trace data that was stored in a set of database files by the ENDTRC (End Trace) command.

1. To use this command you must have *SERVICE special authority, or be authorized to the Service Trace function of the operating system through iSeries Navigator's Application Administration support. The Change Function Usage Information (QSYCHFUI) API, with a function ID of QIBM_SERVICE_TRACE, can also be used to change the list of users that are allowed to perform trace operations.
2. To use this command you must have authority to the library and the database files within that library where the trace data is stored.

Required Parameter

DTAMBR

Specifies the member name for the trace data that you want to delete. The member name will be

member-name: Specify the member name for the trace to delete.

Optional Parameter

DTALIB

Specifies the name of the library that contains the set of database files where the collected trace data is stored.

***CURLIB**: The trace data is deleted from files in the current library for the job. If no library is specified as the current library for the job, QGPL is used.

library-name: Specify the library that contains the trace data files.

Required Parameter

USRIDX

Specifies the name of the user index that is to be deleted.

***LIBL**: All libraries in the job's library list are searched until the first match is found.

DLTUSRPRF (Delete User Profile) Command Description

DLTUSRPRF Command syntax diagram

Purpose

The Delete User Profile (DLTUSRPRF) command deletes a user profile from the system. The user of this command must have *SECADM special authority, which can be obtained through the program adopt operation, and *OBJEXIST authority and *USE authority for the user profile being deleted.

The message queue associated with this user profile is automatically deleted if the user profile is the owner of the message queue.

If a user profile is damaged by system failure, it can be deleted by using the Delete User Profile (DLTUSRPRF) command and re-created by using the Create User Profile (CRTUSRPRF) command. After a user profile is re-created, the owned objects and primary group objects can be transferred back to it. Also, authorities that were granted to the damaged profile must be granted again to the new user profile by using the Grant Object Authority (GRTOBJAUT) command.

If several user profiles have been damaged, the saved user profiles can be restored to the system by using the Restore User Profile (RSTUSRPRF) and Restore Authority (RSTAUT) commands.

Restrictions:

1. The user must have use (*USE) and object existence (*OBJEXIST) authority to the user profile.
2. The user must have existence, use, and delete authorities to delete a message queue associated with and owned by the user profile.
3. The user profile cannot be deleted if a user is currently running under the profile, or if it owns any objects and OWNBOBJOPT(*NODLT) is specified. All objects in the user profile must first either be transferred to new owners by using the Change Object Owner (CHGOBJOWN) command or be

deleted from the system. This can also be accomplished by specifying OWNBJOPT(*DLT) to delete the objects or OWNBJOPT(*CHGOWN user-profile-name) to change the ownership. Authority granted to the user does not have to be specifically revoked by the Revoke Object Authority (RVKOBJAUT) command; it is automatically revoked when the user profile is deleted.

4. To delete any object, the user must have object existence authority for the object.
5. The user profile cannot be deleted if it is the primary group for any object. All objects that the user is the primary group for must either be transferred to new users by using the Change Object Primary Group (CHGOBJPGP) command, or be deleted from the system. The transfer can be accomplished by specifying PGPOPT(*CHGPGP user-profile-name) to change the primary group.
6. This command calls the system distribution directory support to delete the user from the directory and to delete the user from distribution lists, if necessary. The system distribution directory support uses journaling and commitment control for the system distribution directory files (QUSURSYS/QAOS*). Commitment control must be inactive when this function is requested. If commitment control is active when this function is requested, the journal must be QUSURSYS/QAOSDIAJRN.

Required Parameter

USRPRF

Specifies the name of the user profile to be deleted.

Optional Parameters

OWNBJOPT

Specifies the type of operations being done on the owned objects of the user profile being deleted.

***NODLT:** The owned objects for the user profile do not change, and the user profile is not deleted if the user owns any objects other than the message queue associated with the user profile.

***DLT:** The objects owned by the user profile are deleted. If the deletion of the objects is successful, the user's enrollment information is removed from OfficeVision*.

Element 1: Change Ownership of Objects

***CHGOWN:** The owned objects for the user profile have ownership transferred to the specified user profile. The user profile is deleted if the transfer of all owned objects is successful.

When *CHGOWN is specified, a user profile name must be specified for the new user profile. The new user profile owns all objects owned by the user profile specified by the USRPRF parameter.

Element 2: User Profile of New Owner

user-profile-name: Specify the name of the user profile.

PGPOPT

Specifies the type of operations being done on the objects the user profile being deleted is the primary group for.

***NOCHG:** The objects the user profile is the primary group for do not change, and the user profile is not deleted if the user is the primary group for any objects.

Element 1: Change Primary Group of Objects

***CHGPGP:** The objects the user profile is the primary group for are transferred to the specified user profile. The user profile is deleted if the transfer of all objects is successful.

When *CHGPGP is specified, a user profile name or *NONE must be specified. If a user profile name is specified, that user is the primary group for all objects for which the user profile specified by the USRPRF parameter is the primary group. If *NONE is specified, all of the objects for which the user profile (specified by the USRPRF parameter) is the primary group for, will no longer have a primary group.

Element 2: User Profile of New Primary Group

user-profile-name: Specify the name of the user profile. The user profile specified must have a group ID number (gid).

***NONE:** The objects do not have a primary group.

Element 3: New Primary Group Authority

***OLDPGP:** The new primary group has the same authority to the object as the old primary group.

***PRIVATE:** The new primary group has the same authority to the object as it previously had. If the new primary group did not have a private authority to the object, it becomes the primary group but does not have any authority to the object.

***ALL:** The new primary group has *ALL authority to the object.

***CHANGE:** The new primary group has *CHANGE authority to the object.

***USE:** The new primary group has *USE authority to the object.

***EXCLUDE:** The new primary group has *EXCLUDE authority to the object.

Additional Considerations

1. Owned object types *USRPRF, *RCT, and *AUTHLR are not deleted from the system. Ownership of these object types is transferred to user profile QDFTOWN.
2. Owned objects of the type *PRDDFN are not deleted. Ownership is transferred to the user profile QSYS.
3. In addition to the above restrictions, all restrictions that apply to DLTLIB also apply to this parameter. For example, if an object is in use, it cannot be deleted. Or, if a physical file has an associated logical file owned by another user, the physical file cannot be deleted.
4. The user profile of a user enrolled in OfficeVision cannot be deleted.
5. Owned objects of type *LIB are not deleted from the system if the library contains objects owned by another user profile. The ownership of the library is transferred to the system user profile, QDFTOWN.
6. Owned objects of type *DIR are not deleted from the system if the directory contains objects owned by another user profile. The ownership of the directory is transferred to the system user profile, QDFTOWN.
7. Owned objects of type *BLKSF are not deleted from the system if the user-defined file system represented by the *BLKSF contains objects owned by another user profile. The ownership of the user-defined file system is transferred to the system user profile, QDFTOWN.
8. A user profile cannot be both the owner of the object and the primary group of the object. Therefore, if the new owner is already the primary group of an object that the current user owns, the transfer of

ownership fails. Also, if the new primary group already owns an object that the current user is the primary group of, the transfer of primary groups fails.

JOB Specifies the jobs for which the user trace buffers are to be deleted.

***ALL:** The user trace buffers for all jobs that match the specified user name and job number are deleted.

Purpose

The Delete User-Defined File System (DLTUDFS) command deletes an existing and unmounted user-defined file system (UDFS) and all of the objects within it. The command will fail if the UDFS is mounted. The command will fail and no objects will be deleted if the user does not have *OBJEXIST authority to all of the objects in the user-defined file system.

Restrictions:

1. The UDFS being deleted must not be mounted.
2. Only a user with *IOSYSCFG special authority can specify this command.
3. The user must have *OBJEXIST authority to all of the objects in the user-defined file system.

Required Parameter

UDFS Specifies the path name of the existing user-defined file system (UDFS) to be deleted. ➤ It must be in one of the following two forms:

- */dev/QASPXX/udfname.udfs*, where *XX* is one of the valid system or basic user auxiliary storage pool (ASP) numbers on the system, and *udfname* is the name of the user-defined file system. All other parts of the name must appear as in the example above.
- */dev/aspname/udfname.udfs*, where *aspname* is one of the valid independent ASP names on the system, and *udfname* is the name of the user-defined file system. All other parts of the name must appear as in the example above.

The name part of the path must be unique within the specified *QASPXX* or *aspname* directory. ⬅

Wildcard characters such as an asterisk (*) and a question mark (?) are not allowed in this parameter. The command will fail if the UDFS specified is currently mounted.

Example for DLTUDFS

```
DLTUDFS UDFS('/dev/QASP01/joe.udfs')
```

This command deletes the user-defined file system (UDFS) named *joe.udfs* from the system auxiliary storage pool (ASP).

DLTVLDDL (Delete Validation List) Command Description

DLTVLDDL Command syntax diagram

Purpose

The Delete Validation List (DLTVLDDL) command deletes the specified validation lists from a library.

Required Parameter

VLDL Specifies the qualified name of the validation lists being deleted. A specific validation list or a generic validation list can be specified; either type can be optionally qualified by a library name.

The possible library values are:

***LIBL:** All libraries in the user and system portions of the job's library list are searched.

***USRLIBL:** Only the libraries listed in the user portion of the library list are searched.

***CURLIB:** The current library for the job is searched. If no library is specified as the current library for the job, the QGPL library is used.

***ALL:** All libraries in the system, including QSYS, are searched.

***ALLUSR:** All nonsystem libraries, including all user-defined libraries and the QGPL library, not just those in the job's library list, are searched. Libraries whose names start with the letter Q, other than the QGPL library, are not included.

library name: Specify the name of the library to be searched.

validation-list-name: Specify the qualified name of the validation list being deleted.

generic-validation-list-name:* Specify the generic name of the validation list being deleted. A generic name is a character string of one or more characters followed by an asterisk (*); for example, ABC*. If a generic name is specified, then all validation list with names that begin with the generic name, and for which the user has authority, are deleted. If an asterisk is not included with the generic (prefix) name, the system assumes it to be the complete validation list name.

For more information on the use of generic functions, see generic functions.

Example for DLTVLDDL

```
DLTVLDDL VLDL(WEBLIB/WEBUSRS)
```

This command deletes the validation list named WEBUSRS from the library WEBLIB if the user has the proper authority for the validation list and the library.

DLTWSCST (Delete Work Station Customizing Object) Command Description

Purpose

The Delete Work Station Customizing Object (DLTWSCST) command allows the user to delete a work station customizing object.

Required Parameters

WSCST

Specifies the qualified name of a work station customizing object to be deleted.

The name of the work station customizing object can be qualified by one of the following library values:

***LIBL:** All libraries in the job's library list are searched until the first match is found.

***CURLIB:** The current library for the job is searched. If no library is specified as the current library for the job, the QGPL library is used.

library-name: Specify the name of the library to be searched.

object-name: Specify the name of the object that is deleted.

Example for DLTWSCST

```
DLTWSCST WSCST(MYLIB/PERSONNEL)
```

This command deletes the work station customizing object named PERSONNEL.

Error messages for DLTWSCST

DSCJOB (Disconnect Job) Command Description

DSCJOB Command syntax diagram

Purpose

The Disconnect Job (DSCJOB) command allows the interactive user to disconnect all the jobs at the work station and return to the sign-on display.

Restrictions:

1. A job being disconnected must be an interactive job.
2. A job which is being held cannot be disconnected.
3. A pass-through job cannot be disconnected unless the user has used the system request to return the source system from the pass-through target.

- The command must be issued from within the job being disconnected, or the issuer of the command must be running under a user profile which is the same as the job user identity of the job being disconnected, or the issuer of the command must be running under a user profile which has job control (*JOBCTL) special authority.

The job user identity is the name of the user profile by which a job is known to other jobs. It is

described in more detail in Work Management  book.

- A job cannot be disconnected if PC organizer is active.

Optional Parameters

LOG Specifies whether the job log for this interactive job is deleted or is included in the job's spooled output for printing. This entry takes precedence over the LOG parameter value specified for the job. This parameter only has meaning if the disconnected job is canceled due to exceeding the disconnect time interval. The time interval is defined by the system value QDSCJOBITV.

***NOLIST:** The information in the job log is deleted.

***LIST:** The job log is spooled for printing with the job's spooled output.

DROP Specifies whether the switched line attached to the work station is disconnected (dropped) if no other work stations on the same line are signed on. This parameter is ignored if the work station is attached to a nonswitched line.

***DEVD:** The value specified on the DROP parameter of the work station's device description is assumed.

***YES:** The switched line is disconnected when the job is disconnected if no other work stations are signed on the line.

***NO:** The switched line is not disconnected when the job is disconnected.

JOB Specifies the name of a job being disconnected from a work station. The job or jobs that are disconnected from a work station can be reconnected when the user again signs on the same work station.

A job identifier is a qualified name with up to three elements. For example:

```
job-name  
user-name/job-name  
job-number/user-name/job-name
```

More information on this parameter is in commonly used parameters.

Note: The user must have *JOBCTL authority to specify the name of an active or interactive job.

job-name: Specify the name of the job that is being disconnected. If no job qualifier is given, all jobs currently in the system are searched for the name of the job. If duplicates of the specified name are found, a qualified job name must be specified. The qualified job name includes the user name and/or the job number.

user-name: Specify the name of the user who owns the job. Specifying the user as a qualifier is necessary only if a duplicate job name exists for different users. If a duplicate job name exists for the same user, the job must be qualified with the job number.

job-number: Specify the job number. Specifying the job number as a qualifier is necessary only if a duplicate job name exists for the same user.

DUPJOB OPT

Specifies the action taken when duplicate jobs are found by this command.

***SELECT:** The selection display is shown when duplicate jobs are found during an interactive session. Otherwise, a message is issued.

***MSG:** A message is issued when duplicate jobs are found.

Examples for DSCJOB

Example 1: Disconnecting All Interactive Jobs

DSCJOB

This command enables the user of the work station to disconnect all the interactive jobs associated with the work station. The switched line is dropped only if that is specified in the work station device description of this work station and if no other work station on this line is active. If the job is disconnected when the disconnect interval in the QDSCJOBTV system value is reached, the job is ended and the job log is not included with the job's spooled output.

Example 2: Disconnecting Job Without Releasing Switched Line

DSCJOB LOG(*LIST) DROP(*NO)

This command disconnects the interactive job, but the switched line is not released. If the job is ended due to the QDSCJOBTV system value, the job log is included with the job's spooled output.

Example 3: Deleting Information in Job Log

DSCJOB LOG(*NOLIST) DROP(*DEV) JOB(123497/DEPT1/DSP04)

This command disconnects the interactive job 123497/DEPT1/DSP04 and any other jobs on that work station, for example, secondary jobs or group jobs. If the job is disconnected when the disconnect interval in the QDSCJOBTV system value is reached, the job is ended and the job log is not included with the job's spooled output. The work station device description is checked to determine whether the switched line is disconnected.

DSPACC (Display Access Code) Command Description

DSPACC Command syntax diagram

Purpose

The Display Access Code (DSPACC) command shows the access codes currently defined in the system. The display shows both the access code number and the descriptive text associated with the access code. The entries on the display are shown in numeric order from the lowest number to the highest number.

Optional Parameter

OUTPUT

Specifies whether the output from the command is shown at the requesting workstation or printed with the job's spooled output. More information on this parameter is in commonly used parameters.

*: Output requested by an interactive job is shown on the display. Output requested by a batch job is printed with the job's spooled output.

*PRINT: The output is printed with the job's spooled output.

Example for DSPACC

DSPACC

This command, if entered interactively, displays all access codes currently on the system.

Error messages for DSPACC

*ESCAPE Messages

CPF9845

DSPACCAUT (Display Access Code Authority) Command Description

DSPACCAUT Command syntax diagram

Purpose

The Display Access Code Authority (DSPACCAUT) command shows the access codes to which a user or group of users currently have authority. The display shows a list of user profile names, as well as the access codes to which each user is authorized. The access codes are in numeric sequence for each user.

Optional Parameters

USER Specifies the user profile name for which authorized access codes are displayed.

***CURRENT:** The user profile that is currently running is used.

***ALL:** All user profile names for users in the system distribution directory with access code authority are displayed, as well as the access codes to which those users have authority.

user-profile-name: Specify the name of the user profile for which the access codes are displayed. Up to 300 user profile names can be specified.

OUTPUT

Specifies whether the output from the command is shown at the requesting workstation or printed with the job's spooled output. More information on this parameter is in commonly used parameters.

***:** Output requested by an interactive job is shown on the display. Output requested by a batch job is printed with the job's spooled output.

***PRINT:** The output is printed with the job's spooled output.

Example for DSPACCAUT

```
DSPACCAUT USER(*CURRENT) OUTPUT(*PRINT)
```

This command prints all access codes to which the current user is authorized.

Error messages for DSPACCAUT

*ESCAPE Messages

CPF9022

Access code authority not displayed because error occurred.

CPF9845

Error occurred while opening file &1.

CPF9846

Error while processing file &1 in library &2.

CPF9847

Error occurred while closing file &1 in library &2.

CPF9850

Override of printer file &1 not allowed.

CPF9851

DSPACCGRP (Display Access Group) Command Description

Notes:

- This command is part of the 5722-PT1 (Performance Tools for iSeries) licensed program.
- You should not use this command because the Licensed Internal Code no longer uses process access groups for caching data used by a job.

DSPACCGRP Command syntax diagram

Purpose

The Display Access Group (DSPACCGRP) command shows, for each selected job, the process access group (PAG) size, the names and I/O counts for all open files, and the program data storage used. It also optionally writes this information to a database file for further analysis by the Analyze Process Access Group (ANZACCGRP) command.

Jobs can be selected for the report by using several criteria, including job type, job name, user name, and job number. The job and user names may be generic; only the first characters of the corresponding information for a job must match the specified value for selection of the job. Only jobs that match all specified criteria are selected.

Optional Parameters

JOB Specifies the jobs being selected. The parameter value specified can be a special single value or a three-part job identifier. If no job qualifier is given, all of the jobs currently in the system are searched for the name of the job. If duplicates of the specified name are found, a qualified job name must be specified.

A job identifier is a special value or a qualified name with up to three elements. For example:

```
*
*SEC
*INT
*ALL
job-name
user-name/job-name
job-number/user-name/job-name
```

***:** Only the current job is selected.

***SEC:** The secondary interactive job is selected (when system request is used to switch between two jobs, *SEC is the job opposite the current job).

***INT:** All interactive jobs are selected.

If the value is other than one of the preceding values, it is interpreted as a three-part job identifier (although all three parts need not be specified).

***ALL:** All of the jobs are selected.

job-name: Specify the name of the job to select. This may be *ALL, a specific job name, or a generic job name (a name ending in *). Because several jobs may be running with the same job name, this value may not uniquely identify a specific job.

user-name: Specify the name of the user of the job to select. This may be *ALL, a specific user name, or a generic user name (a name ending in *). Because several jobs may be running with the same user name, this value may not uniquely identify a specific job.

job-number: Specify the number of the job to select. This can be either *ALL (select all active jobs that meet the other selection values) or the 6-digit number that uniquely identifies the job in the system. All six digits must be entered. Use leading zeros if necessary.

TITLE Specifies a short title that is printed in the heading at the top of each page of the report.

***BLANK**: No title is used.

'report-title': Specify a title of up to 30 characters, enclosed in apostrophes.

OUTPUT

Specifies the type of output to produce. If OUTPUT(*) or OUTPUT(*PRINT) is specified, the MBR, LIB, and CLEAR parameters are ignored.

*****: If parameter values are specified that result in more than one job being selected (such as JOB(*ALL) or a generic job name), this option is equivalent to specifying *PRINT. Otherwise, the job's process access group information is displayed at the workstation.

***PRINT**: The output is written to the printer file QPPTPAG.

***FILE**: The output is saved in the database file QAPTPAGD for later analysis with ANZACCGRP. This is useful when several jobs are selected.

***BOTH**: The output is saved in the database file (*FILE option). It is also either displayed or printed (* option).

MBR Specifies the member in file QAPTPAGD in which the process access group data is saved. If the member does not exist, it is added to the file. If the member exists, the new data extends or replaces the old contents, depending on the CLEAR parameter value.

QAPAGDTA: The standard member name, QAPAGDTA, is used.

member-name: Specify the name of an alternate member in which the data is saved. This allows you to keep more than one set of process access group data.

LIB Specifies the name of the library where the object is saved. If the library does not contain a file name QAPTPAGD, one is created.

QPFRDATA: The process access group data is stored in the IBM-supplied performance data library, QPFRDATA.

library-name: Specify the name of an alternate library where the process access group data is recorded. This is necessary if, for example, access to the default library is not allowed.

CLEAR

Specifies whether to overwrite or append existing data in the specified member.

***YES**: Existing data is overwritten by the new data.

***NO**: Existing data is kept, and the new data is appended to it. This may be used to accumulate process access group data on more than one set of jobs.

Examples for DSPACCGRP

Example 1: Displaying Access Group Information

```
DSPACCGRP JOB(GL*)
```

This command selects all active jobs with names starting with GL. Because GL* is not one of the special single values, it is interpreted as a three-part job identifier. Because only one part is given, it is taken to be the job name, and the job number and user name default to *ALL. Because no OUTPUT value is specified, output is displayed if there is only one GL job. A report is spooled if there is more than one GL job.

Example 2: Writing Access Group Information to a Database File

```
DSPACCGRP JOB(*ALL) OUTPUT(*FILE) MBR(SAMPLE1)
```

This command writes the process access group information for all active jobs to member SAMPLE1 of the database file QPFRDATA/QAPTPAGD for later analysis by the ANZACCGRP command.

Example 3: Displaying All Access Group Information for a Job

```
DSPACCGRP JOB(001234/*ALL/*ALL)
```

This command displays the process access group information for job number 001234. Since the job number is guaranteed to uniquely identify the job, a report cannot be spooled (no more than one job can be selected).

Example 4: Displaying Access Group Information for a Job

```
DSPACCGRP JOB(WILLIAMS/AP*)
```

This command selects all jobs with a user name of WILLIAMS and a job name beginning with AP.

DSPACTSCD (Display Activation Schedule) Command Description

DSPACTSCD Command syntax diagram

Purpose

The Display Activation Schedule (DSPACTSCD) command displays user profiles with their enable and disable time, and the days the profiles will be activated. This information is in file QASECACT in library QUSRSYS and was gathered from the Change Activation Schedule Entry (CHGACTSCDE) command.

Restrictions:

You must have *ALLOBJ special authority to use this command.

Optional Parameter

OUTPUT

Specifies whether the output from the command is shown at the requesting workstation or printed with the job's spooled output. More information on this parameter is in commonly used parameters.

***:** The output is displayed (if requested by an interactive job) or printed with the job's spooled output (if requested by a batch job).

***PRINT:** The output is printed with the job's spooled output.

Example for DSPACTSCD

```
DSPACTSCD OUTPUT(*PRINT)
```

The activation schedule is printed with the job's spooled output.

Error messages for DSPACTSCD

*ESCAPE Messages

CPFB304

User does not have required special authorities.

DSPACTPJ (Display Active Prestart Jobs) Command Description

DSPACTPJ Command syntax diagram

Purpose

The Display Active Prestart Jobs (DSPACTPJ) command displays statistics and performance information for active prestart jobs associated with a prestart job entry in an active subsystem. All information on the display is collected from the time the prestart job entry is started (either at subsystem startup or when the STRPJ command is run for this entry), or from the time the reset key is pressed.

Restriction: This command is restricted to a user with *USE authority.

Required Parameters

SBS Specifies the name of the active subsystem that contains the active prestart jobs.

PGM Specifies the qualified name of the program in the active prestart job entry.

The name of the program can be qualified by one of the following library values:

***LIBL:** All libraries in the job's library list are searched until the first match is found.

***CURLIB:** The current library for the job is searched. If no library is specified as the current library for the job, the QGPL library is used.

library-name: Specify the name of the library to be searched.

program-name: Specify the name of the program in the active prestart jobs.

Optional Parameter

OUTPUT

Specifies whether the output from the command is being shown at the requesting work station or printed with the job's spooled output. More information on this parameter is in commonly used parameters.

***:** Output requested by an interactive job is shown on the display. Output requested by a batch job is printed with the job's spooled output.

***PRINT:** The output is printed with the job's spooled output.

Examples for DSPACTPJ

Example 1: Displaying Job Information

```
DSPACTPJ SBS(PJSBS) PGM(QGPL/PGM1)
```

This command displays information for the prestart job entry in subsystem PJSBS with program PGM1 in the QGPL library.

Example 2: Printing Job Information

```
DSPACTPJ SBS(PJSBS) PGM(QGPL/PGM2) OUTPUT(*PRINT)
```

This command prints active prestart job information for the prestart job entry in the active subsystem PJSBS with program PGM2 in the QGPL library.

DSPACTPRFL (Display Active Profile List) Command Description

DSPACTPRFL Command syntax diagram

Purpose

The Display Active Profile List (DSPACTPRFL) command displays the list of user profiles that will always be considered active and therefore will not be disabled by the Analyze Profile Activity (ANZPRFACT) command function. Those IBM user profiles which are never considered to be inactive will not be listed. This information was gathered from the Change Active Profile List (CHGACTPRFL) command. If the Display Active Profile List (DSPACTPRFL) command is issued before the CHGACTPRFL command, an empty report will be produced.

You must have *ALLOBJ special authority to run this command.

Optional Parameter

OUTPUT

Specifies whether the output from the command is shown at the requesting workstation or printed with the job's spooled output. More information on this parameter is in commonly used parameters.

***:** The output is displayed (if requested by an interactive job) or printed with the job's spooled output (if requested by a batch job).

***PRINT:** The output is printed with the job's spooled output.

Example for DSPACTPRFL

```
DSPACTPRFL OUTPUT(*PRINT)
```

The list of profiles that are always considered active by the Analyze Profile Activity (ANZPRFACT) are printed with the job's spooled output.

Error messages for DSPACTPRFL

DSPAPPNINF (Display APPN Information) Command Description

DSPAPPNINF Command syntax diagram

Purpose

The Display APPN Information (DSPAPPNINF) command provides the user with Advanced Peer-to-Peer Networking (APPN) network information which is used to assist in problem analysis. The user specifies one basic type of network information being shown, printed, or stored in an output file: information about the network topology, the local directory, or session information.

Optional Parameters

INFTYPE

Specifies the type of information that is shown or printed.

***TOPOLOGY:** The contents of the topology database is shown or printed. This consists of the set of all nodes in the network, their characteristics, and the set of link destination nodes along with the characteristics of the connecting links for each node.

***LCLNODE:** The contents of the local directory is shown or printed. This consists of the local node and the names of all remote control points for which information exists in the local directory.

***SSN:** Information about intermediate sessions or sessions that have the local node as a session end point is shown or printed.

NODES

Specifies which set of nodes will be displayed. This parameter is only valid when INFTYPE(*TOPOLOGY) is specified.

***ALL:** Information about all nodes in the network is printed or displayed.

***ACTIVE:** Information about all network nodes that have at least one active link is printed or displayed.

***INACTIVE:** Information about all network nodes that have no active links is printed or displayed.

SSNTYPE

Specifies which type of session information is shown. This parameter is valid only when INFTYPE(*SSN) is specified.

***ENDPNT:** Information about sessions for which the local node is a session end point is shown or printed.

***INMSSN:** Information about intermediate sessions being routed through the local node is shown or printed.

JOB Specifies the name of the job for which session information is shown or printed. If OUTPUT(*) is specified and no job name is specified, a list of APPN job names run since the most recent initial program load (IPL) of the system is shown. A job name can be selected from that list. If OUTPUT(*PRINT) or OUTPUT(*OUTFILE) is specified without a job name, the session information for all APPN jobs is printed or stored in a specified output file.

A job identifier is a special value or a qualified name with up to three elements. For example:

```
job-name  
user-name/job-name  
job-number/user-name/job-name
```

This parameter is valid only if SSNTYPE(*ENDPNT) is specified.

More information on this parameter is in commonly used parameters.

CTL Specifies the controller description name for which intermediate session information is displayed or printed. This parameter is valid only if SSNTYPE(*INMSSN) is specified.

***ALL:** Intermediate session information for all controllers will be displayed or printed.

controller-description-name: Specify the name of the controller description for which intermediate information will be displayed or printed.

OUTPUT

Specifies whether the output from the command is shown at the requesting workstation or printed with the job's spooled output. More information on this parameter is in commonly used parameters.

***:** The requested data is shown on the display station.

***PRINT:** The output is printed with the job's spooled output.

***OUTFILE:** The output is directed to the database file specified on the OUTFILE parameter.

OUTFILE

Specifies the qualified name of the output file that is used to store the requested APPN information. This parameter is valid only if OUTPUT(*OUTFILE) is specified.

The name of the file can be qualified by one of the following library values:

***LIBL:** All libraries in the job's library list are searched until the first match is found.

***CURLIB:** The current library for the job is searched. If no library is specified as the current library for the job, the QGPL library is used.

library-name: Specify the name of the library to be searched.

file-name: Specify the name of the file that is used to store the requested APPN information.

OUTMBR

Specifies the name of the database file member to which the output is directed. This parameter is valid only if OUTPUT(*OUTFILE) is specified.

Element 1: Member to Receive Output

***FIRST:** The requested APPN information is stored in the first file member.

member-name: Specify the name of the output file member used to store the requested APPN information. The member name can be from 1 to 10 characters in length.

Element 2: Operation to Perform on Member

***REPLACE**: The system clears the existing member and adds the new records.

***ADD**: The system adds the new records to the end of the existing records.

Examples for DSPAPPNINF

Example 1: Printing a List

```
DSPAPPNINF  INFTYPE(*TOPOLOGY)
            NODES(*ALL)  OUTPUT(*PRINT)
```

This command prints the list of all nodes currently existing in the APPN network, the set of links destination nodes associated with each node, and the link characteristics for each link.

Example 2: Showing a List of PCIDs

```
DSPAPPNINF  INFTYPE(*SSN)  SSNTYPE(*ENDPNT)
            JOB(APPNJOB/USERPROF/000001)  OUTPUT(*)
```

This command shows a list of procedure correlation session identifiers (PCIDs) associated with the job name APPNJOB/USERPROF/000001. From this list, the user can specify an option to show additional information about a session.

Example 3: Storing Contents of a Directory

```
DSPAPPNINF  INFTYPE(*LCLNODE)  OUTPUT(*OUTFILE)
            OUTFILE(USERLIB/APPNFILE)  OUTMBR(*FIRST, *REPLACE)
```

This command stores the contents of the local directory in the first member of an output file named USERLIB/APPNFILE. If information already exists in this member, the new information replaces the existing information.

The Display ASP Information (DSPASPBRM) command shows you the Display ASP Information using BRM display. This display shows you a summary of all auxiliary storage pools (ASPs) that are set up and various statistical information about the ASPs on your system.

Example for DSPASPBRM

Example 1: Printing the Display ASP Information Report

```
DSPASPBRM  OUTPUT(*PRINT)
```

In this example the Display ASP Information report is printed.

DSPAUDJRNE (Display Audit Journal Entries) Command Description

DSPAUDJRNE Command syntax diagram

Purpose

The Display Audit Journal Entries (DSPAUDJRNE) command allows you to generate security journal audit reports. The reports are based on the audit entry types and the user profile specified on the command. Reports can be limited to specific time frames and detached journal receivers can be searched. The reports are directed to the active display or a spooled file.

Restrictions:

You must have *ALLOBJ and *AUDIT special authorities to use this command.

Optional Parameters

ENTTYP

Specifies the journal entry types to be included in the report.

AF: Authorization failure entries.

CA: Change authority entries.

CD: Command string entries.

CO: Create object entries.

CP: Change user profile entries.

CU: Cluster management operations.

CV: Connection verification.

DO: Delete object entries.

EV: Environment variable operations.

GR: Generic record.

IP: Interprocess communication.

JS: Actions against jobs entries.

ND: Directory search filter violations.

NE: End point filter violations.

OM: Object move or rename.

OR: Object restored entries.

OW: Object ownership changed entries.

PA: Program changed to adopt authority.

PG: Change of an object's primary group.

PO: Printed output entries.

PS: Profile swap.

PW: Invalid password entries.

SF: Action on spooled files entries.

SO: Server security user information actions.

SV: System values changed entries.

VO: Validation list successful and unsuccessful verify entries.

YC: DLO (document library object) object changed entries.

YR: DLO object read entries.

ZC: Object changed entries.

ZR: Object read entries.

USRPRF

Journal entries created for a user profile's actions are included in the report.

***ALL:** The report will include entries for all user profiles.

user-profile-name: Specify the name of the user profile whose journal entries are to be included in the report.

JRNRCV

Specifies the name of the starting (first) and ending (last) journal receivers whose journal entries are searched.

Note:

If the maximum number of receivers (256) in the range is surpassed, an error occurs and no journal entries are converted.

***CURRENT:** Journal entries in the currently attached journal receiver are searched.

***CURCHAIN:** Journal entries in the currently attached journal receiver chain are searched. If there is a break in the chain, the receiver range is from the most recent break in the chain through the receiver that is attached when starting to convert journal entries.

Element 1: Starting Journal Receiver

The name of the starting journal receiver can be qualified by one of the following library values:

***LIBL:** The library list is used to locate the journal receiver.

***CURLIB:** The current library for the job is used to locate the journal receiver. If no library is specified as the current library for the job, QGPL is used.

library-name: Specify the library where the journal receiver is located.

starting-journal-receiver: Specify the name and library of the first journal receiver from which entries are searched.

Element 2: Ending Journal Receiver

***CURRENT:** The journal receiver that is currently attached is used.

The name of the ending journal receiver can be qualified by one of the following library values:

***LIBL:** The library list is used to locate the journal receiver.

***CURLIB:** The current library for the job is used to locate the journal receiver. If no library is specified as the current library for the job, QGPL is used.

library-name: Specify the library where the journal receiver is located.

ending-journal-receiver: Specify the name and library of the last journal receiver from which entries are searched.

FROMTIME

Specifies the date and time of the first journal entry to be searched.

***FIRST:** The first journal entry in the journal receiver becomes the starting point for the range of entries to be searched.

Element 1: Starting entry date

starting-date: Specify the starting date. The starting date and time of the first journal entry occurring at or after the specified starting date and time becomes the starting point for the range of entries to be searched.

Element 2: Starting entry time

starting-time: Specify the starting time. The starting date and time of the first journal entry occurring at or after the specified starting date and time becomes the starting point for the range of entries to be searched.

TOTIME

Specifies the creation date and time of the last journal entry to be searched.

***LAST:** The last journal entry in the journal receiver becomes the ending point for the range of entries to be searched.

Element 1: Ending entry date

ending-date: Specify the ending date. The ending date and time of the first journal entry occurring at or before the specified ending time on the specified ending date becomes the ending point for the range of entries to be searched.

Element 2: Ending entry time

ending-time: Specify the ending time. The ending date and time of the first journal entry occurring at or before the specified ending time on the specified ending date becomes the ending point for the range of entries to be searched.

OUTPUT

Specifies whether the output from the command is shown at the requesting workstation or printed with the job's spooled output. More information on this parameter is in commonly used parameters.

***PRINT:** The output is printed with the job's spooled output.

*****: The output is shown (if requested by an interactive job) or printed with the job's spooled output (if requested by a batch job).

Example for DSPAUDJRNE

```
DSPAUDJRNE  ENTYP(AF)  OUTPUT(*)
```

A report containing all 'Authority Failure' audit records in the current journal receiver will be displayed on the active workstation.

Error messages for DSPAUDJRNE

DSPAUT (Display Authority) Command Description

DSPAUT Command syntax diagram


Purpose

The Display Authority (DSPAUT) command shows the list of authorized users of an object and their authorities for the object. If the object is secured by an authorization list, the name of the authorization list is also shown.

The following are shown for the specified object:

- The object path name.
- The name of the object's owner.
- The name of the object's primary group.
- The name of the authorization list securing the object.
- A list of all the users who are authorized to use the object.
- The authorities that each user has for the object.

If an object does not have an owner name associated with it, no authorities for the object are shown.

See Appendix D of the iSeries Security Reference  book for the authorities required to use this command.

For more information about integrated file system commands, see Integrated file system topic in the File systems and management category of the Information Center.

Required Parameter

OBJ Specifies the path name of the object for which the authorized users and their authorities are displayed. For more information on specifying path names, refer to path names

Optional Parameter

OUTPUT

Specifies whether the output from the command is shown at the requesting work station or printed with the job's spooled output.

*****: Output requested by an interactive job is shown on the display. Output requested by a batch job is printed with the job's spooled output.

***PRINT**: The output is printed with the job's spooled output.

Examples for DSPAUT

Example 1: Displaying Users and Authorities

```
DSPAUT OBJ('/QSYS.LIB/ARLIB.LIB/PROG1.PGM')
```

This command shows the authorized users and their authorities for the object named PROG1 to the user who entered the command, if that user has object management authority for the object. PROG1 is a program located in the library named ARLIB. The system assumes * for the device that shows the output list. If the command was entered in the batch subsystem, the output is placed in the default output queue for the job. If the command was entered in the interactive subsystem, the output is shown on the device where the user entered the command.

Example 2: Printing List of Users


```
DSPAUT  OBJ('/MYDIR/MYOBJECT')  
OUTPUT(*PRINT)
```

This command causes the list of authorized users of MYOBJECT in the MYDIR directory to be printed.

DSPAUTHLR (Display Authority Holder) Command Description

DSPAUTHLR Command syntax diagram

Purpose

The Display Authority Holder (DSPAUTHLR) command shows a list of authority holders. The list shows the name of the object that the authority holder secures, the name of the library where the object is found, the object type, the owner of the object, and the primary group of the object.

Optional Parameters

OUTPUT

Specifies whether the output from the command is shown at the requesting work station, printed with the job's spooled output, or directed to a database file. More information on this parameter is in Commonly used parameters.

***:** Output requested by an interactive job is shown on the display. Output requested by a batch job is printed with the job's spooled output.

***PRINT:** The output is printed with the job's spooled output.

***OUTFILE:** The output is directed to the database file specified on the OUTFILE parameter.

OUTFILE

Specifies the name of the database file to which the output of the display is directed. If this file does not exist, this command creates a database file in the specified library. If the file is created by this function, the text is 'Outfile for DSPAUTHLR' and the public authority is *EXCLUDE.

The name of the database file can be qualified by one of the following library values:

***LIBL:** All libraries in the job's library list are searched until the first match is found.

***CURLIB:** The current library for the job is searched. If no library is specified as the current library for the job, the QGPL library is used.

library-name: Specify the name of the library to be searched.

database-file-name: Specify the name of the database file that receives the output of the display.

OUTMBR

Specifies the name of the database file member to which the output is directed.

Element 1: Member to Receive Output

***FIRST:** The first member in the file receives the output. If OUTMBR(*FIRST) is specified and the member does not exist, the system creates a member with the name of the file specified on the OUTFILE parameter. If the member already exists, the user has the option to add new records to the end of the existing member or clear the member and then add the new records.

member-name: Specify the file member that receives the output. If OUTMBR(member-name) is specified and the member does not exist, the system creates it. If the member already exists, the user has the option to add new records to the end of the existing member or clear the member and then add the new records.

Element 2: Operation to Perform on Member

***REPLACE:** The system clears the existing member and adds the new records.

***ADD:** The system adds the new records to the end of the existing records.

Example for DSPAUTHLR

DSPAUTL R OUTPUT(*PRINT)

This command sends the display of the authority holder list to the printer.

No error messages.

DSPAUTL (Display Authorization List) Command Description

DSPAUTL Command syntax diagram

Purpose

The Display Authorization List (DSPAUTL) command shows the list of users (and their levels of authority) that make up the authorization list.

The owner of the authorization list, and any user who is not specified as *EXCLUDE on the authorization list, can view the whole list of users and their authorities when they display an authorization list. The authority to see the list may be from a user's group profiles or may have been adopted.

When an authorization list is first shown, the specific authorities shown are determined by the level of detailed information specified on the USROPT parameter in the user profile.

When the DSPAUTL command is used to display an authorization list, the user specifies the name of the authorization list, whether the authorization list should be shown on the display or sent to a printer, or (optionally) whether the output should be sent to an OUTFILE.

Required Parameter

AUTL Specifies the name of the authorization list to be shown.

Optional Parameters

OUTPUT

Specifies whether the output is sent to the display, to a printer file, or to a database file. More information on this parameter is in Commonly used parameters.

***:** Output requested by an interactive job is shown on the display. Output requested by a batch job is printed with the job's spooled output.

***PRINT:** The output is printed with the job's spooled output.

***OUTFILE:** The output is directed to the database file specified on the OUTFILE parameter.

OUTFILE

Specifies the name of the database file to which the output of the display is directed. If the OUTFILE does not exist, this command creates a database file in the specified library. If the file is created by this function, the descriptive text is 'Outfile for DSPAUTL' and the public authority is *EXCLUDE. The database format (QSYDSAUT) of the output file is the same as that used in the IBM-supplied database file QAOBJAUT.

The name of the database file can be qualified by one of the following library values:

***LIBL:** All libraries in the job's library list are searched until the first match is found.

***CURLIB:** The current library for the job is searched. If no library is specified as the current library for the job, the QGPL library is used.

library-name: Specify the name of the library to be searched.

database-file-name: Specify the name of the database file that receives the output of the display.

OUTMBR

Specifies the name of the database file member to which the output is directed.

Element 1: Member to Receive Output

***FIRST:** The first member in the file receives the output. If OUTMBR(*FIRST) is specified and the member does not exist, the system creates a member with the name of the file specified on the OUTFILE parameter. If the member already exists, the option exists to add new records to the end of the existing outfile member or clear the member and add the new records.

member-name: Specify the file member that receives the output. If OUTMBR(member-name) is specified and the member does not exist, the system creates it. If the member already exists, the option exists to add new records to the end of the existing outfile member or clear the member and add the new records.

Element 2: Operation to Perform on Member

***REPLACE:** The system clears the existing member and adds the new records.

***ADD:** The system adds the new records to the end of the existing records.

Example for DSPAUTL

```
DSPAUTL  AUTL(DEPT48X)  OUTPUT(*PRINT)
```

This command sends the display of the authorization list to the printer.

No error messages.

DSPAUTLDLO (Display Authorization List Document Library Objects) Command Description

DSPAUTLDLO Command syntax diagram

Purpose

The Display Authorization List Document Library Objects (DSPAUTLDLO) command shows the list of documents and folders whose access security is specified by the authorization list specified in the AUTL parameter.

Restrictions:

1. If a user on the list has authority other than *EXCLUDE, or is not on the list and public authority is something other than *EXCLUDE, that user is authorized to display the documents and folders.
2. If the user is not authorized to the document or folder because access authorities are private, the document library object is marked "not authorized" in the text field.

Required Parameter

AUTL Specifies the name of the authorization list whose list of documents and folders is displayed.

Optional Parameter

OUTPUT

Specifies whether the output from the command is shown at the requesting workstation or printed with the job's spooled output. More information on this parameter is in Commonly used parameters.

***:** Output requested by an interactive job is shown on the display. Output requested by a batch job is printed with the spooled output of the job.

***PRINT:** The output is printed with the job's spooled output.

Example for DSPAUTLDLO

```
DSPAUTLDLO AUTL(PAYROLL) OUTPUT(*PRINT)
```

This command sends the display output for the authorization list named PAYROLL to a printer.

DSPAUTOBJ (Display Authorization List Objects) Command Description

DSPAUTOBJ Command syntax diagram

Purpose

The Display Authorization List Objects (DSPAUTOBJ) command shows the list of objects that are secured by the authorization list specified in the AUTL parameter. If a user is on the list with authority other than *EXCLUDE, or is not on the list and public authority is something other than *EXCLUDE, the user is authorized to display the objects. If the user is not authorized to an object because of private authorities, the object is marked *not authorized* in the text field.

Required Parameter

AUTL Specifies the name of the authorization list whose list of objects is shown.

Optional Parameters

OUTPUT

Specifies whether the output from the command is shown at the requesting work station, printed with the job's spooled output, or directed to a database file.

More information on this parameter is in Commonly used parameters.

*: Output requested by an interactive job is shown on the display. Output requested by a batch job is printed with the job's spooled output.

***PRINT**: The output is printed with the job's spooled output.

***OUTFILE**: The output is directed to the database file specified on the OUTFILE parameter.

OUTFILE

Specifies the qualified name of the database file to which the output of the display is directed. If this file does not exist, this command creates a database file in the specified library. If the file is created by this function, the text is 'Outfile for DSPAUTLOBJ' and the public authority is *EXCLUDE.

The name of the database file can be qualified by one of the following library values:

***LIBL**: All libraries in the job's library list are searched until the first match is found.

***CURLIB**: The current library for the job is searched. If no library is specified as the current library for the job, the QGPL library is used.

library-name: Specify the name of the library to be searched.

database-file-name: Specify the name of the database file that receives the output of the display.

OUTMBR

Specifies the name of the database file member to which the output is directed.

Element 1: Member to Receive Output

***FIRST**: The first member in the file receives the output. If OUTMBR(*FIRST) is specified and the member does not exist, the system creates a member with the name of the file specified on the OUTFILE parameter. If the member already exists, the user has the option to add new records to the end of the existing member or to clear the existing member and then add the new records.

***REPLACE**: The system clears the existing member and adds the new records.

DSPAUTOBJ AUTL(PAYROLL) OUTFILE(*LIBL/PAYROLL)
OUTMBR(DARL *REPLACE)
```

This command places the output in the database file PAYROLL, member name DARL. If member DARL already exists, the system clears it and adds the new records.

DSPAUTUSR (Display Authorized Users) Command Description

DSPAUTUSR Command syntax diagram

Purpose

The Display Authorized Users (DSPAUTUSR) command displays or prints the names of the authorized system users, in alphabetic order. The following information is provided for each user: the group profile of which the user is a member, the most recent password change date, whether the user profile has a password, the text of the user profile, whether the user profile has a password, the text of the user profile, whether the user has a password for password levels 0 or 1, whether the user has a password for password levels 2 or 3, and whether the user has a password for use with iSeries 400 Support for Windows Network Neighborhood (iSeries 400 NetServer).

Note: While this command is searching for user profile information to display, another job cannot change user profiles (for example, with the Change User Profile (CHGUSRPRF) command).

Restriction: The list of system users contains only the names of the user profiles to which the user of this command has at least read (*READ) authority.

Optional Parameters

SEQ Specifies whether the list of system users is in alphabetic sequence by user profile name or by group profile name.

***USRPRF:** The list is in alphabetic sequence by user profile name.

***GRPPRF:** The list is in alphabetic sequence by group profile name. The members of each group are listed in alphabetical order by user profile name.

OUTPUT

Specifies whether the output from the command is shown at the requesting work station or printed with the job's spooled output. More information on this parameter is in commonly used parameters.

*****: Output requested by an interactive job is shown on the display. Output requested by a batch job is printed with the job's spooled output.

***PRINT:** The output is printed with the job's spooled output.

Examples for DSPAUTUSR

Example 1: Displaying Authorized Users and Group Profile Names

```
DSPAUTUSR
```

This command shows the list of authorized users and their group profile names. The list is in alphabetic sequence by user profile name. OUTPUT(*) is also assumed; the list is shown on the display or printed depending on whether the command was submitted at a work station or as part of the batch input stream.

Example 2: Printing Output

```
DSPAUTUSR SEQ(*GRPPRF) OUTPUT(*PRINT)
```

This command causes authorized system user profile names and their group profile names to be printed. The output is printed in alphabetic sequence by group profile name.

CPF2237

Not authorized to display list of users.
