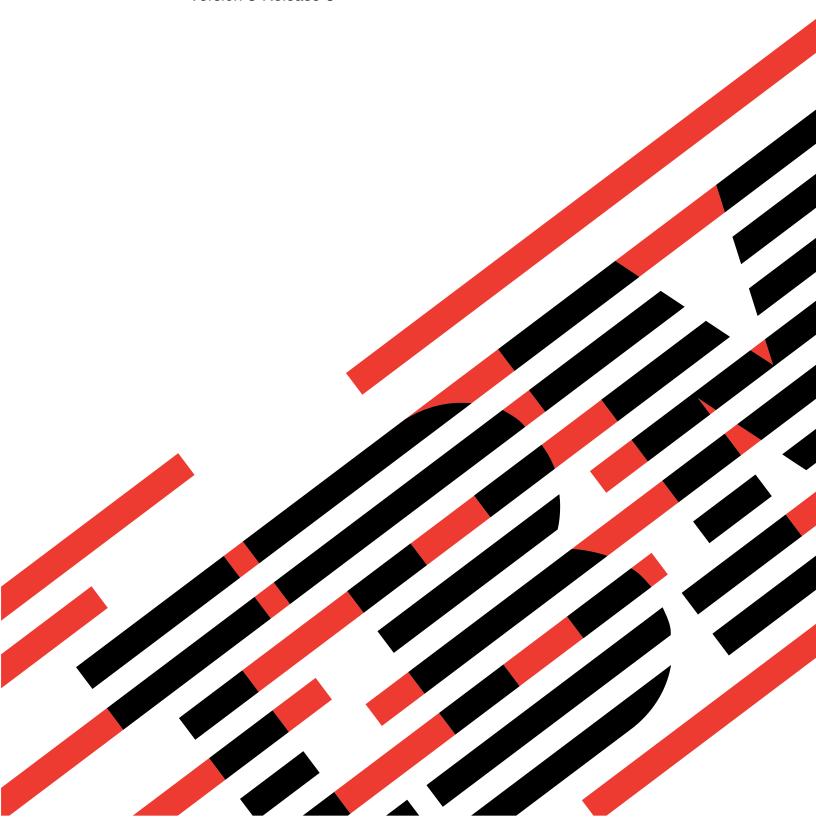

- 2. To verify that all your applications are running properly, use the server with the new software release until you feel comfortable with the new production environment. For example, many customers use the server for 2 weeks or longer.
- 3. Check job logs and server messages.

  Use this information to help you identify and fix any problems that might occur with the newly installed software.

Before upgrading to OS/400 V5R3M5, you must have a load-source disk unit of 17 GB or larger. To read the procedures to upgrade your load-source disk unit, see Checklist 11: Upgrade load source disk unit with device parity protection.
