

Chapter 1. Power supply and air moving device

Replacing and installing the power supply and air moving device are customer tasks. You may be able to install or replace a power supply or an air moving device with the unit powered on. When you use these instructions, you will perform some or all of the following tasks:

- Perform prerequisite tasks.
- Power down the system.
- Remove the system unit covers.
- Remove hardware.
- · Install new hardware.
- · Install covers.

You need to allow additional time to complete your jobs, back up your system, perform an initial program load (IPL) of your system, and verify your hardware configuration.

You can choose to perform these tasks yourself or contact IBM(R) or an authorized service provider to make arrangements for them to perform the tasks for a fee. Should you encounter difficulties when performing a task, contact your authorized dealer or service provider.

Chapter 2. Before you begin

Before	e you begin a replacement or installation task, follow these steps:
1.	For an installation and if possible, for a replacement, ensure that you have a current backup of your system (including operating system, licensed programs, and data). If you have backed up the operating system and licensed programs since the last time you applied PTFs, that backup is acceptable.
2.	Ensure that you take a few minutes to become familiar with these instructions.
3.	Ensure that you have access to a medium flat-bladed screwdriver.
4.	If there are incorrect, missing, or visibly damaged parts, contact one of the following:

Chapter 3. Replace power supply in iSeries 820 or 5075, 5095, or 0595 expansion unit

To perform this procedure with the system powered on, you must have the following:

- Three power supplies and two working air moving devices for the 820 system
- Two power supplies and two working air moving devices for the 5075 expansion unit
- two power supplies and four working air moving devices for the 5095 or 0595 expansion unit

If you need to replace an air moving device, go to Chapter 6, "Replace the air moving device," on page 13.



To install the power supply, follow these steps:

Note: The following figure is a power supply shown on an iSeries model 820. The power supply for the 5075 expansion unit is the same.




- __ 2. Slide the power supply into the system unit.
- __ 3. Move the handle up to lock in place.
- _ 4. Look at the back of the system unit. A green light on the power supply indicates that power is powered on.
- __ 5. Install side cover.
- __ 6. Plug the power cord into the power supply and into the outlet.
- ___ 7. Install back cover.
- _ 8. Power on the system. For instructions, refer to "Power on the system" on page 25.

Chapter 6. Replace the air moving device

You can replace an air moving device with the system unit powered on. To replace the air moving device, follow these steps:

- __ 1. Perform prerequisite tasks as described in Chapter 2, "Before you begin," on page 3.
- __ 2. Remove the front cover. Refer to "Remove the covers" on page 17.
- __ 3. Locate the air moving device to be replaced in the front of your system unit (B01 or B02). Refer to "Locations" on page 27.





- __ 6. The air moving device is running, but the green light will not light until the next power off and power on of the system.
- ___ 7. Install the front cover.
- __ 8. Place the air-moving-device filler plates in a safe place for future use. If the air moving devices are removed, install the air-moving-device filler plate.




820, 5075, or 5095 front cover

Remove the system unit or expansion unit front cover by gripping the sides of the cover A and pulling the cover toward you.




825 front cover

Remove the system unit front cover by gripping the sides of the cover A and pulling the cover toward you.




820, 5075, and 5095 side and back cover

- __ 1. Place your hand near the bottom of the back cover and lift up and out.
- __ 2. Remove the left side cover (view from back) by loosening the thumbscrews and sliding the cover from front to back until it stops.
- __ 3. Pull the cover out.




825 back cover

Remove the back cover only. Place your hand near the bottom of the back cover and lift up and out.

Power down the system

To power down the system, follow these steps:

- 1. If an Integrated xSeries Adapter (IXA) is present on the system, shut it down using OS/400 options.
- 2. Ensure that all jobs are complete.
- **3**. When all jobs are complete, type **pwrdwnsys *immed** on an iSeries command line and press Enter.
- 4. When the iSeries power down is complete, unplug any power cords, such as printers and displays, from electrical outlets.
- 5. Unplug the system or expansion unit power cord from the electrical outlet.

Power on the system

To power on the system, follow these steps:

1. DANGER

An electrical outlet that is not correctly wired could place hazardous voltage on metal parts of the system or the products that attach to the system. It is the customer's responsibility to ensure that the outlet is correctly wired and grounded to prevent an electrical shock. (RSFTD201)

Plug in the system unit and system unit console into an electrical outlet. Plug in everything you previously unplugged such as printers and displays.

2.	Is your system unit an iSeries 270, 800, 810 or 820, 825, 830, 840, 870, 890?			
	270, 800, or 810 : Continue with the next step.			
	820, 825, 830, 840, 870, 890 : Go to step 5.			
3.	Look at the Function/Data display on the control panel.			
4.	Does 01 B V=S appear in the Function/Data display with IPL mode Normal (OK) selected?			
	Yes: Go to step 7 on page 26.			
	No: Do the following:			
	a. Press the Mode Select button until the Manual mode indicator (a small hand) lights up.			
	b. Press the Increment/Decrement push button until 02 appears in the Function/Data display.			
	c. Press the Enter push button on the control panel.			
	d. Press the Increment/Decrement push button until B appears in the Function/Data display.			
	e. Press the Enter push button on the control panel.			
	f. Press the Increment/Decrement push button until \$ appears in the Function/Data display			
	g. Press the Enter push button on the control panel.			
	h. Press the Mode Select button until the Normal indicator (OK) lights up.			
	i. Press the Increment/Decrement push button until 01 appears in the Function/Data display.			
	j. Press the Enter push button on the control panel.			
	01 B S should appear in the Function/Display display. If it does not appear, repeat steps 4a through 4j. If it does, go to 7 on page 26.			
5.	Look at the Function/Data display on the control panel.			
6.	Does 01 B V=S appear in the Function/Data display?			
	Yes: Continue with the next step.			
	No: Do the following:			
	a. Press the Increment/Decrement push button until 02 appears in the Function/Data display.			
	b. Press the Enter push button on the control panel.			

c.	Press the Increment/Decrement push button until B appears in the Function/Data display.
d.	Press the Enter push button on the control panel.
e.	Press the Increment/Decrement push button until \$ appears in the Function/Data display
f.	Press the Enter push button on the control panel.
g.	Press the Increment/Decrement push button until 01 appears in the Function/Data display.
h.	Press the Enter push button on the control panel.
	01 B S should appear in the Function/Display panel. If it does appear, not repeat steps 6a on page 25 through 6h.
i.	Go to step 7.

7. Press the Power push button that is located on the iSeries control panel. There is approximately a 10-second delay before the power-on light comes on, and data appears in the Function/Data display.

Note: The system takes approximately 5 to 20 minutes to power on and complete an IPL. When the IPL is complete, 01 B N S appears in the Function/Data display.






