Chapter 1. Removable media device

Replacing and installing this feature are customer tasks. When you use these instructions, you will perform some or all of the following tasks:

- Perform prerequisite tasks.
- Power down the system unit.
- Remove the system unit covers.
- Remove hardware.
- Install new hardware.
- Install covers.
- IPL your operating system.
- Verify your new hardware configuration.

It will take approximately one hour to perform these tasks. You may need to allow additional time to complete your jobs, back up your system, IPL your system, and verify your hardware configuration.

You can choose to perform these tasks yourself or contact IBM(R) or an authorized service provider to make arrangements for them to perform the tasks for a fee. Should you encounter difficulties when performing a task, contact your authorized dealer or service provider.



To replace a removable media device, perform these tasks:

- ____ 1. Perform prerequisite tasks as described in Chapter 2, "Before you begin," on page 3.
- **___ 2**. "Power down the system unit" on page 31.
- **3**. Remove the "Unit Covers" on page 33.
- 4. If possible, use a wrist strap to prevent electrostatic discharge from damaging your hardware. If you do not have a wrist strap, touch a metal surface of the system or expansion unit before installing or replacing hardware.

If you received the 2209 Disposable Wrist Strap, follow these steps:

- $_$ a. Attach the disposable wrist strap. \square View video.
- ____b. When you unroll the strap, remove the liner from the copper foil at the end.
- ____ c. Attach the adhesive part of the copper foil to an **exposed**, **unpainted** metal surface on the frame of the unit.
- **Note:** Follow the same precautions you would use without the wrist strap. The 2209 Disposable Wrist Strap is for static control. It will not increase or decrease your risk of receiving electric shock when using or working on electrical equipment.
- ____ 5. Locate the removable media device to be replaced.
- ____ 6. Disconnect the signal (larger connector) and power (smaller connector) cables from the back of the device. Access to these connectors is from the side of the system unit.
- _____7. Pull the two latches that secure the device to the system unit frame forward until they stop.



- **8**. Remove the device by sliding it forward and out of the system unit. You may need to remove the filler blank above the control panel.
- ____ 9. Place the device in a static protective bag.
- ____10. Follow the steps in "Details: Install removable media devices in iSeries 270, 800, 810, or 820" on page 7 to install the new device.

- _____1. Find the package that contains the new removable media device and remove it from the package.
- ____ 2. Is the device you are installing an optical device?
 - ____ Yes: Continue with the next step.
 - **No**: Go to step 4 on page 8.
- _____ **3**. Refer to the following figures to place the optical device unit address jumpers




Figure 1. 6321 CD-ROM optical unit jumpers for location D07 (Models 270, 800 and 810) and D13 (Model 820)




Figure 2. 6330 DVD-RAM optical unit jumpers for location D07 (Models 270, 800 and 810) and D13 (Model 820)




Figure 3. DVD-ROM optical unit jumpers for location D07 (Models 270, 800 and 810) and D13 (Model 820)




Figure 4. Installing the removable media device

_____ 4. Align the device and slide it into the front of the system unit (Figure 4 on page 9) until the device is flush against the frame of your system unit.

- ____ 5. Push in the blue latches to secure the device to your system unit.
- ____ 6. Plug the power cable into the smaller connector on the back of the removable media device.
- 7. If you are not replacing an existing removable media device, you need to remove the tape from the end of the cable.
- **8**. Plug the signal cable into the larger connector on the back of the removable media device.

- _ 9. Do you have another removable media device to install?
 - **No**: Continue with the next step.
 - Yes: Repeat this procedure.
- ____10. Do you have any other adapter cards or devices to install?
 - ____ **No**: Continue with the next step.
 - _ Yes: If you have another device such as a disk unit, an adapter card, or a memory card to install, go to the instructions that came with that device.
- ____ 11. Go to "Completing the installation."

Completing the installation

- Install the system unit side cover by aligning the tabs on the top and bottom edge. Press forward and make sure that all tabs enter the slots. Slide the cover toward the front of the system unit until it stops and tighten the screws.
- ____ 2. Install the system unit covers.

 - ____h. Press the Enter push button on the control panel.
 - ____i. Press the Increment/Decrement push button until **01** appears in the Function/Data display.
 - ____j. Press the Enter push button on the control panel.
 - **01 B N S** should appear in the Function/Data display. If it does not, repeat steps 7a through 7i.
 - ____ k. Go to step 10 on page 11.
- **8**. Look at the Function/Data display on the control panel.
- ____ 9. Does 01 B V=S with Normal indicator (OK) illuminated appear in the Function/Data display?
 - _ Yes: Continue with the next step.

01 B S with Normal indicator (**OK**) illuminated appear in the Function/Data display. If it does not appear, repeat steps 9a on page 10 through 9j.

- ____ 10. Power on the workstation or PC that is your console.
- ____11. Press the system-unit power-on button. The power-on light will appear.

- ____f. Press F6 (Print the configuration) from the Hardware Service Manager display.
- _____g. Select Packaging hardware resources (systems, frames, cards, ...) from the *Hardware Service Manager* display.



- __ h. Type 9 (Hardware contained within package) in the *Opt* column next to the system or expansion unit on the *Packaging Hardware Resources* display. Press Enter.
- ____i. Scroll up or down until the removable media device you installed is shown.
- ____j. To return to the Main Menu, press F3 (Exit) three times and then press Enter.
- ____k. Place the configuration list where you can refer to it in the future.
- _____14. For information on how to make your removable media device operational, go to the Work with storage topic in the *Information Center*.
- ____ 15. Your feature installation is complete.




Figure 5. Installing removable media device

- _____ 4. Refer to Figure 5 and support the bottom of the removable media device as you slide it half way into the selected position. Do not push it any further.

- 9. The green light will stop blinking and remain on solid when you properly installed the removable media device.
- ____10. Return to the console and wait until the *Concurrent Maintenance Results* display appears. Press the Enter key.
- ____ 11. When the *Hardware Service Manager* menu appears, select the **Packaging hardware resources** (system, frames, cards...) option. Press the Enter key.
- ____12. On the *Packaging Hardware Resources* menu, enter a 9 in the *Opt* column next to the unit with the new removable media device. Press the Enter key.
- **13**. The *Description* and *Device Type-Model* will be displayed along with the position where your new removable media device was installed.




Figure 6. Installing the removable media device
