Chapter 1. Prepare to set up your expansion unit

Are you installing 0595 in a rack?

- ____ **No**: Continue with these instructions.
- **Yes:** Go to Chapter 5, "Install 0595 expansion unit in a rack," on page 23. Then return here and continue with the set up.

This chapter explains what you need to do before you set up your expansion unit. This includes the following tasks:

- 1. Unpack your expansion unit (refer to the instructions for unpacking that came with your expansion unit).
- 2. Plan layouts for your cables.
- 3. Power down your system unit. All sytem units in a cluster must be powered down.

Before you begin the installation process, carefully plan where you will install your new expansion unit. You should consider several factors that include size, security, and environmental factors. Before you set up your new expansion unit, refer to the *iSeries Information Center* Web site

Hardware requirements

If you are installing your new expansion unit directly to your system unit, you should remember these rules:

- You need to have an available or unused high speed link (HSL) connector.
- · You need to have an unused or available system power control network (SPCN) connector.

Identify HSL and SPCN cables

Use the following tables to identify your High Speed link (HSL) and System Power Control Network (SPCN) cables. Your system uses HSL cables to communicate with your expansion unit. Your system uses SPCN cables to control power to your expansion unit.

Depending on your requirements, you might not have every HSL or SPCN cable listed below.





- Avoid creating a safety hazard.
- Avoid damaging the cables.
- Avoid placing cables parallel to high-voltage lines.

Examples of HSL loops

The following diagrams show different examples of HSL loops:





Redundant links

A *redundant link* is a secondary HSL connection that your system uses if the primary link experiences a failure. Create a redundant link configuration by connecting a redundant HSL cable link between the expansion units and the system unit.

Your new expansion unit may have disk units. To ensure continued access to your disk units in the event of a link failure, a redundant link should be planned for your cable layout.




Figure 1. Planning for redundant link one expansion unit




Figure 2. Planning for redundant link with two expansion units




Figure 3. Planning for redundant link with stacked expansion units (5079)

Refer to Figure 1 to see how to plan your cables with a redundant link configuration with one expansion unit. If you are linking two expansion units, refer to Figure 2. If you are setting up stacked expansion units, refer to Figure 3 on page 5.

Power down your iSeries system unit

You need to power down your system unit before you can connect your new expansion unit to it. All system units in a cluster must be powered down. Follow the steps below to power down your system unit.

- 1. Ensure that you have a current backup of your operating system and licensed programs. If you have backed up the operating system and licensed programs since the last time you applied program temporary fixes (PTFs), that backup is acceptable.
- **2.** If you have installed logical partitions on your system unit, refer to *Logical partitions* in the *iSeries Information Center*. In the *iSeries Information Center* you can find instructions on powering down a system with logical partitions.
- $_$ 3. If an IXA is present on the system, shut it down using the OS/400[®] options.
- _____4. Ensure that all jobs are complete.
- ____5. When all jobs are complete, type pwrdwnsys *immed on a command line and press the Enter key.
- **Note:** If you encounter difficulties during the installation, contact your authorized dealer or service provider.
- ____6. After your system unit has completely powered down, power off all PCs and devices, such as printers and display stations, that are connected to the system unit.
- ____7. Unplug any power cords, such as for printers, expansion units, and display stations, that are connected to the system unit.
- **8**. Unplug all the power cords for the system unit from the electrical outlet.
- ____9. Did you receive a 7002 internal flex cable with your expansion unit?
 - _ No: Go to Chapter 2, "Set up your expansion unit," on page 13.
 - ____ Yes: Go to "Installing the 7002 cable" on page 8.

Installing the 7002 cable

If your system unit came with the 7002 internal flex cable, you need to install it before you can set up your unit. To install the 7002 cable follow these steps:

____1. Remove the right side cover (view from back):

- ____a. Loosen the screws.
- ____b. Slide the cover from front to back until it stops.
- **____ c.** Pull the cover out.




Figure 4. Remove system unit side cover

Your system unit contains a battery that only trained personnel can replace.

CAUTION:

The battery is a lithium battery. Only trained service personnel may replace this battery using the instructions in the Problem Analysis, Repair, and Parts service manual. To avoid possible explosion, do not burn or charge the battery. Exchange only with the IBM-approved part. Discard the battery as instructed by local regulations. (RSFTC241)




Figure 5. Attach wrist strap

__2. Attach the disposable wrist strap to prevent electrostatic discharge from damaging a device. Figure 5 shows an example of where to attach the adhesive part of the foil on the wrist strap to an unpainted surface.




Figure 6. Installing the 7002 internal flex cable

- **____3.** Remove the plate covering the HSL cable ports at **E** (Figure 6 on page 10).
- _____4. Place gasket **D** over connectors **C**.
- ____5. Install connector C in HSL cable port at E.
- ____6. Install retaining screws into connector **B**.
- ___7. Plug connector **B** into backplane at **A**.

- **8**. Remove the wrist strap.




Figure 7. Install system unit side cover

- ____9. **Figure 7 on page 11** shows how to install the system unit side cover by aligning the tabs on the top and bottom edge. Press forward to make sure that all tabs enter the slots. Slide the cover toward the front of the system unit until it stops and install the screws.

This instruction describes how to set up your expansion unit.

- ____1. If you have not powered down your system unit, go to "Power down your iSeries system unit" on page 7. Once you have powered down your system unit, return here.
- ____2. Remove or open the back cover, if you have one.

See Appendix A, "Remove or open the back covers," on page 31 if you need help removing or opening the covers on your expansion units or system unit.

____ **3**. Find the connector locations.

See Appendix B, "Connector locations," on page 37 if you need help finding the connectors on your expansion units or system unit.

- ____4. If your system unit has a migration unit, go to the *iSeries Information Center* and refer to *Installation*, *upgrades and migration* before you proceed.
- ____5. Review the "Examples of HSL Connections" on page 14 and "Examples SPCN Connections" on page 16 and then continue with "Connect your unit with HSL cables" or "Connect your unit with SPCN cables" on page 15.

Connect your unit with HSL cables

If you encounter difficulties during the procedure, contact your authorized dealer or service provider.

- ____1. Locate available HSL connectors on your unit. See Appendix B, "Connector locations," on page 37.
- ____2. If you have just one set of HSL connectors on your system unit, they are labeled A0 and A1.

If you have more than one set of HSL connectors on your system unit, the first set is labeled A0 and A1. The remaining HSL connectors are labeled alphabetically. For example, if you have a model 830, there are four sets of HSL connectors on your system. They are labeled A0 and A1; B0 and B1; C0 and C1; D0 and D1.

Refer to "HSL loop addressing" on page 7.

- ____3. Write down which set of HSL connectors are available here: _____, ____.
- _____4. Label and connect the cables to your unit.


Unused HSL connectors may be covered with metal clips. Remove the clips before you install the HSL cables.


- ____a. Find the HSL cables and power cable that was shipped with your expansion unit.
- ____b. Attach a label to each end of the HSL cables.
- ____ c. Label one HSL cable 0 at both ends.
- ____ d. Label the other HSL cable 1 at both ends.
- ____e. To connect one expansion unit, do the following:
 - ____1) Connect the HSL cable that is labeled 0 to the HSL connector that is labeled 0 on your expansion unit.
 - ____2) Connect the HSL cable that is labeled 1 to the HSL connector that is labeled 1 on your expansion unit.
- ____f. To connect more than one expansion unit:
 - ____1) Label the next HSL cable 0 at one end and 1 at the other end.
 - ____2) Connect the HSL cable that is labeled 0 to the HSL connector that is labeled 0 on your expansion unit.
 - **____3)** Connect the HSL cable that is labeled 1 to the HSL connector that is labeled 1 on your expansion unit.

- _____4) Repeat the above steps until all expansion units are connected.
- _____5. Connect the cables to the available HSL connectors on your system unit. See step 3 on page 13. Connect the cable that is labeled 0 to the HSL connector that is labeled 0 and the cable that is labeled 1 to the HSL connector that is labeled 1.
- ____6. Continue with "Connect your unit with SPCN cables" on page 15.



- ____e. Connect the other end of the cable to connector J15 on your next expansion unit.
- _____f. Repeat the above steps until all expansion units are connected.
- ____g. Connect the power cable. Do not plug into the wall outlet.
- ____3. Close or replace the back cover if you have one.
- ____4. If you are installing a new server with this expansion unit, return to the *Cabling instructions*.
- ____5. Continue with Chapter 3, "Complete your installation," on page 19.






Figure 8. Removing the 5075 and 270 back cover




Figure 9. Removing the 825 back cover




Figure 10. Removing the 830, 5074 and 5094 back cover




Figure 11. Opening the 840, 5079 or 5294





Figure 12. Opening the 870 or 890 back cover




Figure 13. 270, 800, and 810 HSL connector locations




Figure 14. 820 HSL connector locations




Figure 15. 825 HSL connector locations




Figure 16. 830 HSL connector locations





Figure 17. 840 HSL connector locations




Figure 19. 5079 connector locations




Figure 20. 5074 connector locations




Figure 21. 5075 connector locations




Figure 22. 5078 connector locations






Figure 23. 5088 connector locations




Figure 24. 5094 connector locations




Figure 25. 5095 connector locations




Figure 26. 5294 connector locations





Figure 27. 9094 connector locations
