Chapter 1. About this release

The topics in this section provide specific information about the current release.

What's new in this release

IBM Inventory Tool for Microsoft System Center Configuration Manager, v5.0 adds the following features:

Trial license support

The trial license will be automatically activated if no product license is activated when the product is installed for the first time.

After the trial license is activated, it is valid for 90 days. Ensure that sure your system time is correct so that you can take full advantage of the trial period. IBM Inventory Tool is a fee-based product. The tool can provide an inventory of the system hardware, memory, BIOS/UEFI, drivers, IMM configuration and options (such as, LSI, Qlogic, Brocade, Broadcom, Mellanox, and Emulex).

The trial license enables only a few basic inventory options, such as system overview, memory and BIOS/UEFI. To enable other premium features, after a product license is activated, you must run the IBM Inventory Tool server configuration from the **Start** menu.

Premium features

The premium features are available when the IBM Inventory Tool installation is registered with the IBM Upward Integration for Microsoft System Center, v4.0 or later license. You can purchase an activation license by contacting your IBM representative or an IBM Business Partner.

The fee-based functions that are enabled through a valid product license of v4.0 or later include the ability to configure the SCCM server to collect IBM hardware inventory of drivers, IMM configuration and options (LSI, Qlogic, Brocade, Broadcom, Mellanox, and Emulex).

Chapter 2. Known limitations

The topics in this section provide information about limitations, problems, and workarounds that are applicable to the IBM Inventory Tool for Microsoft System Center Configuration Manager, version 5.0.

Limitations

The following limitations are applicable to the IBM Inventory Tool for System Center Configuration Manager, version 5.0.

A window confirming the uninstallation may be blocked by the processing bar of the installation program.

Issue: When the product is uninstalled from the system control panel, a confirmation window opens at the end of the uninstallation process; however, the processing bar prevents you from confirming the uninstallation.

Possible solutions:

- Bring the underlying uninstallation confirmation window into focus by clicking on it, then click OK to complete the uninstallation.
- Use the uninstallation shortcut option from the **Start** menu to uninstall the product. The confirmation message window is not blocked when you use this method.

Known problems and workarounds

The following known problems and workarounds are applicable to IBM Inventory Tool for Microsoft System Center Configuration Manager, v5.0.

Configuration fails when installing or repairing IBM Inventory Tool

Issue: IBM Inventory Tool fails to configure SCCM and modify sms_def.mof due to the deletion of IBM.SysMgmt.InventoryTool.ServerConfig.exe which is in the Installation directory.

Possible solution:

Uninstall IBM Inventory Tool, and then reinstall or delete all the IBM UIM Inventory Tool classes in sms_def.mof first and then try to repair. The mof file is located at: %SystemDrive%\Program Files (x86)\Microsoft Configuration Manager\inboxes\clifiles.src\hinv. The classes have a special head and end as follows:
